## 3 Matters Arising from the Minute

### 6.1 Management of the Estate

- Chipping of the Laurel trees.
- Regular patrols on the Estate.

- Clearing and rendering safe all the damaged trees and limbs resulting from the gales of 22 May 2011.

## 6.2 Flooding on the Road

- Discussions were currently taking place between the Countryside Ranger, the adjacent landowner and the Roads Division.
- The landowner would provide a risk assessment to carry out investigative works.

#### 6.3 Estate Buildings

- The Farmhouse was checked on a regular basis with any breaches being reported.
- The alarm system was now fully operational at the Lodge and a new electricity metre had been installed.
- The Visitor Centre had been closed one day following the storm on 22 May as members of the team had been helping survey tree damage.

#### 6.4 Groups Which had Visited the Estate

- BTCV.
- Stevenson College Groups.

## 6.5 Biodiversity Surveys

- Countryside Rangers were continuing with a Butterfly Monitoring Survey.
- For the first time a Bumblebee Survey would also be carried out this year.
- A new volunteer for the Countryside Ranger Service would be assisting with the Bumblebee Survey.

The surveys were being carried out to establish a record of the species distribution for bees and butterflies, before any changes to the land management took place. Later surveys would hopefully show if there had been any improvement in invertebrate diversity.

### 6.6 Projects

- Pinetum improvements, including the planting of 7 new endangered conifer species.
- Part of the grass area in the Pinetum had been strimmed.
- Discussion would take place with the local environment team to include the amenity grass area in the regular mowing schedule.
- New woodchip paths would be created.

## 7 Interpretation of the Estate
