#### "Council:

- Notes that in the last air quality update, presented to Transport and Environment Committee on 17 January 2017, that the annual mean nitrogen dioxide objective was exceeded at 26 monitoring locations across the city in 2015;
- 2) Notes that Scottish air quality objectives for PM10 were exceeded at Salamander Street, and Scottish air quality objectives for PM2.5 were estimated to have been exceeded at four sites across the city;

- 3) Notes and welcomes the downward trend in most pollutants but believes that faster progress could and should be made in delivering cleaner air for Edinburgh;
- 4) Notes that four out of five parties represented on the council have made public commitments to introduce a low emission zone (LEZ) in the city in order to tackle poor air quality;
- Notes that the Scottish Government aims to have a single Low Emission Zone in place in Scotland by 2018, is currently seeking a local authority to take the lead on this, and that some Scottish Government funding may be available from the Scottish Government for the first Scottish LEZ only, therefore notes that this is a matter of urgency;
- Therefore agrees that the Council should be prepared to take the lead in progressing a Low Emission Zone for Edinburgh, and calls for additional funding for the Zone to be identified from partners such as the Scottish Government;
- Agrees that the Council Chief Executive will urgently write to the Scottish Government offering to work towards establishing Scotland's first Low Emission Zone in Edinburgh, with the expectation that the Scottish Government can make a significant contribution towards the cost of establishing the Zone, and offering early talks to discuss the practical details of bringing this about."

# **Executive summary**

Standing Order 1.2 requires the Council to make various appointments at its first meeting after an election. The Council is invited to appoint members to Committees of the Council, Boards and Joint Boards.

# Appointment of Members to Committees, Boards and Joint Boards

#### Recommendations

#### The Council is asked:

- 1.1 To specify its appointments to the following positions for 2017/18:
  - (a) The Leader and Depute Leader of the Council;
  - (b) Conveners and Vice Conveners of the Corporate Policy and Strategy Committee, Executive Committees and other Committees of the Council:
  - (c) Members of the Corporate Policy and Strategy Committee, Executive Committees and other Committees of the Council;
  - (d) Members of the Neighbourhood Partnerships;
  - (e) Members of the Integration Joint Board and Joint Committees.
  - (f) The Convener of the Integration Joint Board.
  - (g) Members of the Lothian Valuation Joint Board.
  - (h) Members of the Licensing Board.
- 1.2 To determine Senior Councillor Allowances.
- 1.3 To agree added members of the Education, Children and Families Committee.

## **Background**

- 2.1 Standing Order 1.2 States that at the first meeting after the election, the Council will:
  - Appoint the Lord Provost of the Council
  - Appoint the Depute Convener of the Council
  - Appoint the Leader and Depute Leader of the Council
  - Appoint members of the Committees of the Council and their Conveners and Vice Conveners
  - Appoint members of the Joint Committees and Joint Boards
  - Appoint members of the Licensing Board

- Appoint representatives to other bodies as the Council may decide to appoint.
- 2.2 The Election of the Lord Provost and Depute Convener is dealt with elsewhere on the agenda for this meeting, as is appointments to outside organisations.
- 2.3 The Committee Terms of Reference and Delegated Functions specify that committee membership will be proportionate to the elected representation of political parties, unless expressly agreed otherwise at a meeting of the full Council.

#### **Main report**

- 3.1 The Council is invited to specify its appointments to the following positions for 2017/2018:
  - The Leader and Depute Leader of the Council;
  - Conveners and Vice Conveners of the Corporate Policy and Strategy Committee, Executive Committees and other Committees of the Council (Appendix 1 details the list of Committees);
  - Members of the Corporate Policy and Strategy Committee, Executive Committees and other Committees of the Council (Appendix 1 details the list of Committees with the number of members to be appointed based on the political balance of the full Council);
  - Members of Neighbourhood Partnerships (Appendix 2 details the Neighbourhood Partnerships);
  - Members of the Licensing Board, Joint Committees and Joint Boards that the Council should appoint (see paragraphs 3.6 - 3.11 below) (Appendix 3 details the number of members to be appointed based on the political balance of the full Council).
  - The Convener of the Integration Joint Board.

#### **Education, Children and Families Committee**

- 3.2 Legislation requires the Council to appoint one representative from each of the Church of Scotland and the Roman Catholic Church to serve as full committee members. Nominations have been invited, and the Church of Scotland nominee is detailed in the Appendix. The Roman Catholic Church nominee will be reported once received.
- 3.3 The Council is also required to appoint a third outside representative, taking account of the comparative strength of churches and denominational bodies within the city. This is currently the subject of public advertisement, and the outcome will be reported as soon as possible.

3.4 Teachers and parents were previously represented on this committee. Scope exists for this representation to continue, and the Council's view on such added members is sought.

# Planning Committee/Development Management Sub-Committee/ Local Review Bodies and the Regulatory Committee/Licensing Sub-Committee

- 3.5 Committee Terms of Reference provides that the membership of the Planning Committee shall be 15 members and the Regulatory Committee shall be 9 members.
- 3.6 By custom and practice, the 15 members of the Planning Committee have comprised the Development Management Sub-Committee and the 9 members of the Regulatory Committee have comprised the Licensing Sub-Committee.
- 3.7 The Council is also required to appoint a Local Review Body as a committee of the Council to fulfil the Council's obligations as planning authority for the conduct of reviews of decisions taken by the appointed officer on local developments.
- 3.8 Members appointed to the Planning and Regulatory Committees for the first time are expected to attend training before they attend their first meeting. Training has been arranged on:
  - Planning Committee 30 and 31 May 2017
  - Appeals and Local Review Body 7 June 2017
  - Regulatory Committee 15 and 20 June 2017

# Joint Committees and Joint Boards, the Licensing Board, Lothian and Borders Community Justice Authority and SEStran

- 3.9 Standing Order 1.2 requires the appointment of members of Joint Boards and Joint Committees.
- 3.10 The legislation relating to the Lothian Valuation Joint Board provides for the members first appointed to it to hold office for the life of the Council.
- 3.11 If there is to be any change in the Council's membership of this Joint Board, the co-operation of existing members is required by their resigning from the Board. New appointments cannot be made until a letter of resignation is received.
- 3.12 Members of the Lothian Valuation Joint Board are also appointed to the Lothian Electoral Joint Committee, in terms of the 1996 Minute of Agreement.
- 3.13 The Council is therefore invited to appoint members to this Joint Board.
- 3.14 In terms of the Integration Scheme, the Council and NHS Lothian share the appointments of Convener and Vice-Convener of the Integration Joint Board. The Council currently holds the position of Convener and is asked to appoint to this.

#### **Licensing Board**

- 3.15 Under licensing legislation, a Licensing Board is to consist of such number (being not fewer than 5 and not more than 10) of members as may be determined by the Council.
- 3.16 The Licensing (Scotland) Act 2005 states that any member appointed to the Licensing Board cannot take their place on the Board until they have completed an external training course and passed an examination.

Training has been arranged as follows:

12 June 2017 (Liquor)

14 June 2017 (Liquor and Gambling)

- 3.17 A Councillor who is a premises licence holder, or the employee of a premises licence holder and works as such in licensed premises, whether alone or in partnership with another person engaged in the business of producing or selling alcohol, or a director or other officer of a company so engaged or an employee of any person so engaged and working as such in that business, shall not act as a member of a Licensing Board for any purpose under the Act.
- 3.18 The Council will appoint members to outside bodies elsewhere on the agenda to this meeting. However, the statutory instruments which established the Lothian and Borders Community Justice Authority and the South East of Scotland Regional Transport Partnership (SEStran) require the Council to appoint members to these bodies at its first meeting after the election.
- 3.19 Lothian and Borders Community Justice Authority brings together local authorities, the Scottish Prison Service and key partners to ensure an integrated approach to reduce reoffending. SEStran is one of 7 Regional Transport Partnerships in Scotland which aims to address the transportation issues within the area and work towards a more sustainable and efficient transport network.

#### **Senior Councillor Allowances**

3.20 When specifying appointments the Council can appoint Senior Councillors within a maximum budget set out in the Local Governance (Scotland) Act 2004 (remuneration). The 2016/17 allocations, updated to allow for a 1% pay rise from 1 April 2016, are set out in Appendix 4.

# **Appointments to Outside Organisations 2017/22**

#### Recommendations

- To appoint elected members to a range of outside organisations and Council companies, as detailed in the Appendix to this report.
- 2 To consider whether to continue with the practice of appointing specific Champions, and if so to appoint members to the positions identified.

## **Main report**

- 2.1 Standing Order 1.2 (b) requires that the first meeting of the Council following the ordinary election of councillors appoints representatives to "other bodies as the Council may decide to appoint".
- 2.2 The Appendix list the organisations the Council is invited to appoint to for 2017/22, along with the previous representation. Appointments to city-wide groups help support the Council's strategic objectives; while those to local groups assist locality planning, and support local ward members. Council companies have key roles and responsibilities across a range of service areas.
- 2.3 The list of organisations has been reviewed ahead of this process. A number of organisations appointed in 2012 have ceased to exist. Groups have been asked to confirm they still wish Council representation, and a few have declined. Despite approaches from the Council, some groups have retained their unincorporated status. Due to the potential liability on individual members and the Council, it is proposed that these appointments are made in line with the advice to Council in June 2016.
- 2.4 Individual councillors were also surveyed to establish whether they had benefited from being appointed to a particular organisation, either in terms of local ward interest, or in terms of the overall development of Council policy. This report takes account of the responses received. Specifically, the role of members appointed to outside bodies has been incorporated in the member induction training programme.
- 2.5 In terms of appointments to charitable bodies, Office of the Scottish Charity Regulator (OSCR) guidance recommends the board membership of charities should be regularly refreshed.
- 2.6 A detailed review of elected membership on Council companies was undertaken in 2012, overseen by a members' working group. Amongst its conclusions, agreed at full Council in December 2012, was that a maximum of three elected

- members should sit on the board of each Council company, at that time one member from each of the coalition groups and one from an opposition group.
- 2.7 The previous Council also appointed a number of Champions, individual members who served as lead member, and champion, for a particular issue. The previous Champions are also listed in the Appendix, and the Council is invited to consider appointing to these positions.

#### **Measures of success**

- 3.1 The Council is fully represented on a range of outside bodies.
- 3.2 Council companies have a full complement of elected members appointed to them.

### **Executive summary**

- 2.1 The Council diary is approved annually by full Council as required by Standing Order 4.2.
- 2.2 The 2016/17 diary (excerpt at Appendix 1) was approved by Council on 4 February 2016, subject to minor adjustment at the 24 November 2016 meeting. It runs until end-August 2017.
