Executive summary

As part of the appointments process following the May 2017 Local Government elections, Council is asked to appoint the members of its Neighbourhood Partnerships. Council is also invited to appoint four members as political leads for the locality areas.

Recommendations

The Council is asked:

- 1.1 To appoint members to the Neighbourhood Partnerships (Appendix).
- 1.2 To agree to appoint a senior councillor for each of the four localities.

Background

- 2.1 The Political Management Arrangements 2017 report elsewhere on the agenda notes the need to re-appoint to the existing Neighbourhood Partnerships to allow elected members and the community to engage in the Locality Improvement Plans which are currently being developed.
- 2.2 In parallel to this, consultation with elected members, communities, key stakeholders etc is to take place over the summer months on the possible remit and focus of the four Locality Committees.
- 2.3 The outcome of this review will be reported to the September Council meeting.

Main report

- 3.1 As set out above, it is proposed that the Council appoint the membership of the Neighbourhood Partnerships, as detailed in Appendix 1.
- 3.2 In order to support the development of the locality model, it is also suggested that four political leads be identified for the four Locality Committees, with each post receiving a senior councillor allowance.

The Council's political managements arrangements are robust, and encourage effective decision-making.
