## 4 Acquisitions for the City's Fine Art Collection

### 4.1 Commission of a Portrait by David Mach

The Committee had previously agreed to authorise negotiations with David Mach on the proposal to commission a portrait of Aung San Suu Kyi, explore external avenues of funding and report back to the Committee.

The Committee was informed that the artist had offered to undertake the portrait at cost price as he very much supported the action taken by the Council. Following consultation between the Director of Culture and Leisure and the Convener of the Committee the decision was taken to proceed with the portrait at a cost of £5,000 plus approximately £500 for framing. It was hoped to find a suitable site for the portrait within the new Council headquarters.
