# 6 National Collecting Scheme for Scotland – Continuation

The Committee at its meeting of 29 August 2003 agreed to participate in the National Collecting Scheme for Scotland. Approval of the Committee was sought to continue in the Scheme and commit up to £4,000 from the Jean F Watson Bequest in the current financial year. This would enable the City Art Centre to apply for between £8,000 and £10,000 from Scottish Arts Council funds, while also applying for grant aid from the National Fund for Acquisitions and also, possibly, the Art Fund. This should enable a total funding package of £18,000 to £24,000 to be assembled for the acquisition of contemporary art in the next few months.

Details were provided of:

- the conditions of the previous Scheme and the new Scheme;
- the works acquired by the City Art Centre through membership of the Scheme
- the total cost of the works acquired.

The deadline for applications for this funding to the Scottish Arts Council was 14 December 2007.

#### Decision

To approve the City Art Centre's continuing participation in the National Collecting Scheme for Scotland.
