### Information about the Committee on the Jean F Watson Bequest Transport and Environment Committee

In 1962 Miss Jean F Watson set up a trust to acquire works of art by Scottish artists. The bequest states that works purchased or commissioned shall be by artists born, practising in, or otherwise associated with Scotland and in particular Edinburgh. These shall include paintings, sculpture, prints and drawings and items of applied art such as tapestries, stained glass, glass, ceramics, silver and jewellery. It shall be a requirement that works by local artists selected for purchase should be of sufficient high quality to achieve national standing. The Watson Bequest allows the City to continue collecting important and significant works strengthening an already important and nationally significant collection.

# **Executive summary**

# Remit amendment and valuation of the collection

### Summary

An internal audit of heritable assets held by the Council was carried out in October 2012. The Jean F Watson (JFW) Bequest Trust and the Catherine E Cowper Trust (CC Trust) were included in this audit. The Watson Bequest dates from the early 1960s and was established by Miss Watson to enable an Edinburgh municipal collection to be developed. In 1996 Mrs Catherine E Cowper established a bequest to be used by the Museum of Childhood to acquire items for its collection which has subsequently been recognised as nationally significant.

The audit made several recommendations about these Trusts to ensure that full details of their value are available each year for the Council's audited accounts.

The recommendations which are relevant to this Committee are as follows:

- exhibits, artworks and artefacts valued over £5,000 should be revalued once every five years; and
- the Jean F Watson collection inventory should be clearly separated from the inventory of other artworks owned by the Council.

As the JFW collection was last valued in 2008, it is now time to revalue the collection. In the past this has been undertaken by curatorial staff based at the City Art Centre and it is suggested that this practice continues. A modest subscription to an appropriate online valuation tool, as used by other museums and galleries, would help to ensure the accuracy of this work.

The Museums and Galleries service is in the process of purchasing a new collections management system, called Ke Emu, which will provide curators with the facility to generate more effective reports on any aspect of collection items. Up to date separate inventory reports on the Jean F Watson collection will be able to be produced to order.

The auditor also suggested that it would improve internal governance and accountability for this Committee's remit to be expanded to cover proposed purchases by the more modest Catherine E Cowper (CC) Trust. The current balance of the CC Trust is £47,360.

The majority of items acquired by the Museum of Childhood are generally donated and usually date from the late 20<sup>th</sup> century or earlier. It is proposed that the CC Trust could be used to buy contemporary items on a regular basis to keep the collection up to date.

It is anticipated that these toys, games and other childhood items would range in price from a few pounds to a few hundred pounds, and would be acquired through the Council's normal purchasing process for goods. In addition, there may occasionally be opportunities to acquire an historic item to fill a gap in the Museum's collection.

It is recommended that the above purchases be reported retrospectively to this Committee once a year. Any item that would cost more than £1,000 will be reported in advance for Committee approval or agreed in consultation with the Convener if the opportunity would otherwise be lost because of a tight purchase deadline.

As the above proposals in relation to the Catherine E Cowper Trust would alter the Jean F Watson Bequest Committee's remit, and add an entry in the Council's Scheme of Delegation, it is recommended that they should be referred to the Council for its consideration and approval, if the Committee agrees these changes in principle.

### Recommendations

It is recommended that the Committee:

- 1. notes that JFW Bequest collection items worth over £5,000 each will be revalued by the curatorial team by March 2014;
- 2. approves in principle the extension of the Committee's remit to include the Catherine E Cowper Trust;
- 3. approves in principal the reporting and approval mechanism outlined above for purchases funded by the Catherine E Cowper Trust; and
- 4. refers these remit and Scheme of Delegation changes to the Council for its consideration and approval.

# **Executive summary**

## Update on proposed acquisitions

### **Summary**

At its last meeting on 12 October 2011, the Committee gave consideration to purchasing a number of works. This report details progress in pursuing these acquisitions.

The purchase of the painting *Craigleith Quarry* by William Kidd for £4,500 has been completed with the assistance of a grant of £2,250 from the National Fund for Acquisitions.

The purchase of the object *Untitled (One Armed Snake)* by Charles Avery for £12,000 has been completed with a grant of £8,000 from Creative Scotland.

The purchase of the watercolour *The Rialto* by Arthur Melville for £120,000 has not been completed. Following applications, two offers of grants were made towards this work: £18,000 from the National Fund for Acquisitions and £6,000 from the Friends of the City Art Centre and Museums.

Also, a donation of £6,500 was made towards a significant purchase for the City Art Centre's collection following a lecture given by the Curator of Fine Art to the Edinburgh Decorative and Fine Art Society and potentially earmarked for the Melville acquisition. This makes a total raised so far of £30,500, leaving a shortfall of £89,500.

More recently an application for a grant of £36,000 was submitted to the Art Fund and considered at their meeting on 3 October 2013. This application was unsuccessful.

In the light of the above, it is suggested that an application for a grant is now made to the Heritage Lottery Fund. Simultaneously any other appropriate trusts and foundations will be approached and the Committee advised in due course of the level of shortfall.

The purchase of works by David Mach has not yet been pursued as the intention is to complete the Melville purchase first, so that multiple grant applications are not submitted in competition with each other.

At its last meeting, the Committee had decided not to purchase the recommended artwork by Karla Black, but had instructed officers to bring forward alternative works by the artist. It was considered prudent to resolve the Melville and Mach purchases before presenting alternative works to the Committee.

### Recommendations

It is recommended that the Committee:

1. notes the progress made to date and approves the above course of action.

### Measures of success

Completed purchase of *The Rialto* by Arthur Melville.

### **Financial impact**

The funds for the purchase of *The Rialto* will come from the Jean F Watson Bequest Fund, supplemented by grant aid already committed and other external funding to be sought from other sources.
