5 Pupil Placements

Moyra Wilson gave a presentation on pupil placements in 2012. The presentation highlighted the extent of the issue this year, explained the reasons for the number of refusals and gave advice to members about what information they could provide to parents affected by the issue. An explanation was given of the Council's priorities for dealing with placement requests and of the setting of intake levels.

Discussion following the presentation highlighted: -

- Discussions with developers over the impact of new developments
- Potential for the realignment of catchment areas in light of the renewal of the estate
- The implications of parents withdrawing one or more children from a school if they cannot accommodate a sibling child at the same school via a placing request
- Schools with a surplus of places
- Issues concerning Tollcross Primary School following the relocation of the Gaelic Unit
- That classes could have more than 25 pupils if the additional numbers resulted from decisions by the Placing in Schools Committee or the Sheriff
- Confidence that catchment area children would be accommodated this year but that there was pressure next year

Summary

The Placing in Schools Appeal Committee was established under Section 28C of the Education (Scotland) Act 1981 to hear and decide appeals against decisions of the Council or relevant Head Teacher to refuse placing requests and exclude pupils in terms of the Education (Scotland) Act 1980 as amended. The Committee also considers appeals against decisions by the Director of Children and Families to refuse early admission to school.

The Consultative Committee with Parents requires to nominate parent representatives to serve on the Placing in Schools Appeal Committee. These nominations require to be approved by the full Council.

The appointment is for four years to 31 January 2017 or until the parent's youngest child leaves school, whichever is earlier.

Appointment of Parent Representatives to the Placing in Schools Appeal Committee

1. Background

1.1 The Placing in Schools Appeal Committee was established under Section 28C of the Education (Scotland) Act 1981 to hear and decide appeals against decisions of the Council or relevant Head Teacher to refuse placing requests and exclude pupils in terms of the Education (Scotland) Act 1980 as amended. The Committee also considers appeals against decisions by the Director of Children and Families to refuse early admission to school.

2. Main report

- 2.1 The City of Edinburgh Council's Placing in School Appeal Committee comprises one member from each of the following three groups:
 - Panel 1 All Members of Council, religious and teacher and any parent representatives on the Education, Children and Families Committee.
 - Panel 2 Parents of children of school age.
 - Panel 3 Persons with experience in education and acquainted with educational conditions in the Council's area, nominated by the Director of Children and Families.
- 2.2 The current membership is detailed in the appendix to this report. It should be noted that:
 - (a) members of the Pupil and Student Support Committee do not participate in the annual placing in schools Appeals process;
 - (b) a Councillor cannot participate in an appeal if the school is within their ward or catchment area; and
 - (c) a parent member cannot participate if their child attends the school for which the appeal is being made.
- 2.3 Vacancies on Panel 2 of the Placing in Schools Appeal Committee (Parents of Children of School Age) are nominated by the Consultative Committee with Parents for consideration by the Council at its next meeting.

- 2.4 The appointment is for four years, to 31 January 2017, or until the member's youngest child leaves school, whichever is earlier.
- 2.5 The Protection of Children (Scotland) Act 2003 requires that members of certain Committees are subject to the Protecting Vulnerable Groups Scheme check to ensure that they are not disqualified from holding such positions. Persons appointed to the Placing in Schools Appeal Committee will require to comply with this.
- 2.6 The heaviest workload of the Appeal Committee is during May and June each year to deal with P1 and S1 appeals. Participation by Panel 2 members will be required, on average, once per week during this period. Other appeals are held throughout the year requiring members to attend for a morning or afternoon every couple of months.
- 2.7 Training is provided and appointment is conditional on attendance at the required training.
