#### 1. Welcome

Councillor Godzik welcomed everyone to the meeting.

#### 2. Minute

#### **Decision**

The minute of the meeting of the Consultative Committee with Parents of 3 October 2013 was approved as a correct record.



# 3. Director's Update

Gillian Tee highlighted a series of items of relevance to parents that would be considered on 10 December 2013 by the Education, Children and Families Committee. These included:-

#### Castlebrae Community High School – Progress Update

An update on progress towards improving outcomes for learners, parental and community engagement, and increasing the school roll would be considered by the Committee. Longer term improvements which would be required until a new school was built (currently anticipated to be in 2020) would also be outlined together with options for the new school.

#### Neighbourhood Issues

An issues log had been created to note the issues raised at neighbourhood meetings. The issues raised at neighbourhood meetings were being responded to and any suggestions in terms of improving the format of neighbourhood meetings should be forwarded to Gillian Tee.

Additionally, and also to be considered by the CCwP later in the business, information on the New Highers and national 4 and 5, and work undertaken to improve and boost uptake of school meals would also be considered by the Education, Children and Families Committee.

#### **Decision**

To note the information that would be provided to the Education, Children and Families Committee on 21 May 2013.

#### 4. Educational Attainment

Karen Prophet, Senior Education Manager, Children and Families, provided information on issues relating to educational attainment. A report summarising analysis of attainment in the City of Edinburgh's schools for the year 2012-13 would be submitted to the Education, Children and Families Committee on 10 December 2013, and indicated general improvement across all National Priority Targets.

# 4.1 New Highers

The new Higher qualifications were scheduled to be implemented in 2014/15. The City of Edinburgh were in discussion with Head Teachers and Teacher Unions had agreed there could be additional flexibility in implementation over session 2014/15 and 2015/16. Schools would make final decisions by March 2014 after the SQA Professional Development activities had taken place. Teachers were keen to ensure that the correct materials and adequate resources were in place to achieve the best outcome for pupils.

During discussion it was agreed that providing additional flexibility in implementation was the right approach for the City of Edinburgh. The importance of ensuring that the first students to undertake the new qualifications were not disadvantaged was also stressed.

#### 4.2 National 4 and 5

These courses had been introduced from session 2013/14 and replaced the current Standard Grade and Intermediate qualifications.

#### Decision

To note that a report on the implementation of the new Highers would be submitted to the Education, Children and Families Committee in March 2014.

#### 5. School Meals

Jim Davidson, Services for Communities, spoke on the subject of school meals, currently delivered by three different catering providers. In the PPP (Public Private Partnership) contract schools these were provided by either Amey or by Chartwell. Catering to non-PPP schools was provided by the Council through the Integrated Property and Facilities Management (IPFM) service.

Discussions had been ongoing since April to canvass parents' opinions of school meals with a view to improving the end product. While representations thus far had yielded some positive feedback, it was acknowledged that work remained to be done. The comments would be used to feed into the proposals to be brought to the March 2014 meeting of the Education, Children and Families Committee.

The Food for Life Project had prompted a pilot scheme involving two or three schools, the outcome of which would be also be reported to the Education, Children and Families Committee in March 2014. A report detailing work to increase uptake of school meals was going to the meeting on Tuesday 10 December 2013.

During discussion, the following issues were raised:-

- Disparity in the quality of food offered
- portion size/control
- electronic payment for school meals
- sourcing local/organic produce.

#### Decision

To note the information and that a further report on the subject of school meals would go to the Education, Children and Families Committee in March 2014.

# 6. Budget Update

Gillian Tee updated the Committee on the draft budget and the meetings that were taking place with the chairs of parent councils, head teachers and the wider public to gather feedback on the proposals ahead of them being finalised in February. Areas of particular debate were Additional Support Needs, Libraries, Primary management; and class size, particularly for core literacy and numeracy classes. During discussion, the following points/issues were highlighted:

- Some members expressed concern at the costs of employing Ernst and Young, but were informed that their work was across the whole Council, so not being funded by the Children and Families Department.
- Some members felt that they needed more information on aspects of the proposals and were directed to the Council's website which had much more information on the plans for Children and Young People, and the City generally - <a href="https://www.edinburgh.gov.uk/budget/">www.edinburgh.gov.uk/budget/</a>
- The need for Council recognition of how pinched school budgets were already.
- The need to maximise income generation as well as make savings.
- Gillian Tee stated that work on energy efficiency in schools including efficiency audits was underway.

#### **Decision**

- 1) That a link to the budget page be circulated to members.
- 2) That successful ideas/suggestions for savings or income generation be reported back for inclusion in the Director's Update.

# 7. Issues Arising from Committee Reports

Gillian Tee described how, following an extensive survey of the school estate, the Council now had an accurate picture of what works were required to improve Edinburgh's schools. The coalition had approved a targeted capital investment programme of £30 m over the next five years for this purpose.

#### **Decision**

To note that a further report on the issue of Capital works in school would be presented in early 2014.

#### 8. Communications

#### 8.1 New website

The Committee had previously received a presentation on work undertaken to develop web communications for parents. At that time, it had not been decided whether the information would be presented through a free-standing parents' website, or form part of the main Council site.

Moyra Wilson, Children and Families, presented sample pages developed for the new 'parental engagement' section, to form part of the Council website. She explained that the pages would include a video to inform parents of the role of the CCwP. It was intended that the pages would be circulated round parent councils and community groups to get feedback on content and layout.

#### **Decision**

To ask that the sample web pages be circulated to parent councils and community groups as soon as possible.

#### 8.2 Issues Action Log

Moyra Wilson provided an update on the development of the Action Log. Issues that were raised from the Neighbourhood meetings would be entered into the action log to ensure that they were picked up be the appropriate officers and investigated.

# 9. Neighbourhood Updates

Diane Anderson reported on the discussion at the North Neighbourhood Group as follows:

 Science and Engineering Week 2014 (NSEW) - a ten-day national programme of science, technology, engineering and maths events and activities across the UK aimed at people of all ages. Anyone could organise an event or activity and the British Science Association would help organisers plan by providing free activity and support resources. Would it be possible to stage an event in Edinburgh?

Alex Ramage reported on the discussion at the South Neighbourhood Group, highlighting the following:

 Was the slowness of the rollout of Wisepay due to the size of the company? The Group had asked how the company was chosen and whether it would be able to cope with demand

Gillian Tee reported that she was meeting with the Head of IT and would report back.

Liz Power from the Citywide Special Schools Group provided an update on the financial successes experienced by special schools across the City.

#### **Decision**

To note the updates and agree to include the minutes of neighbourhood updates in papers for future meetings.

# 10. Preventing and Responding to Bullying and Prejudice in City of Edinburgh Council Schools

The Education, Children and Families Committee of 8 October 2013 considered a report which updated on work undertaken to reduce bullying and prejudice in Edinburgh schools, and sought approval for some changes to the Council's policy and procedures.

The Committee agreed, amongst other things, to refer the report to the Consultative Committee with Parents and Neighbourhood Parent Groups for their interest.

# 12. Report from the National Parent Forum Representative

Tina Woonough appraised Committee members of issues discussed at the National Parent Forum Annual Conference on 5 October 2013, the theme of which was 'healthy, happy children'.

She updated on the current focus group work she was personally orchestrating such as the group set up to review guidance on education of children absent from school through ill health.

Other areas of interest presently included the Supporting Children's Learning Code of Practice, specifically about those issues that were of particular significance to parents with children who had Additional Support Needs. Further involvement would follow when a draft of the document became available.

Comments and views were also being sought on assessment and general education. The group looking at this topic had met two weeks earlier with a representative from the SQA (Scottish Qualifications Authority).

The Forum was putting together more resources; a revision guide compiled of books recommended by teachers, to be given to the parents of all S3 and S4 pupils.

#### Report for CCWP and Edinburgh Parent Councils and Parents/Carers

As I am unable to attend the CCWP meeting to present my usual report on the National Parent Forum of Scotland's current activities, please see below for a brief summary:

- Our latest E Newsletter has been circulated through our database and via schools. Please let me know if you have not received this, or if you would like to be added to our database via <a href="mailto:npfscommunications@gmail.com">npfscommunications@gmail.com</a>. The E Newsletter can be viewed or downloaded at <a href="mailto:www.parentforumscotland.org">www.parentforumscotland.org</a>. It contains information on issues such as exam/study leave (plus leave for prelims which is a matter for local authorities to decide), on resources to support revision for the new National Qualifications, on the 1+2 Modern Languages policy (to be rolled out in primary schools by 2020) and on assessment arrangements for the Nationals for those with additional support for learning needs.
- We have been preparing new materials to help parents to engage with the new National qualifications, including Nationals in a Nutshell, summary guides for National 1, 2, 3, 4 and 5 Qualifications, Assessment in a Nutshell (which explains the new assessment procedures for the Nationals) and Pointers for Parents and Pupils, which suggests some revision support materials. These are all available on our website (<a href="www.parentforumscotland.org">www.parentforumscotland.org</a>). We are gathering additional revision support materials for those doing National 5 exams; these will appear under the 'For Learners' tab on our website. If your school is suggesting some support materials that are publicly available, please do share these with me and I will post them on our website. All S3 and S4 parents should have received an envelope of resources about the Nationals from us via your schools please let me know if you have not received these.
- We still need a depute rep for Edinburgh for the National Parent Forum please let me know if you are interested. There are termly meetings on a Saturday in either Edinburgh or Glasgow, travel expenses are paid and childcare can be arranged.
- The Children and Young People (Scotland) Bill recently passed its 3<sup>rd</sup> Stage in the Scottish Parliamentary process. Key features/universal entitlements within the legislation are: embedding the Getting it Right for Every Child approach in legislation (including the Named Person role), 600 hours of early years childcare and education for 3-5 year olds, enhanced powers for the Children and Young People's Commissioner and free school lunches for P1 to P3 children. There are a wide range of views about different aspects of the Bill. Our position statement (broadly supportive of the Bill) is available on our website. However, we will continue to ask parents' questions and to monitor the development of the guidance, and will respond to consultation on the guidance.
- Our next meeting is this Saturday (1 March) in Edinburgh. If you have issues that you would
  like me to raise on your behalf, or views that you would like me to share, please email me
  ASAP. We are looking at cyber-bullying, assessment in the broad general education, modern
  languages, early years, Getting it Right for Every Child, relationships/sexual health with our reps
  who represent us on national working groups.

#### REPORT FROM SCOTTISH PARENT TEACHER COUNCIL

- 1. <u>Gathered Together Cruinn Còmhla</u>: There was a successful parliamentary event with Alasdair Allan MSP on 16 January. Work is underway in pilot areas (Aberdeenshire, Aberdeen City, Fife, Falkirk, Clackmannanshire, Stirling and Glasgow). The next steering group meeting takes place in March. A special issue of Backchat went to all SPTC members, with those in the pilot local authority areas also receiving more detailed information on the project.
- 2. <u>SPTC Staff</u>: We have a new Communications Officer, Lydia House, and a new Administration Officer, Mary Stark.
- 3. <u>Consultations</u>: We are planning to respond to current consultations on changes to Section 70 appeals and Accessibility Strategies.
- 4. Conference and AGM 2014: The 2014 conference will take place on 22 March at the Edinburgh Training and Conference Venue. Gillian Tee (Edinburgh City Council) and Howard Lipscombe (University of Strathclyde) are confirmed speakers and there will be a range of parent-led workshops on a range of topics. Booking information has been sent to all members and is available on the website. Members are also being asked to nominate parent and teacher directors to the Board and to vote on proposed amendments to SPTC's constitution.
- 5. <u>Regional Advisors</u>: Our programme of information and training sessions for parent groups is well underway (information attached).
- 6. <u>Easyfundraising</u>: SPTC has launched a partnership with Easyfundraising, which will enable member groups to raise funds through on-line purchases. Any parent or supporter of the PTA or PC can sign up, with a % of any purchase price being contributed to the group. This will also help raise funds for SPTC as an additional 20% will go to support SPTC's work.
- 7. <u>Facebook and Website</u>: SPTC's presence on Facebook is now up and running. We are also pressing ahead with a number of further refinements to the website, including a specific area for Gathered Together.
- 8. <u>Referendum</u>: We are drafting guidance for Parent Councils on what part they can play in how this issue is dealt with in schools.
- 9. Parents Voice: We are planning a survey on the question of religious observance.
- 10. New Leaflets: We have added new leaflets to the range available: a Template for Minutes and Guidelines for Committee Members.
