1. Minutes

Decision

The minute of the meeting of the Consultative Committee with Parents of 15 May 2014 was approved as a correct record.

2. Director's Update

2.1 Report to Parent Council Neighbourhood Groups

A report had been circulated to Parent Council Neighbourhood Groups providing an update for parents/carers in relation to Children's Services in Edinburgh. The report also included feedback from the Neighbourhood Parent forums and a progress update on matters arising. The Director highlighted the following areas:

2.1.1 Exam Results

This year's exam results included the first year of the New Qualifications. The Director was pleased to report record Higher results and a continued trend of improvement across the board. The Director thanked teachers and staff for their hard work and dedication in successfully introducing the new courses and congratulated young people for their achievements.

2.1.2 Partnership with College and University - Launch of HNC Academy

Agreement had been reached with Queen Margaret University, Edinburgh College and other Local Authorities to formalise the delivery of Higher National Certificate courses in the senior school curriculum. Courses in Health and Social Care, Hospitality, Food Science and Creative Industries would provide young people with a high quality educational experience. In session 2013/14, over fifty S5 pupils were undertaking courses to achieve an HNC by the end of S6. Successful completion of these courses would provide access to second year at University in their chosen area.

2.1.3 Summer Playscheme for Children with Additional Support Needs

Around 400 children with additional support needs from special schools and specialist provision in Edinburgh had joined in summer holiday playscheme activities.

- Road build at Gracemount Primary School had not yet been adopted by Highways.
- Concerns regarding licensing issues for new student housing at Boroughmuir High and Bruntsfield Primary Schools.

Special Schools Group

• There had been a lot of positive feedback from parents on the summer playscheme.

3. Rising Rolls/ Children and Families Estate/ Local Development Plan/ Free School Meals

Billy MacIntyre, Head of Resources for Children and Families, presented information on a number of issues as follows:

3.1 Rising School Rolls

Births and P1 intakes were currently rising with significant variations on primary school intakes in different parts of the city. It was expected that rising rolls would impact on the primary estate until approximately 2020. An outline was provided of the rising rolls in 2014, new buildings delivered, and the potential future pressures for rising rolls in 2015 and beyond. Consultation would be undertaken with schools and parent councils to review all options. A decision on progressing options would be made in early 2015. The impact of rising rolls in the primary sector would be considered for increased secondary intakes from 2019.

3.2 Children and Families Estate

Information was provided on investments in the Children and Families estate including Early Years, Primary Schools, Special Schools, Residential and High School provision.

3.3 Local Development Plan

Local authorities were required to produce a Local Development Plan every five years. As part of the process, education needs were assessed cumulatively with requirements set out in Educational Infrastructure Appraisal, produced by Children and Families as part of the Local Development Plan process.

A refreshed Asset Management Plan was being progressed for consideration in draft by Committee in December 2014 and would include a full assessment of all anticipated changes in the Children and Families estate including the impact of rising rolls and the Local Development Plan.

3.4 Free School Meals

Eligibility of free school meals was being extended from January 2015 to include all P1 to P3 pupils. A number of schools identified as having potential dining capacity issues from the estimated new uptake had been assessed for solutions.

Arising from the presentation on the above issues, a number of matters were discussed including:

- An outline of new build efficiencies/ renewables/ energy usage.
- An outline of the process for new schools/roll projections where land was allocated for housing in the Local Development Plan.
- Tribute was paid to Billy MacIntyre and the staff team for the work undertaken on the consultation and engagement process with parents on rising school rolls and the good feedback which had been received.

4. Committee Reports – Education, Children and Families Committee 11 September 2014

The Director highlighted reports being presented to the Education Children and Families Committee on 11 September 2014 as follows:-

4.1 Early Years Capital Investment

The Children and Young People (Scotland) Act 2014 set the requirement to expand free nursery provision from 475 hours to 600 hours a year for all three and four year olds and for certain two year olds.

The Scottish Government had provided additional capital funding to respond to the necessity to deliver additional capacity across the estate as a result of the new requirements.

Committee approval was being sought to utilise part of the additional funding received to progress priority projects involving the replacement and/or expansion of the early years provision at five key locations across the City.

4.2 Energy in Schools

Details were provided of school energy consumption in 2013/14 and a high level analysis of consumption trends. Information was also provided on progress made against the action plan presented in last year's Schools Energy Report.

4.3 Free School Meals

The Scottish Government had committed to give all children in primary 1 to 3 the option of a free school meal from January 2015. Details were provided on practical and financial issues associated with the introduction of the policy in terms of accommodating and producing the extra volume of meals.

4.4 Sports and Outdoor Learning Unit

Details were provided of front line service delivery by the Sports and Outdoor Learning Unit for children and young people in schools and in community settings. The body of work within the Unit was wide ranging and covered team and individual sports, outdoor learning, residential outdoor centres, the acquisition of achievement awards, the support of school to club links and the development of school based sport hubs.

The Sports and Outdoor Learning Unit consists of Active Schools Co-ordinators, Sports Coaches, Outdoor Instructors, Swimming teachers, Modern Apprentices and other project specific staff members leading learning and coaching, organising tournaments, festivals and adventure activity trips, coaching and supporting others and being involved in planning for children and young people to become more active.

Recent research had indicated that daily intense bursts of physical activity were beneficial to children's health and fitness. A new project to pilot this idea would start in Craigour Park Primary School. The project was being developed in partnership with the Early Years Collaborative and the NHS. If successful, it would be rolled out to other schools in due course.

4.5 Parental Engagement

An update was provided on progress with the implementation of the Parental Engagement Strategy and Action Plan.

5. Neighbourhood Issues

5.1 Parking at schools – update

Moyra Wilson provided an update on the issue of parking at schools. The first meeting of the Working Group established to discuss parking issues had taken place at the end of June. Some of the issues which had been discussed included:

- Possible fines, although this might not be practical as parents moved vehicles before fines could be issued. It was noted however that legislation existed in England where CCTV was used to impose fines.
- Pilot for School Streets campaign involving five schools.
- Good practice for parking to be shared between schools.
- It was noted that the idea of name and shame would be difficult.
- The road safety team had highlighted the importance of schools having updated travel plans.

Councillor Fullerton advised that following feedback from parents, Councillor Godzik, Convener of the Education, Children and Families Committee, proposed to submit the following motion to the Council:-

"Council:

Notes the ongoing pilot, led by the Transport & Environment Committee, seeking to improve road safety around schools in Edinburgh by banning cars from roads immediately outside schools where appropriate, and recognises that parking outside of schools has been a major concern for Head Teachers and parents for many years.

Further notes that the Consultative Committee with Parents (CCwP) has requested that the Council investigate the use of CCTV to improve road safety around schools.

Requests a report on the possible introduction of CCTV around schools not suitable for the current schools street pilot. This would include potential benefits, cost and legal barriers currently in place."

Update for Parent Council Neighbourhood Groups

November 2014

This report provides an update for parents/carers in relation to Children's Services in Edinburgh. We have also included feedback from the Neighbourhood Parent Forums and a progress update on matters arising.

At the previous CCwP the presentation from Billy MacIntyre Head of Resources for Children and Families was very well received. His presentation covered the areas of Rising Rolls/ Children and Families Estate/ Local Development Plan/ Free School Meals. (Reference – <u>Presentation - Rising Rolls, Children & Families Estate, Local Development Plan, Free</u> <u>School Meals</u>)

Rising School Rolls update

The Convener and Vice Convener recently visited the five Primary schools (St David's, Victoria, Broughton, Stockbridge and Craigour Park) to see how they have been developed as part of the rising rolls process. They were very impressed by the high quality of the school extensions. The staff and pupils were also delighted with them.

Asset Management update

An updated Asset Management Plan is being progressed and will be presented to the Education, Children and Families Committee in December 2014. It will include a full assessment of all anticipated changes in the Children and Families estate including the impact of rising rolls and the Local Development Plan. This report will be discussed at the CCwP meeting.

Free School Meals update

As of January 2015 all pupils in P1-P3 will be entitled to a free school meal. A number of schools have identified problems with physical accommodation and we are looking at ways to address these issues. We are awaiting information from the Government on funding.

Online School Payments update – The Children and Families' Pilot

Over the past year I have been keeping you updated on the work in this area. I am pleased to report that the pilot in 5 of our schools – Sciennes, Currie, and Craigroyston Primaries and Firhill and Balerno High schools has been a success.

This project has put in place an online payments system for an extensive range of activities including meals, milk, trips, events, fundraisers, sports coaching; an integrated communications system; and an integrated back office school fund management system.

The evaluation of the pilot has suggested there was wide scale support for online payments together with valuable feedback on how the system could be improved. There were also significant staff time savings through the removal of cash collection and more efficient reconciliation processes.

There is now a national online school procurement process. Once completed this can be rolled out to other establishments. This is likely to be in Spring 2015, subject to funding.

Parking at schools - update

Following the last CCwP meeting, it was agreed that the Convener Paul Godzik would put forward a motion to Council on 25 September to consider requesting that the Council investigate the use of CCTV to improve road safety around schools. This motion was put forward and accepted.

1 plus 2 Languages update

The great work in this area continues. Our 3 year rolling programme will see all primary schools delivering a second language (L2) from P1 at the latest and offering children the experience of an additional language (L3) from P5 at the latest. We are working to a timeline that will mean that all our primary schools will be delivering 1 plus 2 languages by the end of session 2016-17. This will be ahead of the Scottish Government's 2020 deadline for implementation.

An extensive range of high quality learning and teaching resources in different languages, (including Gaelic and Mandarin), is being developed. Activities are designed to be delivered using active approaches to engage and motivate children. These resources have been very positively evaluated both locally and nationally and are now in the process of being packaged to be sold to other local authorities.

The resources are accompanied by extensive training and on-going support for class teachers. We see class teachers' role as vital to successful and sustained implementation of 1+2 Languages. Alongside this training, we offer Primary Languages Learning courses for teachers in a number of languages. These courses aim to develop teacher skills and competence in all taught languages.

Budget Process

I would like to encourage you to 'Have your say on how we invest and spend money' as a Council. The Council is deciding where to invest and where to save money. Have your say on how we do this by 19 December 2014.

Your feedback will help the Council to make its final budget decisions on 12 February 2015.

We are encouraging pupils in schools to look at the online planner as part of a lesson particularly in Secondary schools in Personal and Social Education, Mathematics and Modern Studies. I hope this keeps the momentum and interest going from the great engagement we had from senior pupils with the referendum.

As part of this ongoing engagement process all Parent Chairs have been invited by the Convener Paul Godzik to a budget consultation on the 11 November at the City Chambers (6.00 -7.30pm) to give time to look at the proposals and answer your questions.

October In-service in Secondary Schools

For the third year running Children and Families Quality Improvement Officers delivered training all morning in all the curricular areas across the City. This is in response to the needs of teachers in helping implement the new qualifications.

Early feedback from staff is that this was a well received session allowing staff time to meet with each other and share best practice.

Scottish Learning Festival

This year at this two day National Event I was delighted that we had six representatives from Edinburgh sharing their good practice. Greg Dimeck, Headteacher at Gracemount Primary, presented a seminar on "**The School at the Heart of the Community**". Greg talked about

the importance of community engagement and the challenges faced by schools in promoting successful and dynamic parental engagement. Greg shared information about various strategies from setting up a dads' football team to solution focussed inter-agency working.

The Children and Families' Mental Health & Wellbeing Team presented a seminar on: **'Supporting the Promotion of Mental Health and Wellbeing in Schools'**. This seminar explored the work taking place in Secondary schools across Edinburgh, which aims to increase understanding and promotion of positive mental health and wellbeing in pupils, staff & parents. Jacquie Ramsay Deputy Headteacher from Tynecastle School gave an overview of the benefits and successes for their school community following participation in the 'Growing Confidence' programme.

Pauline Walker, Headteacher at The Royal High School presented a seminar '**Making the most of the Senior Phase**'. The flexibility of the new qualifications enables schools to provide a curriculum best suited to individual needs. Flexible pathways which provide varied approaches to learning and a wide range of curricular options provide new opportunities for learners to certificate at a time which is right for them to maximise success. This will allow our young people to access the best sustained positive destinations.

Sandra Milne, Deputy Headteacher Additional Support for Learning Service, presented a seminar on '**The Fresh Start Literacy Project for Upper Primary Pupils in Edinburgh**'. Sandra shared Edinburgh's successes in the Fresh Start Literacy Intervention Programme. The presentation included a film of Fresh Start in action, highlighting some of the teaching methodology and feedback from learners and their teachers.

Joyce Rochford, Senior Development Officer for the Senior Phase took part in the panel discussion entitled, '**The importance of effective partnership working. Lessons learned through citizenship & enterprise education: failed small, learned big'**. The seminar reflected upon effective partnership working within citizenship and enterprise education, drawing upon perspectives from the public, private and third sectors.

Pilrig Park School's Theatre Arts Group provided a welcomed entertainment break. Sixty pupils performed a 30 minute dance sequence from their show 'Going for Gold' which was staged at the Festival Theatre in June. These young performers received a standing ovation in the main arena and Head Girl Abigail Hillen spoke about how their Going for Gold performance was based on the theme of the Commonwealth Games and how each young person was trying to be the best they could be and achieve that gold medal in all areas of life.

The Drop In

'The Drop In' was launched on Saturday 18 October. This is a new city wide service for families with a child/young person aged 0-18 years old with a disability and their siblings. It provides an opportunity for parents/carers to meet each other and chat over a cuppa whilst their children take part in activities run by experienced youth workers from FABB Scotland and CEC. We are encouraged by the positive feedback from the 24 families who attended on the first week. This is a really positive start and we are expecting numbers to increase as news travels about this new opportunity for families. The two hour sessions are held each Saturday at Jack Kane; Northfield and Willowbrae; Carrickvale; Royston Wardieburn.

Oaklands School welcomes Scotland's Minister for Learning

On 20 August 2014 Dr Alasdair Allan, Minister for Learning, Science & Scotland's Languages visited Woodlands Special School.

The visit was initiated by Avril Elliot, chair of Oakland's School Parent Council. The school shared with the minister the hard work that goes on in Oaklands and their commitment to achieving the very best for pupils, which were recognised in the school's recent positive <u>HMIe inspection report</u>.

FEAST - Families' Edinburgh Additional Support Training

Psychology of Parenting Project

We are delighted that Edinburgh has been selected as a site for the national rollout of Psychology of Parenting Project (PoPP).

PoPP is aimed at improving the availability of high-quality evidence-based parenting programmes for families with young children (3/4 year olds) who have behaviour problems.

Effective interventions are needed for these children because approximately 10% of preschool children display high levels of behaviour problems (aggression, noncompliance and poor temper control) that are strongly predictive of a host of poor outcomes such as school exclusion, juvenile delinquency, substance abuse and mental health difficulties later in life.

Practitioners from a range of services have been identified and facilitator training for the two programmes, Incredible Years and Level 4 Group Triple P is underway.

Creative Writing course

Over 200 S5 and S6 pupils from 20 Edinburgh schools attended this year's Creative Writing Conference on 5 September 2014. The conference was held in partnership with

- University of Edinburgh
- Scottish Book Trust
- Scottish Poetry Library

The event was held at Edinburgh University School of Education, where the students heard a keynote address by Anne Donovan, award winning author of 'Buddha Da'. After this they took part in two workshops, designed to inspire them to write creatively as part of their Higher and Advanced Higher English programme.

The workshops were led by English teachers and professional writers from a range of genres, including fantasy, crime, short stories, poetry and drama. Pupil comments were very positive:

Really loved this event and got me inspired for writing

I felt inspired to write and try out ideas from the workshops. I received good tips and advice which I think will benefit me and improve my writing.

The teacher workshop helped me think of different ways to create my folio. The author workshop was inspiring as we received useful tips for the future.

Thanks to all the teachers, professional writers and Edinburgh University staff involved in the event, for all their help to make this a memorable day for all who attended.

Early Years update

Since the implementation of the <u>Children and Young People Act (Scotland) 2014</u> children aged three and four are now entitled to additional hours of early learning and childcare.

Many children and families across Edinburgh are now benefitting from additional hours of early learning and childcare. We have increased nursery opening hours across local authority nursery schools, classes and Early Years Centres for three and four year olds. Parents who use partner provider early years establishments will receive more financial support. This is the first phase of changes in the way parents can access nursery provision for their children. We will be looking, in future years, at ways to make our early years provision more flexible in the hours that parents can access.

We are also offering places in our nursery settings to some two year olds. We are currently sending out information to our schools and centre's about the application process, including criteria for eligibility and an explanation of where places are available.

In order to deliver increased hours we require more staff across early years. We have established an Early Learning and Childcare Academy which is providing a unique opportunity to young people in Edinburgh who wish to pursue a career in early learning and childcare. We have recruited 11 Modern Apprentice Early Years Practitioners who will work in our nurseries and access training at Edinburgh College. This is linked with the Edinburgh Guarantee.

We have also introduced a trainee Early Years Practitioner programme which was open to anyone wishing to pursue a career in early years. Successful candidates will be able to earn while training. The training will be delivered by successful leaders working in early years in Edinburgh and in our own local authority settings. The programme that has been designed has been described as a 'flagship' for early years training.

Improving school websites

As part of our drive to help improve school websites across the city, we have recently launched:

A new easy-to-follow, comprehensive school websites guidelines that schools can access

- A dedicated section of the Orb (staff site) called Schools on the Orb to support schools in creating their website
- A school website template

The first training course on creating web content for schools ran recently and the second will run near the end of the year.

Over the last year we have audited all primary, secondary and special school websites to check for compliance with legislation and policy and to ensure basic information was in place to help parent's complete popular tasks. We will report on the findings of the audit to schools directly. It is hoped that this will improve your experience of school websites and also give a strong first impression to others looking at our schools.

Achievement Awards

This event held on 11 September, has been a highlight of my year. It is a ceremony that celebrates outstanding achievements from across Children and Families. The evening brings all the applications to life. All entries were of high quality, but the winners of each of the seven categories stood out in improving the lives of children and young people. My award went to the Active Schools team, which I was delighted about, as they do an amazing job increasing young people's participation in physical activity and sport. The Convener's award went to the Speak Up Speak Out campaign, which was a thoroughly worthy winner as they have successfully improved the public's understanding of child protection, particularly issues surrounding the use of social media.

Where one has been available, this will not be taken away but the norm will be to provide packed lunches on Fridays and this applies council- wide. Discussion regarding expected benefits of free schools meals – healthy children, getting children into good eating habits, allow them to enjoy a variety of foods of good nutritional value etc. Nutritionally designed lunches. Ruth Wood asked if it was possible for parents to input into schools meals. Moyra responded that Peter Watten will come along to Feb CCwP meeting to look into issues such as these/answer parents questions. More information is expected in this area as there has been a change of management. Gordon Kaye expressed concern that his home-made packed lunches for his children were more nutritionally valuable than the meals on offer at school. Other concerns expressed: how are meals made, what is in each meal (ie a pizza), is nutritional balance across the whole menu of per meal? 5. Better Relationships, Better Behaviour, Better Learning This is a Scottish/Edinburgh strategy and draft was available last September. The feed back is in and has now been sent out to parents. Look at it in parent councils and feedback to MW at 14 Dec meeting. ALL TO ACTION. Founded on the fact that good relationships = good behaviour and better learning. Restorative approach to learning - a whole new role at Education Scotland.	
6. Severe Weather Resilience officer asked for this to be put on the agenda. Since terrible weather of December 2010, contingencies have been in place and some schools have been doing their own scenario planning. The council has made a commitment to keep schools open as much as possible in severe weather conditions. Every teacher in the city has nominated their local 'snow school' - the school they will go to when the weather is too severe to travel to their usual place of work. Every headteacher has a list of who they can expect to come in as their 'snow school'. It is amazing what can be achieved when everybody joins in and aims to keep all schools open if possible. In the case of the winter vomiting bug, the aim is also to keep schools open. Public health would monitor the situation on a daily basis and send in deep cleaners. If numbers of those affected - pupils and staff - get too high, public health Amy decide to close the school. Advice is as always, do not return to school/work until 48 hours after last symptoms.	
7. Placements Procedures are in place for P1 & S1 placements and are just the same as before. Parents can sign up to the one citizen account if they want. Baptism certificates are required for placement in catholic schools	
8. Traffic Control Measures CCwP - have had 2 meetings about parking and traffic control measures. Kirsty McWilliam outlined the situation at St Johns - what they do/can do (standing with signs, handing out lists of dos & don't see, approaching parents, etc.) and what affect their measures have had. Gavin Brown wants to push through legislation allowing roving CCTV cameras which would spend 1 week at each school. This went to committee Councillor Godsik agreed to look into the use of CCTV cameras. In Oct 2014, the transport committee agreed to suspend traffic from outside certain schools during school start/end/ lunch times. This will be introduced in phases: 1st phase - Aug 2015 -	

Duddingston, Abbeyhill, Colinton, Sciennes, Gracemount, St Johns. 2nd phase - Dec 2015 - Towerbank, St Peters, Clermiston, Bonaly, Buckstone. This started in East Lothian with 3 schools in Haddington - Knox Academy, it's infant & junior schools. This was monitored, deemed successful and decided to pilot in Edinburgh primary schools. The pilot will be evaluated in terms of safety, accidents, tickets issued, feedback from locals. Lindsay Watt commented that their school used junior road safety officers - parents tend to take notice if reminded of their actions by children. Anna asked what about disabled children getting access to schools if the roads are shut off to traffic? Kirsty McWilliam commented that you can buy a disabled parking space but you have to ensure you get the right kind - enforceable by a council traffic warden. Moyra commented that the safety of all children is taken into account and schools are bound by legislation, offering accessibility to all including those with a disability (requiring to be driven directly to school entrance). Gordon Kaye pointed out that these measures may just move the problem geographically elsewhere/further way and that parents who park unsafely may still continue to do so, just somewhere else. Moyra commented that phases 1 & 2 are pilots and we'll have to wait to see what happens.

St Johns new build Kirsty McWilliam reported on the St Johns building issue. Consultation is now closed. Of the 3 options (complete rebuild on PHS site, refurbishment, and rebuild on current site), the 1st was selected. There will be no parking or drop-off zones with new build.

Supply Teachers Gordon Kaye brought up issue with supply teachers. Lots of teachers on short/long term sickness leave. Supply situation appears bad. Brought up with council whose general response was "we know it's bad; it's not just you". Lindsay Watt commented on the availability of teachers - numbers were wrong. There is a lack of supply teachers across Scotland. They're managed by Adecco who would send them out if they had them. It very much depends on the school - there are some areas supply teachers don't want to work in - some say yes but then call in sick. However, situation has changed. Supply teachers used to be able to pick and choose but now they have to go when they're called. The supply teachers situation is in crisis nationwide. Moyra: Karen Prophet is looking into the situation with Adecco & head teachers. It is a difficult situation and they are constantly recruiting. Some supply teachers have been removed from supply list because of behaviour such as mentioned above. There are lots of young teachers looking for work. The council interview for supply teachers & Adecco manage them. There is simply not the volume of appointments that there used to be which relates to permanent positions too. Kirsty McWilliam asked why is there not recruitment on a termly basis? LW responded that the situation is complex and that's maybe not the best way of doing it when temporary contracts only have to give 1 week notice. Peigi McArthur commented that the situation was not quite so bad at secondary level. In England, teachers can only leave at 2 points in an academic year and this may be worth exploring with the council. Lindsay Watt commented that	

recruitments across the city then allocated to particular schools didn't work either; 1 size doesn't fit all. Head teachers need to interview/appoint their own staff for their own particular schools needs. Moyra added that the council are trying to recruit permanent supply teachers - downsides are cost, tied up in 1 school covering long term sick etc. The Scottish government has reduced the pay for supply teachers. Number of reasons for situation but council is actively recruiting - there is a permanent advert out for supply teachers. However, in C&F in general, there is not a high level of absence.

6.	Severe Weather Parents were reassured that there is a Severe Weather policy in place after 2010 winter. This is activated every year in preparation for severe weather. Head Teachers have been sent out relevant information to help them risk assess their schools. There is enough grit around the city, one of the major issues in 2010 was turning circles at schools which were not gritted, this has now been built into the plan and priority will be for special schools .Council policy is to keep schools open where possible but parents will be kept updated through texts/twitter/radio/council website. Due to mild winters this has not been tested! The Council also has plans in place for 'norovirus' and schools will be closed if Public Health advise. Lesson learned from an outbreak at Pilrig Park when it was reported that 67 had the 'norovirus' this did not seem a huge number but in relation to school roll this was significant. Clarified that children should not return to school until 48 hours after last bout. It was suggested that this should be put out to parents for their information as it is policy.	Schools to advise parents of recommendations from public health to remain at home for 48 hours
7.	Review of Nursery Nurse and Support Staff RW gave some background: special schools looked at budgets four years ago in relation to the needs of each school. Two years a review was undertake which included all management roles within special schools, Head Teacher, Deputy Head and Principal Teachers. This has been of great benefit. The final part of the review is to look at support staff: there are eleven special schools who have different support staff (escorts, Nursery Nurses, PSA, behaviour support, group workers and project workers), some of these posts are historic and job descriptions need updated. Early Years reviewed their Nursery Nurse role and these were renamed to Early Years Practitioner and Early Years and Senior Early Years officer roles were created. There are very few Nursery Nurse posts left around the country.	

	The review will look at the different hours, sessional/non sessional nature of posts, roles at the different grades, job descriptions, etc At the last review of Learning Assistants two posts were created PSA and school support this brought with it a new framework for staff, in special schools PSA's are paid at a grade above mainstream schools. The review was launched in October, A Gaw is the project chair and G Tee is taking an interest in the process. Working groups have begun with Nursery Nurses. Keen to have parents involved in the process, decided best way forward is to have parent's feedback through Parent Council and HT and have this as an agenda item on each meeting. Member Support

- 1. <u>Member Support in Edinburgh</u>: a series of information & training sessions has been arranged for the next few months and emails with more details have been sent to Parent Councils by SPTC and Edinburgh City Council.
- 2. <u>Member Survey</u>: A copy of the member survey has been sent to all member organisations, to help SPTC make sure it is providing the support and services our members want.
- 3. <u>AGM 2015</u>: next year we are planning to combine our AGM with a Lecture from a high profile speaker: information to follow. Any member group (PC or PTA) can nominate a parent or teacher to the SPTC board: please consider taking up a role with SPTC.
- 4. <u>Parents Voice</u>: survey report on CfE and qualifications has been published. It is intended that the next survey will be on the implementation of PVG.
- 5. <u>Backchat</u>: we have redesigned Backchat so we are keen to hear members' views. From this issue, members will have to opt in to receive a paper version; otherwise it will be sent by email.
- 6. <u>E-updates</u>: we are refreshing our mailing list and asking everyone to re-subscribe so that we're not spamming folk who don't want our information! Subscription is simple on the website.

What else is happening

- <u>Children & Young People's Act</u>: There will be a consultation on the draft guidance launched at the end of January/February. We will be consulting our members on their views, particularly on the Named Person and Data Sharing elements, so that this can be reflected in our response to the consultation.
- 8. <u>Teacher Shortages</u>: We sent a letter to the then Cabinet Secretary Michael Russell regarding shortages of teachers: we will be having meetings with civil servants to follow up. There has been very positive response from a number of local authorities and teaching unions.
- 9. <u>Scottish Parliament Education and Culture Committee</u>: Evidence was submitted regarding the Government's Budget for local authorities and SPTC has been invited to participate in a panel discussion on 4 November. In addition a meeting has been arranged with the Clerk to the committee, who plays a significant role in advising on the committee's work programme.
- 10. <u>ParentZone</u>: we have been working with other organisations and Education Scotland to help make sure ParentZone is parent-friendly and accessible. The new site will be launched soon.
- 11. <u>School Inspections</u>: Education Scotland is undertaking a long term review of the inspection process: we have been asked to contribute to the debate and are keen to hear from parents about their views and experiences. We are also working to develop and Information Session on the topic of school improvement and inspection.
- 12. <u>SDS My World of Work</u>: SPTC is part of a parent forum set up to SDS to feed into the parent element of My World of Work. There is an online survey for parents: <u>https://www.research.net/s/mywowforparents_evaluation</u>
- 13. <u>RespectMe</u>: We are working on developing and delivering materials for parents to help them work with their children to prevent or deal with bullying.
