1. Welcome and Introduction

Councillor Keith Robson introduced himself to members of the CCWP. As a member of the Education, Children and Families Committee, he had been invited to chair the meeting on behalf of Councillor Godzik who was unable to attend.

1.1 Ellen Muir MBE

Councillor Robson noted congratulations to Ellen Muir, Head Teacher of Pilrig Park School and representative on the CCWP, who had been recently honoured with a Member of the British Empire. Ellen's commitment and leadership had been recognised as an inspiration to both staff and pupils.

2. Minutes

Decision

The Note of Meeting of the Consultative Committee with Parents of 4 December 2014 was approved as a correct record.

3. Director's Update

3.1 Report to Parent Council Neighbourhood Groups

A report had been circulated to Parent Council Neighbourhood Groups providing an update for parents/carers in relation to Children's Services in Edinburgh. The report included feedback from the Neighbourhood Parent Groups and a progress update on matters arising. The Director of Children and Families highlighted the following key areas:

3.2 Ministerial Visits

Details were provided on a number of visits which had provided the opportunity to see different examples of work and good practice going on in schools.

3.3 Education Scotland – Feedback

Education Scotland's annual report on education services in Edinburgh had been very positive. A summary of the areas commended by Education Scotland was provided along with the areas which would be developed further.

3.4 Council Budget

The budget engagement process had ended on 19 December 2014. The Director expressed her thanks to everyone who had contributed to the process feeding into the Council's budget meeting on 12 February 2015. She was pleased to report that school budgets had been protected from significant further reductions.

4. Facilities Management Issues – School Meals and Property Repairs and Maintenance

The Director introduced Peter Watton and Murdo MacLeod who had been invited to present information on school meals and procedures for dealing with property repairs and maintenance issues.

The presentation focussed on:

- the structure of Total FM which served to understand and deliver customer facilities management requirements.
- the school meals service.
- · cleaning and janitorial services.
- repairs and maintenance issues including information on the work of the new asset management section to deliver an ongoing condition survey programme across the estate.

A number of issues were discussed including:

- Wave 4 schools programme it was noted that work was ongoing on new build work priorities and that this would be reported later in the year.
- Improved communication and compliance for sub-contractors meeting timescales and signing off work.
- Improvements to the computerised system to provide information on where logged calls were situated in the queue.

5. Educational Attainment – Improving Outcomes for Learners

Grace Vickers, Quality Improvement Manager had been invited to present information on improving attainment and outcomes for learners.

The presentation gave an overview of improvements in attainment, positive destinations and wider achievement. Details were provided on how schools tracked progress in tackling disadvantage by improving attainment of lower attainers relative to higher attainers. The various opportunities for wider achievement offered to pupils such as volunteering were outlined, together with areas proposed for further improvement to improve outcomes.

7. Committee Reports – Education, Children and Families Committee 3 March 2015

The Director highlighted reports being presented to the Education Children and Families Committee on 3 March 2015 as follows:

7.1 Vision for Schools

Details were provided of progress on the Vision for Schools for all children and young people to have the best start in life; be physically and emotionally healthy; be successful learners, confident individuals, and responsible citizens making a positive contribution to their communities; and to leave school into a positive destination well prepared for work, leisure, family life and lifelong learning.

7.2 Integrated Literacy Strategy

An update was provided on progress of priorities within the 2014-2015 Edinburgh Integrated Literacy Strategy (EILS) action plan.

The overarching vision of the strategy was to improve literacy skills and raise standards for all learners at all stages, enabling them to participate confidently in a wide range of roles in modern society and to contribute to their local community.

7.3 Primary School Estate Rising Rolls

The latest primary school roll projections at a city-wide level estimated that the primary school roll would rise from the position of 28,010 pupils at the start of session 2014/15 to an estimated 31,700 pupils by 2020 and 35,400 pupils by 2030.

To help predict how rising rolls might affect each primary school catchment area, detailed analysis was undertaken each year to identify schools where there could be insufficient accommodation to meet future catchment demand. Schools which would potentially face accommodation pressures in August 2016 and beyond had been identified, with options to address issues at each school.

Engagement would be undertaken with each school community to identify preferred options and would be reported back to Committee in May 2015.

In respect of proposals to alter catchment boundaries between Towerbank Primary School and neighbouring primary schools, initial informal consultation was underway with the affected schools to establish if there were any other feasible or preferred options for alterations to catchment boundaries which would still achieve the required outcome.

7.4 School Based Sports Hubs

Community Sport Hubs were a national initiative designed to improve school to club links and develop partnerships with sports clubs and other community organisations.

The Sports and Outdoor Learning Unit had taken the lead role in the successful development of three school based Community Sport Hubs - Forrester/St Augustine's High School Campus, Broughton High School and more recently The Royal High School. The sport hub approach would be rolled out to other schools and neighbourhoods in the city.

The Director also noted that funding was now available for defibrillators to be placed in all secondary schools.

8. Neighbourhood Issues

Minutes of the most recent meetings of the Parent Neighbourhood Groups had been circulated. Councillor Robson invited any additional information or issues parents wished to raise. Discussion on specific issues raised included the following:-

• School term dates – concern had been expressed at the West Neighbourhood Group that parental consultation on school term dates had not been taken on board. It was suggested that it would be useful if confirmation could be given to parents prior to future consultation, that the Council had no preferred option for term dates. A request was also made for the adoption of an evidence-based approach to school holidays to be considered in terms of what would be best for children educationally, rather than adhering to the current traditional holidays. The Director confirmed that staff and trade unions had also been consulted on the term dates.

• Catchment and non-catchment schools – It was confirmed that a parent could make a request for a non-catchment school and at the same time reserve a place in their catchment school.

- Learning Pathways in a Nutshell. This new Nutshell illustrated and explained the various pathways available for young people to gather awards and qualifications at school, college, university and the workplace.
- Parent Survey of Early Years and Childcare Provision.

Director of Children and Families Update for Parent Council Neighbourhood Groups May 2015

Item 4.1

This report provides an update for parents/carers in relation to Children's Services in Edinburgh. We have also included feedback from the Neighbourhood Parent Forums and a progress update on matters arising.

I was delighted at full Council in March that the good work of Children and Families was publicly recognised by the Council Leader who who highlighted the positive Education Scotland report on Education Services in Edinburgh. Andrew Burns thanked all staff in Children and Families and particularly those in schools for their hard work and commitment which is delivering good and improving education services.

Consultative Committee with Parents (CCwP)

The last meeting was on 26 February 2015. The first presentation was on Educational Attainment which I am pleased to say has improved year on year since 2007 and is now better than national and comparators on most measures. The presentation also described the new way of monitoring educational attainment nationally through a tool called Insight. Parents asked if they could have a copy of this helpful presentation including data on their own school's performance and this was agreed. The second presentation related to Facilities Management. Peter Watton, Acting Head of Corporate Property gave a helpful presentation and responded to parents questions. He clarified that condition surveys had been completed for the whole school estate and extra capital and revenue funding has been allocated to take this forward. He explained the financial challenge but emphasised that the budget would always be there to ensure that health and safety issues are addressed as a priority.

The Budget

As we start another financial year I can report that we delivered a balanced budget for 2014-2015. For 2015/16 we have another £14m savings to find in Children and Families but I am pleased to say that school budgets have been protected from any further reductions.

Vision for Schools

This <u>report</u> describes the good progress which has been made in implementing our Vision for Schools. Educational attainment has improved, there is strong commitment meeting the needs of vulnerable children and children's wider achievements are highly valued.

The following areas are identified as priorities for development:

- Moving our schools from good to great
- Continuing and sustaining improvements in education attainment
- Continuing to strengthen support for children with additional support needs
- Continuing to improve early years
- Continuing to develop and upgrade the school estate

Sub Committee on Standards in schools – 9 March 2015

The recent Sub Committee on Standards chaired by the Convener Paul Godzik was able to celebrate two very positive School Inspection reports from Kirkliston Primary School and Craigroyston Community High School. There was also a positive report on the Craigroyston Learning Community. A report on the ongoing work of Total Craigroyston

also went to Committee on 3 March 2015 and was highly praised for its innovative work which is already improving outcomes for children and families.

Third Party Working Group - 4 February 2015

For the future we want to rethink how we award grants so they are more closely linked to our priorities and our Commissioning Plan. We are re-designing our approach in partnership with the voluntary sector and there have been several engagement events. The feedback will be shared with the organisations and will help to formulate a report to Children and Families Committee in May 2015.

Sports Hubs and Active Schools

At the Committee in March a report on the success of the school-based community sports hubs was shared. We currently have sports hubs in Forrester's/St Augustine's, Broughton and The Royal High School. They are supported financially by SportsScotland who acknowledge Edinburgh's good practice and want to invest further a further £90,000 over the next four years in a bid to expand the successful approach to other high schools and neighbourhoods in the city. Currently these are hoped to include Liberton High School and Leith Academy. There is also a proposal to develop an area-based sports hub in Kirkliston and South Queensferry, through a joint partnership approach with Edinburgh Leisure, which may involve Queensferry High School and the local feeder primaries. I will keep you updated on the progress of these.

Our active schools programme is also hugely successful. Over 13,000 young people are accessing 57 different sports involving 1071 volunteers associated with 211 local community sports clubs.

Placing in Schools

All letters of acceptance or refusal for outwith catchment requests were sent out to Parents/Carers on Friday 13 March 2015 which is almost a month ahead of what we usually do and 7 weeks ahead of our statutory deadline. Appeals are now under way a few weeks earlier than previous years.

Work starts on new primary school buildings

Construction work has started on the next wave of additional classrooms as the City of Edinburgh Council continues to tackle the issue of rising rolls in primary schools. The Council will provide 24 new class spaces, being delivered in conjunction with partners Hub South East Scotland Ltd and Morrison Construction, for the start of the 2015/16 school session.

The primary schools where the new class spaces will be provided are: Clermiston (4 classes), Flora Stevenson (3), Gilmerton (4), James Gillespie's (4), Pentland (3), Ratho (4) and Wardie (2).

In addition South Morningside Primary School will have a temporary annexe created for P1 and P2 pupils at the former Deanbank Resource Centre and extra internal space will be provided at both Brunstfield and Liberton Primary Schools.

Eight primary schools have already been identified by the City of Edinburgh Council as potentially having accommodation issues for August 2016 due to rising rolls - Balgreen, East Craigs, Ferryhill, Fox Covert, Granton, Roseburn, St Mary's RC (Leith) and Towerbank Primary Schools. Discussions have already started with the school communities to consider the best options if additional accommodation is needed.

Towerbank Catchment Review

Committee were asked to approve that a statutory consultation be undertaken regarding proposals to alter catchment boundaries between Towerbank Primary School and the neighbouring primary schools. Officers have just completed an informal consultation with the affected schools to establish if there are any other feasible and more preferable alternative options for alterations to catchment boundaries which would still achieve the required outcome

There will be no impact on children currently at Towerbank however we want to reassure all their parents and those at neighbouring schools that we will listen to their views and take them on board when it comes to making a decision on the final proposals for the public consultation.

The dates for the Public meetings have been arranged as follows:

A further report on the outcomes of the statutory consultation will be submitted to a future Council meeting for consideration.

Defibrillators in all Secondary schools

We are pleased to say that, in consultation with the Scottish Ambulance Service and as part of a Council wide approach, we have made a commitment to install defibrillators in all of our secondary schools. Some of these have already been provided through the

generosity and fundraising efforts of parents and the wider public. The rest will be provided by the Council. I will keep you updated on this initiative.

Safer Internet Day

Our third successful Safer Internet Day was held on the 10th February 2015. This event was organised by the Council and Edinburgh's Child Protection Committee partnership. Safer Internet Day 2015 is celebrated globally and this year's slogan was 'Let's create a better internet together'. Coordinated in the UK by the UK Safer Internet Centre the celebration sees hundreds of organisations get involved to help promote the safe, responsible and positive use of digital technology for children and young people. Our event was well attended by a wide range of professionals, as always the winners from our schools were the highlight of the day.

Early Years

These are exciting and challenging times for early years as we strive to meet the needs of children and families. The introduction of additional hours of early learning and childcare for children has been welcomed by families across Edinburgh. Further engagement with parents will take place next session to ensure more flexible approaches can be considered as we move forward. Plans for new nursery provision across the city are well under way and will provide further opportunities for us to support our eligible 2 year olds and provide more flexible arrangements for parents.

Teacher Numbers

You may have seen recent media coverage relating to the number of teachers employed in Scotland's school and the Scottish Government asking local authorities to commit to maintaining teacher numbers for 2015 at the same level as last year. We have confirmed that our overall teacher numbers will not reduce, particularly as we are currently facing

increased rolls in the primary sector. By maintaining teacher numbers we will access some additional funding from the Scottish Government.

Study Guides for the New National Qualifications

Tina Woolnough the Edinburgh representative on the National Parent Forum of Scotland and co-creator of the Curriculum for Excellence in a Nutshell guides for parents has asked me to distribute the new Nutshell guides. These were well received two years ago when the new nationals were first being introduced. I hope you find these equally helpful.

Please find below the links to the National Parent Forum's Revision in a Nutshell guides for the new Highers (20 subjects) and updated Revision guides for National 5s (20 subjects).

These revision guides contain direct links to SQA specimen question papers, exemplar question papers plus past question papers, where appropriate. They are designed as digital resources and work well with ipads or other tablets.

The guides advise learners to check with their teachers to make sure that material is relevant. The guides are primarily intended to provide the SQA direct links by subject in one place, and to give some additional revision opportunities (if relevant) which are weblinks to school pages or to the websites of subject-relevant organisations.

Schools which have been recognised nationally

It is always good to see the work of Edinburgh's schools recognised nationally.

In the Times Educational Supplement Scotland on the 6 March 2015 we had two significant features. The first relates to the partnership work between with the Scottish Parent Teacher Council and **Sciennes Primary school**. The aim of this <u>pilot project</u> is to strengthen the involvement of parents in the curriculum aspects of the school.

The second feature is the sector-leading work on our **Modern Languages** 1+2 strategy. There was a particular focus on our success in German teaching in Edinburgh. You can read more about this here.

Castlebrae Community High School

I was really pleased to hear about the work between the Edinburgh International Festival and Castlebrae Community High School to create a three year arts residency. From *Castlebrae with Love* is a film and music project which will be shown in the Hub on 15 August 2015

Craigroyston Community High School

The Times Educational Supplement Scotland on 6 April 2015 ran a three page article on Craigroyston Community High School which highlighted as demonstrating national best practice for the way it has improved its senior phase and its

vocational courses to encourage as many pupils as possible to stay on and learn at school. This exemplifies the Wood Commission report which was trying to ensure that all pupils get opportunities to develop skills to be ready for work. You can read the article here.

Unsung stories is an expressive arts project which has been ongoing for the last two years and involved many past and present learners from Kaimes School. It tracks the history of migration to Scotland through personal real life stories and investigation into the past.

The Filmhouse held the premier of their nine short animated films about a wide range of people who have chosen to come from outside Edinburgh to settle here.

Pupils have also created 12 murals which tell the story of migration to Scotland over the centuries to the present day. Some of these panels have been on display in Holyrood at the Scottish Parliament.
