### 5. Committee Decisions - October 2014 - October 2015

On 19 June 2014, the Governance, Risk and Best Value Committee agreed increased monitoring for the dissemination and implementation of committee decisions. It was agreed that a report outlining all decisions taken in the previous year with an update on the implementation of decisions and recommendations to discharge actions would be presented to Executive Committees annually.

### 6. Outcome of the Cultural Policy Review: Culture Plan

The Convener welcomed Donald Smith, Director of the Storytelling Centre, to the meeting. Mr Smith provided an overview of the updated Culture Plan.

The Committee considered the Culture Plan which was a working document, continually updated and available to view in full online. Approval was sought for the Councils representation on the Culture Task Group, created as part of the Culture Plan for an initial period of a year.

#### Decision

- 1) To note that the three-year process to review the 1999 Cultural Policy has concluded, and once again, to thank all those individuals and groups who took part in the review, particularly the members of the Desire Lines Steering Group.
- 2) To note that the original policy objectives of the 1999 Cultural Policy and the five 'Desire Lines' developed in the last consultation phase, were integrated in a single set of objectives within the Culture Plan;
- 3) To approve the replacement of the Cultural Policy with a new Culture Plan, the core of which was appended to the report in a first indicative edition.
- 4) To note that the format and content of the Culture Plan has been devised to respond directly to the key finding of the consultation process, namely that any new Plan should be concise and actions-based.
- 5) To note that the full content of the Culture Plan would be available from early 2016 in a purpose-designed website, which would be updated on a continuous basis, and will act as a single point of contact for information about Council services which support cultural activity and creative industries in the city.

- 6) To approve the replacement of the dormant Cultural Partnership by the creation of a citywide Culture Task Group, to be set up and managed in partnership by the Desire Lines Steering Group and the Council, for a year in the first instance.
- 7) To approve the proposed Council representation on the Task Group as listed in appendix two, and to note that any action required by the Council emerging from the Task Group's discussions will be reported to the appropriate committees for approval.
- 8) To note that the success of the new Culture Plan model will be reviewed and reported annually to the Culture and Sport Committee.

## 7. Museums and Galleries Update

Details were provided on the income maximisation of Edinburgh's Museums and Galleries as well as development of new income streams.

Data from the 2013/14 Local Government Benchmarking Framework showed that in Edinburgh, the cost per museum visit was lower and satisfaction higher than any other major Scottish city authority over the same period.

#### Decision

- 1) To note that the Museums and Galleries service continued to deliver a high quality customer service and maximise income.
- 2) To welcome the progress made on the Calton Hill project, for which an additional £2.4m of external funding has been secured in autumn 2015.
- 3) To request the Director of Culture to investigate the return of the Emperor's Warriors exhibition to Edinburgh through the twin city link with Xi'an, China.
