Pre- Birth to Three Plan for Action

Education, Children and Families Committee

15 March 2011

1 Purpose of report

1.1 To highlight the Council's commitment to the improvement and development of Pre-Birth to Three Services within Edinburgh and set out an action plan to raise standards of care and increase support to young children and their families

2 Main Report

Background

- 2.1 The City of Edinburgh Council's Early Years Strategy and Action Plan launched in March 2010 recognised that all our children deserve to have the best start in life and recognised that what they experience in their earliest years is key to their success in adulthood.
- 2.2 One of its key objectives sets out a commitment to prioritise the development of the 0-3s services.
- 2.3 The importance of the first years of life in influencing children's development and future outcomes are now well documented. The period before birth and in the early months and years of life have a profound effect on all aspects of a child's life.
- 2.4 Dr Suzanne Zeedyk, Senior Lecturer in Psychology at the University of Dundee has been inspirational in her presentations to staff across Edinburgh in describing the neuroscientific evidence that exists to show that brain development is faster between birth and age 3 than during any other period of life.
- 2.5 From conception to age 3, a child's brain goes from being smaller than a seed to being 90% of the weight and size of an adult's brain as it makes connections in response to the world and to the people around it.
- 2.6 There is a strong relationship between early life experiences, and how babies develop cognitively, socially, emotionally and physically throughout their lives. The recognition of this is a core component of *Getting it right for every child* in Edinburgh and a cornerstone of early intervention.

2.7 A wide range of economic studies suggest that returns on early investment in children are high. Research studies by Action for Children, for example, indicate that for every £1 invested in their targeted services designed to catch problems early, society benefits by between £7.60 and £9.20. These savings are seen in the cost of preventable social problems such as crime, mental and physical ill health, family breakdown and substance misuse.

3 Key Achievements to Date

- 3.1 Following the launch of the Early Years Strategy and Action Plan much has been achieved in 0-3s service development, some examples are:
 - Two new Early Years Centres at Craigroyston and the Fort have opened and are able to deliver increasingly flexible services to meet the changing needs of families.
 - A comprehensive training programme has been delivered to staff working with 0-3s.
 - The target to meet the Scottish Social Services Council (SSSC) registration requirements for childcare workers has been met.
 - 93% of preschool establishments are rated good, very good and excellent by the Care Commission.
 - Support to families has increased across the city through the development of the Peer Early Education Partnership (PEEP) which provides an early learning opportunity and universal support to families.
 - The Prepare Project has supported approximately 70 substance misusing pregnant women with intensive, multi-agency support with the aim to stablise and reduce their drug dependency. The project has recently been nominated for a COSLA award.
- 3.2 This list of achievements is not comprehensive and Appendix 1 provides a further summary.

4 Way Forward

- 4.1 There is recognition however, that much more could be achieved. An action plan has been developed which sets out an ambitious agenda and timescales for taking forward 0-3s work and addressing outstanding key issues (see Appendix 2)
- 4.2 To raise the awareness of the importance of work with 0-3s the following measures are proposed:
 - Key messages and articles will be placed in FACe, Outlook and on the City of Edinburgh and other relevant websites to raise public awareness of the importance of the early years.
 - Explore options to raise the profile of early years work through health partners, e.g. DVDs at antenatal clinics, inclusion in red books, developmental checks.

- Engage with the Scottish Government re: possibility of a media campaign e.g.; promotion of national websites- Play Talk Read, LTS Pre-birth to Three DVD
- The option of holding a 0-3s conference will be explored.
- 4.3 In order to raise the overall standard of care in 0-3s services, a range of measures are proposed:
 - A comprehensive training programme for 0-3s practitioners will be delivered to support the upskilling of 0-3s practitioners.
 - The importance of 0-3s training for childcare workers will be raised at a national level. Currently, the vocational training programme, which is the career pathway for childcare workers, offers an optional 0-3s unit and is not a mandatory part of their studies.
 - There will be an expectation that all 0-3s practitioners, supported by CEC, attend the training programme on the Pre-Birth to Three Guidance.
 - It is proposed that a requirement to implement the Pre-Birth to Three Guidance will be added to relevant service agreements with both Sure Start and Partner Provider nurseries. Currently, the CEC contracts with partner provider nurseries cover preschool education (3-5s) and not their 0-3s provision. There may be an assumption, made by parents and carers, that the partnership agreement is a mark of quality which would cover all the nursery provision.
 - A quality assurance procedure for 0-3s will be developed and implemented. Currently, the CEC quality assurance support and challenge visits are aimed at the pre-school education for 3-5year olds and the resource available to quality assure 0-3s services is very limited
 - Information on quality standards will be made more readily available to parents
- 4.4 Support to very young children and their families will be taken forward by the following measures:
 - The roll out of the PEEP programme to reach all areas of the city to increase universal support to children and young families.
 - A review of the Child and Family Centres and related services will be undertaken to consider how best to deliver a range of services to support children and their parents/ carers.
 - The implementation of *Getting it right for every child* will ensure that there is effective assessment and early support for children in need and targeted provision for additional support needs. This will include a programme to promote language development for children at greatest risk in developing the key foundation for literacy.
- 4.5 Opportunities will be taken to refocus and reprioritise resources to ensure that 0-3s work remains a key departmental priority.

- 4.6 The Best Start in Life Group (a subgroup of the Children and Young People's Strategic Partnership) will have a role in overseeing and delivering specific actions which are only achievable with partner engagement, involvement and resources.
- 4.7 The Best Start in Life Group will have a role in monitoring and evaluating progress including the participation of groups protected by equalities legislation.

5 Financial Implications

5.1 Existing funding and staffing resources will be realigned to develop capacity and prioritise early intervention work with 0-3years olds.

Appendix 1

Summary Key Achievements in Early Years March 2010- March 2011

Quality of Provision

93% of preschool establishments are rated good, very good and excellent by the Care Commission.

Support to Families

The following are some examples of support provided to families over the past year:

Child and Family Centres

• C&F centres have provided intensive support to 472 of the most vulnerable children, 82% of which are aged 0-3years.

Parenting Programmes

- 100 practitioners have been trained to deliver PEEP programme which provides an early learning opportunity and universal support to families.
- Number of PEEP groups running increased from 10 in 2009 to 43 in 2010, reaching 400 families.
- 70 starter resource packs are available for PEEP practitioners.
- 20 practitioners have been trained in Mellow Parenting Programme.
- Mellow Parenting Programmes are currently running.
- The Family Nurse partnership (FNP) have successfully recruited 145 mothers under the age of 19 years to this evidence based programme.

Prepare

• Over 70 substance misusing pregnant women have been provided with intensive, multi-agency support with the aim to stablise and reduce their drug dependency.

Early Literacy Resource

• Child Inclusion Research into Curriculum Learning Education (CIRCLE) early literacy resource has been developed.

Sure Start Programme

• 20 Sure Start projects have supported 2,140 parents and 3,447 children aged 0-3 years through a wide range of services.

Inclusive Playschemes (for children with additional support needs)

- Playscheme places have been funded through Childcare Strategy Funding.
- 332 children have attended summer play scheme for 3 weeks.
- 40 children have attended October Playscheme.
- 40 children attended February Playscehme.
- 212 children attended Easter Playscheme.

Affordable inclusive childcare

- 40 children with a disability have been supported to attend mainstream childcare settings through childcare strategy funding
- 15 childcare providers have been offered training and support to become confident in including child with a disability in their mainstream childcare setting

Childcare Strategy funding has contributed to affordable childcare places in areas of deprivation for:

- 90 childcare places for 0-5s
- 140 childcare places in summer holidays
- 315 out of school care places

Play and Outdoor Learning

- Play@Home has been rolled out in partnership with NHS.
- 160 professionals in Edinburgh trained introduced to the play@home programme to use in their work with parents.
- 68 individual families have received regular support through play@home .
- 75 play@home sessions delivered with 831 adult and 1093 child attendances.
- 93 practitioners attended Nature play conference.
- Summer Play Ranger pilot in North Edinburgh.
- Play day event in Grassmarket in August 2010 was attended by over 500 families.

Preschool Education

- Additional teaching resource has increased access to a teacher for pre-school children in 25 pre-school establishments
- Comprehensive training programme to support the CfE has been developed and delivered to all pre-school establishments

Workforce Development

- All C&F practitioners in early settings currently meet SSSC requirements.
- 83% of childcare staff in partner provider nurseries currently meet SSSC requirements.
- 27 early years practitioners are currently undertaking Froebel CPD course which emphasises the importance of outdoor space and nature. The course has been developed in partnership with the heads of early years establishments and Edinburgh University
- In total 533 practitioners have attended training for Birth to Three between 2008-10.
- 98% of partner provider nurseries and 100% of Child and Family centres have attended Birth to Three training.
- 58 Child and Family Staff, 28 Partner Provider Staff and 2 of the Prepare Team have completed the 21 hour CPD course Confident Staff, Confident Children.
- Approximately 419 staff from across the sector- voluntary, private and Local Authority early years settings have attended training or been involved in developing and piloting the 'Thinking Feeling Doing Resource'
- 50 (out of 56) SVQ level 2 and 3 students working in 0-3s playrooms have received a half day training course entitled Emotional Health and Wellbeing: Why What we do Matters.
- The posts of an early years worker and senior early years worker have been introduced on a pilot basis in nurseries to increase flexibility of workforce.
