1 Motion By Councillor Godzik – Reduction of Management Costs in Secondary Schools

Councillor Godzik had tabled a motion on the Reduction of Management Costs in Secondary Schools for consideration at this meeting in terms of Standing Order 27.

Decision

The Convener ruled that the matter was not urgent. Accordingly, the motion would be included as an item for the next ordinary meeting of the Committee.

2 Minute

Decision

3 Edinburgh Youth Issues Forum Event – The United Nations Convention on the Rights of the Child (UNCRC) and a ‘RIGHT blether’

The Committee heard a presentation from a group of young people involved with the Youth Issues Forum, on the theme of the United Nations Convention on the Rights of the Child and a RIGHT blether.

The Edinburgh and National results of the RIGHT blether vote were also presented to members of the Committee, the results of which were intended to help plan the work of the Scottish Commissioner for Children and Young People.

Decision

- 1) To thank the members of the Edinburgh Youth Issues Forum for their presentation.
- 2) To note the success of the event and the issues raised.

4 St Joseph’s RC Primary School and Broomhouse Primary School Accommodation

4.1 Deputation – Broomhouse Primary School Parent Council

The Committee heard a deputation from Carol Munro and Suzanne Herbert, Broomhouse Primary School Parent Council on accommodation issues at St Joseph’s RC and Broomhouse Primary Schools. They highlighted:

- The activities and successes of the school which they felt would be affected if the option to switch accommodation was approved.
- The joint projects currently shared by the two schools.
- The tensions experienced with the accommodation issue being raised again.
- Additional support needs of pupils.
- Practical issues within the school such as the use of class dividers.

- Some factual inaccuracies in Paragraph 5.1 of the Director of Children and Families' report.

The preferred option of Broomhouse Primary School Parent Council was to share accommodation as outlined in Option 1 of the report by the Director of Children and Families (item 4.3 below).

The Convener thanked the deputation for their presentation and invited them to remain for the Committee's consideration of the Director of Children and Families' report.

4.2 Deputation – St Joseph's RC Primary School Parent Council

The Committee heard a deputation from Yuva Arumugam and Rosaleen Hardie, St Joseph's RC Primary School Parent Council, on accommodation issues at St Joseph's RC and Broomhouse Primary Schools. They highlighted:

- The various cultures and religions at the school.
- That St Joseph's was a victim of its own success and pupils were being disadvantaged because of the current over-crowding at the school.
- Potential problems with sharing accommodation such as pupils crossing to the dining area.
- Various health and safety issues that had to be taken into consideration.
- That if the option to share accommodation was agreed, it was likely that St Joseph's would have to come back to the Committee next year requesting more space.

The preferred option of St Joseph's RC Primary School Parent Council was to switch accommodation as outlined in Option 2 of the report by the Director of Children and Families (item 4.3 below)

The Convener thanked the deputation for their presentation and invited them to remain for the Committee's consideration of the Director of Children and Families' report.

4.3 Report by the Director of Children and Families

The Committee had previously agreed, amongst other things, to ask the school management teams and communities of St Joseph's RC Primary School and Broomhouse Primary School to work together in conjunction

with the Children and Families Department to identify a solution to the accommodation issues for implementation in August 2011, and that the Director of Children and Families report to a future meeting.

Details were presented of the three options that had been the subject of further discussion with the respective school communities of St Joseph's and Broomhouse Primary Schools. Option 1 was to share accommodation, Option 2 was to switch accommodation and Option 3 was to cap P1 intake at St Joseph's.

Following these further discussions, no consensus had been reached with the option to share accommodation being the preferred option of Broomhouse and the option to switch accommodation being the preferred option of St Joseph's. Neither school was in favour of the option to cap P1 intake at St Joseph's.

Councillor Wilson was heard as a local ward member.

Decision

- 1) To approve the proposal to share accommodation as detailed in the report by the Director of Children and Families.
- 2) To note that the Archdiocese of St Andrews and Edinburgh had indicated its preference for the option to switch accommodation, and that it considered a 5:3 sharing of rooms arrangement in the southern wing in St Joseph's Primary School's favour to be fairer on a pro rata basis than a 4:4 sharing arrangement.

5 Motion by Councillor Johnstone Remitted from Council – Energy Use in Schools

The following motion by Councillor Johnstone was remitted from the Council in terms of Standing Order 28(3):-

“That this Council;

Notes that sustained low temperatures over winter are putting severe pressure on school energy budgets.

Notes concerns raised by parents over poor energy efficiency and inadequate temperature control within schools.

Notes that feed-in tariffs for renewable energy systems offer a significant income generating opportunity.

Believes that there are significant savings which could be made on energy budgets within schools and calls for a report into these issues and into how the Council can prepare and implement a comprehensive school energy improvement plan in advance of winter 2011-12.”

Councillor Johnstone was heard on her motion.

Decision

1) To note that:

- The Council had acknowledged that the prolonged low temperatures over the winter has caused budget problems for some schools and had taken action to help schools who have a deficit in their energy budgets in the current year.
- A programme is underway to install smart energy meters in all schools and that significant investment of £250,000 is already being made in a variety of measures which will not only see a saving in energy costs but a reduction in carbon emissions. This current investment programme will see voltage optimisers installed in nine of our older secondary schools and a variety of improved insulation and other energy efficiency measures in a range of establishments within the estate.
- A survey of all non PPP schools has been undertaken and each building now has an assessed energy performance certificate.
- A further review of energy consumption and temperature settings in schools has been instructed by the Children and Families Department in order to reduce energy consumption and target improvement measures where they can deliver most benefit.

2) To ask officers to report back to the Committee on progress within two cycles.

6 Strategic Management of School Places: P1 and S1 Intakes for August 2011

School placement, accommodation and associated staffing issues for the anticipated P1 and S1 intakes for August 2011 were presented, together with

details of a series of strategies to manage intake limits for some schools and the action required to address emerging issues.

Decision

- 1) To note the report.
- 2) To agree to follow The Education (Lower Primary Class Sizes) (Scotland) Amendment Regulations 2010 setting a maximum class size of 25 for P1 intakes.
- 3) To prioritise placing requests out of Corstorphine Primary School.
- 4) To prioritise placing requests out of Stockbridge Primary School.
- 5) To note there may be a requirement to prioritise baptised Roman Catholics into St Catherine's Primary School.
- 6) To prioritise baptised Roman Catholics into St Mary's (Leith) Primary School.
- 7) To prioritise baptised Roman Catholics into St Peter's Primary School and prioritise placing requests out of St Peter's Primary School.
- 8) To note that accommodation issues at St Joseph's RC Primary School had been addressed by the Committee's decision at item 4.3 above.

7 School Session Dates 2012/13

The Council on 18 November 2010 had agreed to designate a staff in service training day in all City of Edinburgh primary schools on polling days for fixed term elections, where the dates were known well in advance, subject to further discussion with the Director of Children and Families.

Approval was sought for the School Session Dates for 2012/13 and the designation of polling days as staff In-Service days in all City of Edinburgh schools (secondary, primary, special and nursery).

- 3) That the Director of Children and Families look at the feasibility of changing one of the previously designated in-service training days to the day of the local government elections in May 2012, and report back to members of the Committee.

10 School Attendance in Edinburgh 2009/10

Trends and patterns in school attendance in Edinburgh in 2009/10, and strategies to improve attendance were outlined.

Key factors in improving attendance were:

- Ensuring that all schools had in place policies and procedures informing the management of pupils' attendance and absence.
- Robust monitoring of absence data by schools and the Education Welfare Service (EWS) to identify priorities.
- Setting of challenging attendance targets annually in all sectors.
- Regular review of statistics centrally to inform tracking of individual pupils at risk.
- Working in partnership with parents and other agencies to address attendance issues and to promote early intervention.

The achievements of phase two of the Active Schools Programme and plans for phase three were outlined. Active Schools offered a successful, highly valued and valuable service to Edinburgh's children and young people. **Sportscotland**
