1 Appointment of Vice-Convener 2011-2012

Decision

To appoint Councillor McIvor as Vice-Convener for 2011-2012.

2 Minute

Decision

The minute of the meeting of the Education, Children and Families Committee of 21 June 2011 was approved as a correct record.

3 Motion by Councillor Johnstone – South Morningside Primary School: Save To Spend Proposal to Deliver PE for all Pupils

The following motion by Councillor Johnstone had been remitted from Council in terms of Standing Order 28 (3):

"That this Council warmly welcomes the work of the parent body at South Morningside Parent Council in their efforts to ensure that every pupil at the school receives the national minimum recommendation of two hours physical education each week;

Notes that a recent consultation of parents at South Morningside Primary School voted overwhelmingly in favour of removing the bus service between the school and the Cluny Annexe, saving approximately £20,000 annually and delivering health, educational and environmental benefits;

Notes that £5,000 of this saving could be used to pay for the rental of hall space at Cluny which would allow all pupils at South Morningside Primary School to receive two hours per week of physical education and that P1 and P2 pupils receive only thirty minutes of gym per week at present;

Notes that a proportion of this saving could be used to improve road safety between the main school building and the Cluny annexe; and

Calls for a detailed report into how the Council can best support the school body in taking forward the work required to transfer funding released by cancellation of this coach service into the delivery of two hours physical education each week for each pupil."

Decision

To note that the motion had been withdrawn by Councillor Johnstone.

11 Boyd Anderson Trust

Approval was sought to wind up the current arrangements for the Boyd Anderson Trust and to disburse and utilise the Trust capital to fund appropriate snow sport developments that directly related to the life and legacy of George Boyd Anderson. Midlothian Council had been consulted on the matter, and the proposals had been adjusted following their representations.

It was proposed that the Trust funding be used for three purposes:

- 1) The upgrade of Lagganlia Outdoor Centre in the Cairngorms.
- 2) A capital contribution towards the costs of upgrading Midlothian Snowsports Centre.
- 3) The transfer of an element of the Trust capital to Snowsport Scotland.

Decision

- 2) To refer the report to the Pensions and Trusts Committee for a final determination regarding the disbursement of the Trust capital and the consequent closure of the Trust.
