# Adoption of the Scotland Excel Multi Lot Framework Agreement for the Supply and Delivery of Educational Materials 09-16

## Executive Summary

This report seeks Committee approval to adopt and mobilise the Scotland Excel multi lot Framework Agreement to the most economically advantageous organisations identified, following a competitive tendering process, for the Supply and Delivery of Educational Materials 09-16. The framework consists of nine lots.

The term of the framework will be two years from August 2017 to August 2019 with the option to extend annually for a further two years until August 2021.
The value between the nine lots will be approximately £5m over the term of the framework.

## Report

## Adoption of the Scotland Excel Multi Lot Framework Agreement for the Supply and Delivery of Educational Materials 09-16

## 1. Recommendations

1.1 It is recommended that Committee approves the adoption and mobilisation of the Scotland Excel Framework for the Supply and Delivery of Educational Materials 0916.

## 2. Background

2.1 The Council has utilised the Scotland Excel Framework for Education Materials 0712 from June 2013 to 31 March 2017 and subsequently extended by Scotland Excel to the end of August 2017, the implementation of the new Framework will be 1 September 2017.
2.2 The current framework has been utilised widely by the Council for the supply and delivery of Art and Craft Materials; Bespoke Home Diaries; Board, Card and Paper; Early Learning Materials; Exercise Books; Gym Mats; Musical instruments; Science Equipment and Sports Equipment.
2.3 Of these nine lots six were awarded to Findel Education representing 75\% of the Council's educational material spend of $£ 4.6 \mathrm{~m}$ over the period of 46 months.
3. Main report
3.1 The City of Edinburgh Council wishes to appoint a number of suitable suppliers to provide the Council with supplies of the Educational Materials required for the current Curriculum.
3.2 The tender and evaluation process was conducted in accordance with Council Contract Standing Orders, Public Contracts (Scotland) Regulations 2015.
3.3 A Prior Information Notice (PIN) was published for this tender on 23 September 2016, Scotland Excel undertook a full tender exercise by placing a contract notice on the Public Contracts Scotland and Official Journal of the European Union on 10 April 2017.
3.4 The lots advertised were:

8 Scientific equipment
9 Sports Equipment
3.5 The procurement process followed a two-stage tendering procedure. Stage one, qualification was conducted using the European Single Procurement Document (ESPD). Stage 2 tender submissions were evaluated by a technical evaluation panel against the following criteria and weightings. A technical ratio of $20 \%$ and a commercial ratio of $80 \%$ was applied to all lots.
3.6 The above revised Lot structure was designed to actively encourage both larger organisations and smaller specialist organisations to bid enabling Councils to utilise call offs (including mini-competitions) for their specific spend.
3.7 The following Lots will be called off from the highest scoring bidder (Findel Education Ltd) based on the results noted in appendix 2. Product lists will be subject to further review to provide comprehensive cover.

Lot 3 Board, Card and Paper
Lot 4 Exercise Books
Lot 6 Bespoke Homework Diaries

3.8 Commercial and Procurement Services will work with Schools to carry out mini competitions to further specify their requirements and encourage local supply chain, best value and target Community Benefits directly relevant. Details of successful suppliers can be found in appendix 2.

Lot 2 Arts and Craft Materials
Lot 5 Early Learning Materials
Lot 7 Music Instruments

3.9 Current non-contract items have been incorporated in Lot 1, Commercial and Procurement Services will work with Schools to carry out mini competitions to incorporate the requirements of specialist teaching staff.

## 4. Measures of success

4.1 The success of the framework will be measured by Key Performance Indicators (KPIs).
4.2 KPIs will ensure that strict contract management and performance monitoring is maintained for all maintenance and improvement works carried out on behalf of the Council. KPIs will measure:

- Commercial Management
- Scheduled On-Time Deliveries
- Product Quality
- Customer Care
- Continuous Improvement Measures
- Community Benefit Delivery
4.3 The User Intelligence Group (UIG) will be convened on a regular basis throughout the framework period.


## 5. Financial impact

5.1 The estimated contract value of $£ 5 \mathrm{~m}$ is reflective of all 9 lots historical spend for these supplies. Contract spend across the 9 lots will be monitored on a quarterly basis.
5.2 The costs associated with procuring this contract are estimated to be less than £10,000.
5.3 Pricing is fixed on all lots for the first 12 months of the contract.
5.4 A retrospective rebate will be due when a supplier receives more than $£ 1$ million of expenditure across the Framework (not that of each Council). The rebate will apply to all expenditure.
5.5 The range of products within each lot have been reviewed, updated and extended to meet demand.
5.6 It is anticipated that the above developments should secure a saving of $3.9 \%$ on total spend on this contract equating to $£ 195,000.00$.
6. Risk, policy, compliance and governance impact
6.1 The Scotland Excel procurement strategy includes a robust and comprehensive assessment of all associated risk factors with mitigating actions.
6.2 Awarding this framework will ensure compliance with the Councils contract standing orders, European procurement rules, coalition pledges, our statutory duties and continued delivery of the service.
6.3 Dedicated account managers have been identified through the tender process.
6.4 The Schools Procurement Forum will regularly review the impact of the framework.

## 7. Equalities impact

7.1 The procurement process excludes any bidders where a complaint had been upheld after investigation by the Equality and Human Rights commission or its predecessors and a failure to take remedial action.
7.2 The Equalities Rights Impact Assessment (ERIA) has identified no impact on the Councils specific public sector equality duties.
8. Sustainability impact
8.1 Scotland Excel incorporated a number of sustainability aspects, including supply chain sustainability, waste reduction, environmental considerations and end-of-life processes as well as transportation considerations. For Lot 1, bidders provided details on their sourcing strategies, including sourcing fair trade and ethical products, and how they audit international suppliers that they use.
8.2 With regards to their environmental impact, bidders detailed how they have minimised the packaging required in deliveries and maximised recycling of waste generated by their operations. In addition, bidders provided details on how they can consolidate deliveries, reducing their carbon footprint.
8.3 Bidders also provided details of delivery methods, including the trailing of electric and hybrid vehicles, route planning and how they incorporated environmental factors into their own subcontract activity for delivery partners.
8.4 Environmental considerations such as balanced service deliveries, fuel management and reduced vehicle emissions.
8.5 Bidders were asked to detail community benefit initiatives in line with the Scottish Government's National Outcomes that they would commit to deliver during the lifetime of the framework, e.g. Opportunities for work placements in Music Repair, Graphic Design, Production, Administration, Printing and Print Finishing.

## 9. Consultation and engagement

9.1 Scotland Excel held Technical Panel meetings comprising of members from participating Councils, the City of Edinburgh Council was represented by an officer from Commercial and Procurement Services.
