1. Minutes of meeting of 19th December 2016 for approval

The minutes of the Board's meeting of 19th December 2016 together with the decision list for that meeting, were presented for approval.

Decision: Minutes and decision list approved.

2. Licensing Board Rules – Dates of Meetings 2017/18

The Depute Clerk referred to a schedule of dates provided by the Council for consideration, for Licensing Board meetings up to and including 25th June 2018. It was confirmed that for those dates set beyond May 2016, the Licensing Board appointed after that date would require to consider matters at a later date.

Decision: the Board agreed to amend its rules to include the schedule of meetings dates for 2017/18, with a further report to go before the new Board.

3. Gambling Act 2005 – Applications for Licensed Premises Gaming Machine Permits (More than 2 Category C/D Machines)

The Depute Clerk advised of an application for Licensed Premises Gaming Machine Permit, where the premises licence holder was looking to place more than two category C/D gaming machines on their premises. The application details, and the Board's decision on the application, are listed in the attached decision list.

Decision: application granted, as per attached decision list.

4. Applications for variation of existing premises licences, new premises and provisional premises licences, personal licences, etc

The Board considered twenty-one applications for variation of existing premises licences, five applications for new premises or provisional premises licences and one application for a personal licence, the decisions for which are as detailed in the list appended to these minutes.

Declarations of interest: none

Divisions:

Variation application – Assembly Theatre Ltd – 2 Roxburgh Place – application to amend condition controlling amplified music and vocals; add offsales; commence onsales 11.00 Sunday.

Councillor Redpath, seconded by Councillor Balfour, moved partial grant of the application as sought, on the basis that the variation of condition controlling amplified music and vocals be refused. Councillor Milligan, seconded by Councillor Barrie, moved grant of the application.

Decision: Following a division, the application was partially granted, on the basis that the variation of condition controlling amplified music and vocals was refused.

Variation application – The Voyage of Buck Ltd – 29-31 William Street – application to amend condition controlling amplified music and vocals.

Councillor Redpath, seconded by Councillor Walker, moved refusal of the application. Councillor Barrie, seconded by Councillor Milligan, moved continuation of the application to allow the applicant to meet again with objectors to consider their concerns.

Decision: Following a division, the application was refused.

Variation application – Growler Beers UK Ltd – 38 Bernard Street – application to amend condition controlling amplified music and vocals; add onsales hours; amend children and young persons' access; amend capacity

Councillor Balfour, seconded by Councillor Redpath, moved refusal of the application. Councillor Milligan, seconded by Councillor Bridgman, moved grant of the application.

Decision: Following a division, the application was granted.

5. Personal Licence – Section 82 Notification – Lesley Gilmour

All statutory references to Licensing (Scotland) Act 2005, unless stated otherwise

The Depute Clerk referred to a notification made by Police Scotland of a conviction for a relevant offence acquired by Lesley Gilmour. The Board noted Ms Gilmour was not present and agreed to continue consideration of the matter to its next meeting.

Decision: the Board agreed to continue the matter, to allow Ms Gilmour to attend.

6. Personal Licence – Section 84A Application – Lachezar Boyanov

The Depute Clerk referred to an application from Police Scotland for review of Mr Boyanov's personal licence. Mr Boyanov was not present, at the third time of calling.

Decision: The Board agreed to proceed with a hearing in Mr Boyanov's absence. The Board agreed that it was necessary for the purposes of the licensing objectives, to revoke Mr Boyanov's personal licence.

7. Personal Licence – Section 84A Application – Maciej Zmijewski

The Depute Clerk referred to an application from Police Scotland for review of Mr Zmijewski's personal licence. Mr Zmijewski was not present, at the third time of calling.

Decision: The Board agreed to proceed with a hearing in Mr Zmijewski's absence. The Board agreed that it was necessary for the purposes of the licensing objectives, to revoke Mr Zmijewski's personal licence.

8. Update Report – 1 Sighthill Court, Edinburgh (Crofters)

Following on from a review hearing for the premises licence for 1 Sighthill Court, held by the Board at its meeting of 27th June 2016, the Board noted the terms of an update report from Police Scotland confirming that there were no further issues which would require further action by the Board.

Decision: the Board agreed to note the terms of the police report.

9. Premises Licence review hearing – updated – 260-262 Leith Walk, Edinburgh (Woodland Creatures)

The Depute Clerk referred to the Board's ongoing consideration of an application for review of the premises licence for 260-262 Leith Walk, for which a hearing had commenced on 31st October 2016. The Board heard further from the applicant, Ms McIntosh, and from the agent for the licence holder, Alistair Macdonald.

After careful consideration of all of the representations made at the meeting, the Board agreed that the mediation process already underway should continue, with

a view to achieving possible agreement between the parties. The Board called for an update report on the mediation process, at its meeting on 30th April 2017.

The Board noted in the course of the hearing that the licence holders would agree to limit the use of the external area to the rear of their premises, with an 8pm curfew. It was also agreed that they would explore the possibility of a daily break in the use of the area, during the summer months, with the latter being a matter for discussion as part of the mediation process.

Decision: hearing continued for the mediation process to continue. Further report to be made to the Board at its meeting on 30th April 2017.

10. Premises Licence review application – 88 Portobello High Street, Edinburgh (Galleon Bar)

The Depute Clerk referred to an application for review of the premises licence, submitted by a Mr Yule who was present at the Board meeting. Alistair Macdonald was in attendance for the licence holder, together with Graeme Arnott of Caledonian Heritable, the licence holder.

After careful consideration of the representations made Mr Yule, and after hearing from Mr Macdonald and Mr Arnott, the Board agreed that Mr Yule had not set out grounds in his application upon which a review hearing could proceed.

Decision: application for review of premises licence was rejected.
