### 1. Minutes of meeting of 26<sup>th</sup> February 2018

The minutes of the Board's meeting of 26<sup>th</sup> February 2018, together with the decision list for that meeting, were agreed.

**Decision:** Minutes and decision list agreed.

### 2. Applications for variation of existing premises licences, new premises and provisional premises licences, personal licences, etc – as detailed in separate list

The Board considered eleven applications for variation of existing premises licences, one application for transfer & variation of existing premises licence, four applications for new provisional premises licences and three applications for personal licences, the decisions for which are as detailed in the list appended to these minutes.

### **3. Occasional Licence Application – TV17 Event**

The Depute Clerk reported on an application for Occasional Licence for an event to be held at Ingliston. The applicant's agent provided details about the event.

Following consideration of the application hearing representations from police and LSOs, the Board agreed to grant the application subject to an amended capacity of 6,500 and subject to licence conditions recommended by the Chief Constable and by the LSOs .

**Decision:** Application granted as amended

### **4. Premises Licence Review Hearings – Non-payment of Annual Fees**

The Depute Clerk advised of premises where annual fees for the period 2017/18 remained outstanding. The Board had agreed at its meeting on 29<sup>th</sup> January 2018 that it would be necessary to proceed with review hearings for the premises licences in each case.

The Board noted the terms of LSO reports which had been prepared following premises visits.

### **5. Extended Hours During Festivals – 2018**

The Depute Clerk reported to the Board that in terms of its Statement of Licensing Policy, the Board would have to designate the period during which premises licences which included seasonal variations in their operating plans would be able to benefit from additional on-sales trading hours during the 2018 Festival period.

**Decision:** The Board agreed that the Festival Extended Hours period would operate between 3<sup>rd</sup> and 27<sup>th</sup> August 2018 inclusive.

### **6. Disabled Access and Facilities Statements**

The Depute Clerk advised the Board that from 30<sup>th</sup> March 2018 anyone applying for a new premises or provisional premises licence will be required to provide the Board with a Disabled Access and Facilities Statement with their application. She advised the Board of the details required for completion of the statement, confirming that any application submitted to the Board for consideration without a statement would require to be treated as incomplete.

**Decision:** The Board agreed that the LSOs would note compliance with this requirement and make representations on any contentious applications to the Board.

### **7. Consultation – Update of the Licensing (Procedure) (Scotland) Regulations 2007 - <http://www.gov.scot/Resource/0053/00532211.pdf>**

The Depute Clerk advised the Board of the consultation and timescales for response.

**Decision:** The Board noted the report and that a draft response would be prepared by officers and tabled at the Board for consideration.

### **8. Model FOI Scheme – Update**

The Depute Clerk advised the Board of the requirement to maintain a publication scheme in terms of the Freedom of Information (Scotland) Act 2002. The Board's previous scheme had been prepared having regard to the Scottish Information Commissioner's Model Publication Scheme and she advised that an updated version of the model scheme had been published in 2017.

The Board agreed to adopt an updated publication scheme, taking account of the changes to the model scheme.

**Decision:** the Board agreed to adopt an updated publication scheme.

### **9. Statement of Licensing Policy – Consultation Process – Update**

The Depute Clerk gave a verbal update to the Board on progress in relation to the arrangements for an evening workshop focusing on overprovision as a topic and dates for oral hearings to be scheduled following on from the written responses received to the informal consultation. She further advised that these dates were being arranged to suit the majority of members and once all responses were received then the confirmed dates would be circulated to members.

**1. Purpose**

- 1.1 To advise the Board of the requirement to hold a hearing for the review of Mehmet Cagritekin's personal licence

**2. Main Report**

- 2.1. Mehmet Cagritekin holds a Personal Licence issued by the Edinburgh Licensing Board. Where a personal licence holder acquires a conviction for a relevant offence they are required to provide the Licensing Board with notification to that effect. Notice is then sent to the Chief Constable in order for him to provide a notice either confirming the conviction details or otherwise. Where the Board receives such a notice, it must hold a hearing.

- 2.2. If, after proceeding with a hearing, the Board is satisfied that it is necessary to do so for the purposes of any of the licensing objectives, it may make an order:-

- (a) revoking;
- (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
- (c) endorsing

the licence held by the personal licence holder.

- 2.5 In this instance, notice has come directly from Police Scotland regarding a conviction acquired by Mr Cagritekin. He has been invited to attend the Board meeting, in order that the Board can hold a hearing on his personal licence and decide what action, if any, is considered necessary for the purpose of the licensing objectives.

**3. Recommendation**

- 3.1 The Board is required, having regard to the notification contained in the Chief Constable's report:-

- (a) to hold a hearing on the personal licence;
- (b) to decide whether to take any action with regard to the personal licence.

1. Purpose

- 1.1 To ask the Board to consider whether it is ~~necessary to make a~~ premises licence review proposal, on the basis as narrated in the report.

2. Main Report

- 2.1. A premises licence holder has a duty to inform the Licensing Board if they are convicted for a relevant offence. The 2005 Act provides a definition of what is considered to be a "relevant offence". The Chief Constable is required to provide the Board with a notice confirming the conviction details, or otherwise and may make a recommendation with regard to the premises licence holder's licence(s).
- 2.2. Where the Board receives a notice from the Chief Constable confirming the conviction details but containing no recommendation, the Board has a discretion to decide whether it is considered necessary to make a review proposal, or to note the details and take no action.
- 2.3. Where the Board receives a notice from the Chief Constable confirming the conviction details and the Chief Constable has made a recommendation, it must make a proposal for review of the relevant premises licence(s). When considering the details of the Chief Constable's notice, the Board should consider the following:-
- (a) Whether it discloses that one or more of the conditions to which the premises licence(s) are subject have been breached, or
  - (b) any other ground relevant to one or more of the licensing objectives, namely:-
    - i. preventing crime and disorder,
    - ii. securing public safety,
    - iii. preventing public nuisance,
    - iv. protecting and improving public health, and
    - v. protecting children and young persons from harm.
- 2.4. If, following a hearing, the Board is satisfied that a ground for review is established, the Board may take any of the following steps:-
- (a) issue a written warning to the licence holder
  - (b) make a variation of the licence
  - (c) suspend the licence for such period as the Board may determine
  - (d) revoke the licence
- 2.5. The review proposal relates to the premises licence for the 88 Diner, 88 Grassmarket. The holder of the premises licence is El Toro Loco Limited, of which Mr Cagritekin is a director. His agent intimated details of Mr Cagritekin's conviction for relevant offences. The Chief Constable's notice in response is provided, together with the agent's intimation. Mr Cagritekin has been invited to attend the Board

meeting in connection with his Personal Licence, which is separately reported on.
