1. Minutes of meeting of 26th March and 16th April 2018

APPLICATION TO EXTEND PERIOD OF PROVISIONAL LICENCE - 121
GREAT JUNCTION STREET, EDINBURGH

1. Purpose

1.1 To ask the Board to consider an application to extend the provisional period for a provisional premises licence.

2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If it is not confirmed before the end of the provisional period, the licence is treated as revoked. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, if appropriate, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting such an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.5 An application has been made to extend the provisional period for the premises 121 Great Junction Street, Edinburgh by at least one year or such longer period as the Board considers appropriate. The circumstances upon which the request has been made are set out in the attached letter. The licence was granted by the Board on 25th August 2014. The provisional period will expire on 25th August 2018.

3. Recommendation

3.1 In the event that the Board is satisfied with the reasons given, the Board is asked to reach a decision on the duration of any extension of the provisional premises licence, noting that a period of more than one year has been requested.

PREMISES LICENCE REVIEW PROPOSAL – 14-18 LADY LAWSON STREET, EDINBURGH

1. Purpose





- 1.1 To ask the Board to make a premises licence review proposal, naving regard to the circumstances as set out below;
- 1.2 To consider revocation of the premises licence, on the basis of those circumstances.

2. Main Report

- 2.1. The premises licence for 14-18 Lady Lawson Street was held by the company S. C. Cultural Limited, company number SC429644. It has been confirmed that the company was dissolved on 21 November 2014.
- 2.2. The premises are not currently being used for the sale of alcohol, as there is no premises manager in place. In all other respects the premises have operated without causing problems for LSOs or police. The premises licence annual fees have been paid on time every year.
- 2.3. Dissolution of the company does not result in the premises licence ceasing to have effect, in terms of section 28 of the 2005 Act. However the dissolution of the company means that it would not be possible for the existing premises manager to be replaced, for example, in the event that this became necessary. The Board is therefore asked to make a review proposal, on the basis of the licence holder company having been dissolved and having regard to the potential detrimental impact upon the licensing objectives.
- 2.4. In the event that the Board agrees to make a review proposal, it is suggested that it would be appropriate in the circumstances to revoke the premises licence.

3. Recommendation

- 3.1 The Board is asked:-
 - (a) to make a review proposal on the ground stated; and to revoke the premises licence.

PERSONAL LICENCE REVIEW - SECTION 84B - ALAN JAMES MARION

1. Purpose

ITEM No.

1.1 To advise the Board of the requirement to hold a hearing for the review of Alan Mahon's personal licence, following an application for review submitted by the Council's Licensing Standards Officers.

2. Main Report

- 2.1. Alan Mahon holds a Personal Licence issued by the Edinburgh Licensing Board. The Council's Licensing Standards Officers have made an application for review of Mr Mahon's personal licence in terms of section 84B of the Licensing (Scotland) Act 2005, citing inconsistent conduct with the licensing objectives of:-
 - Preventing public nuisance
 - Securing public safety
 - Preventing crime and disorder
- 2.2. Section 84B states that where a Board receives a report from the Council's Licensing Standards Officers seeking a review of personal licence, it may hold a hearing.
- 2.3. If the Board decides it is necessary to proceed with a hearing and is satisfied that it is necessary to do so for the purposes of any of the licensing objectives, it may make an order:-
 - (a) revoking;
 - (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
 - (c) endorsing

the licence held by the personal licence holder.

2.5 The Board is required to consider whether to hold a hearing on Mr Mahon's personal licence having regard to the terms of the LSO application. If it is considered necessary to proceed with a hearing, the Board will then have to decide what action, if any, is considered necessary for the purpose of the licensing objectives. Mr Mahon has been invited to attend.

3. Recommendation

- 3.1 The Board is required, having regard to the LSO application:-
 - (a) to decide whether to hold a hearing on Mr Mahon's personal licence;
 - (b) if it holds a hearing, to decide whether to take any action with regard to Mr Mahon's personal licence.
