1. Minutes of Meetings of (a) 30<sup>th</sup> July 2018 and (b) 13<sup>th</sup> August 2018

The minutes of the meetings of 30<sup>th</sup> July and 13<sup>th</sup> August 2018 were agreed as providing accurate records of those meetings

Decision: minutes of 30<sup>th</sup> July and 13<sup>th</sup> August 2018 agreed.

2. Verbal Update – formal consultation on draft revised Statement of Licensing Policy and Assessment of Overprovision

The Depute Clerk advised the Board's consultations on the draft Statement of Licensing Policy and the Assessment of Overprovision were now open, with details published on the Council's online Consultation Hub and circulated to consultees. He advised there had been a delay of around a week in publishing the details online and the Board agreed therefore to extend the deadline for responses to 5<sup>th</sup> October 2018.

The Board noted there would be a requirement to hold its joint meeting with the Licensing Forum, and agreed that meeting should be held once the consultations period had closed.

Decision: deadline for responses to consultations extended from 1<sup>st</sup> to 5<sup>th</sup> October 2018. Joint meeting with Licensing Forum to be held after that date.

3. Chief Constable's Annual Report

Inspector Mark Wilson was in attendance to speak to the terms of the report. He highlighted particular parts of the report, including the manner in which Extended Hours applications were made, and the increased use of occasional licence applications for temporary licensing of premises.

Board members discussed the terms of the report and impacts upon police resourcing in the city centre area. The Board also noted the success of the “Ask Angela” initiative, and the intention for it to be rolled out further.

#### 4. Change of Licensing Board Membership

The Convener advised the Board that Councillor Steve Burgess would be joining the Board (his completion of the mandatory training was confirmed later in the morning), replacing Councillor Mary Campbell who had resigned as a Board member.

The Convener expressed his thanks for Councillor Campbell’s contribution to the work of the Board over the past year, and welcomed Councillor Burgess as a new Board member.

#### 5. Applications for variation of existing premises licences, new premises and provisional premises licences, personal licences, etc – as detailed in separate list

The Board considered eleven applications for variation of premises licences, eleven applications for provisional and premises licences and two applications for personal licences, the decisions for which are as detailed in the list appended to these minutes.
