Preliminary Matters

The Board agreed that it would consider a late item for inclusion in the Agenda, being item 8 as listed in the minutes below

Personal Licence Renewals

The Convener opened the meeting by drawing attention to the requirement for holders of Personal Licences issued by the Licensing Board to ensure that they met the deadlines set down by regulations. He referred to efforts which had been made to publicise this issue. He noted that there was a significant number of licence holders whose licences had been issued in September 2009, for whom there would be a May 2019 deadline for renewal procedures to be completed.

He encouraged agents and licence holders to ensure that they submitted their renewal paperwork in sufficient time.

7. Licensing Board Policy – Occasional Licence Applications

The Depute Clerk presented a report to the Board highlighting the terms of the new policy on Occasional Licences and providing details of premises which were currently being licensed by means of their longer term use.

The Board discussed the implications of premises being licensed longer term by Occasional Licences. Noting the number of premises being licensed in this way, the Board agreed that a separate meeting should be convened, with the relevant licence holders invited to attend in order that the Board could establish whether continued licensing by means of occasional licences was appropriate, having regard to the terms of its policy.

8. Premises Licence Reviews – Non-payment of Annual Fees 2018/19

The Depute Clerk referred the Board to a report setting out details of premises licences where the annual fees for 2018/19 remained unpaid, having become due for payment in October 2018.



The Board noted the details of the premises provided and the efforts made so far to encourage payment of the fees. The Board agreed it was necessary to proceed with review hearings for the various premises, and these would be scheduled over the next two Board meetings.
