MINUTES OF MEETING

MONDAY 27th MAY 2019

1. Licensing Board change of membership

The Convener noted the change in membership of the Board as Councillor Cathy Fullerton had resigned and Councillor Derek Howie had been appointed as her replacement by the Council. The Convener thanked Councillor Fullerton for her service to the Board since 2017 and intimated that arrangements were being made for Councillor Howie to complete the necessary statutory training prior to sitting on the Board

2. Personal Licence Renewals - Update

The Depute Clerk advised that as of 21st May 2019 the Board had received 577 applications in respect of renewal of personal licences due to expire by the end of 2019 and 274 applications had been granted.

The Board noted that the last date for the submission of personal licences due to expire as of 31st August 2019 was imminent being 31st May 2019 and again encouraged licence holders to submit applications timeously.

3. Minutes of Meeting of 29th April 2019

The minutes of the meeting of 29th April 2019 were noted and approved.

4. Request for Extension of Provisional Licence (continued) – Lidl, 234-246 Easter Road

The Board was provided with updates from Colin McCulloch confirming the position for Building Standards, and from Andrew Hunter on behalf of the licence holder. The Board agreed to a further continuation of the provisional period for one month, noting that efforts were continuing towards confirmation of the provisional premises licence.



5. Request for Extension of Provisional Licence – 85/87 South Bridge

The Board heard from Alistair Macdonald on behalf of the licence holder, and from Colin McCulloch confirming the Building Standards position on the request for extension.

The Board agreed to a six month extension of the provisional period.

6. Request for Extension of Provisional Licence - 120 Dundas Street

The Board heard from Alistair Macdonald on behalf of the licence holder, and from Colin McCulloch confirming the Building Standards position on the request for extension. The Board noted the provisional period would expire In July.

Review of premises licence – Oceana Bar, 145 Ferry Road, Edinburgh – verbal update

The Depute Clerk confirmed the Board had previously considered an application for review of the premises licence, submitted by the Council's LSOs. Tom Veitch provided the Board with an update, advising that a level set had been carried out at the premises, ensuring the volume of the jukebox operating in the premises was controlled. There were no further issues to report and the Board noted the position.

8. Personal Licence – section 83 hearing – Murray Duncan

The Depute Clerk advised the Board of the basis upon which there was a requirement to review Mr Duncan's personal licence. The Board heard from Mr Duncan and after due consideration agreed to endorse his personal licence.

9. Scottish Government Consultation – Occasional Licences – fees and duration

The Depute Clerk advised of the details of the Scottish Government's consultation on occasional licences. She confirmed the closing date for responses was 16th July and it was agreed that the views of Board members would be collated with a view to submitting a response to the consultation. The Board considered it would be beneficial to have information made available from the Council's Licensing Service about the costs of administering occasional licence applications.

Scottish Government Consultation – Draft Guidance – Licensing (Scotland) Act 2005

The Depute Clerk referred to the Scottish Government's consultation on the terms of the new draft guidance to the 2005 Act. The Board agreed the terms of the report provided for consideration. During discussions, it was agreed it would be beneficial to highlight to the Scottish Government the Board's concerns about the part of the 2005 Act dealing with excluded premises, in view of developments in case law.

11. Licensing Board Equalities Policy and Equalities Outcomes

The Depute Clerk confirmed work was continuing on this matter and that a detailed update would be provided to the Board at a future meeting
