1.1 Nick Smith from the Edinburgh Alcohol and Drug Partnership (EADP) and his colleague Hannah Carver discussed how they might be able to assist in co-ordinating a data gathering exercise about consumption and impact of alcohol in Edinburgh, on behalf of the Forum and the EADP. Nick will email a copy of the presentation to Isla Burton to put onto the Licensing Forum website. They plan to look at overprovision of alcohol. The challenge they may face is the less obviously problematic drinkers. Data indicate that in the Lothians, with regards to consuming alcohol, 12% don't, 45% are above the recommended guidelines and 25% are at a hazardous level. It was noted that people who live just a short distance from licensed premises are 50% more likely to consume. In cases involving Child Protection issues, where the parents have an alcohol problem, it was noted that 41% of 13 year olds and 78% of 15 year olds have had an alcoholic drink.

EADP are currently working with Lothian and Borders Police on alcohol related offences. A 2012/2013 report indicated that 3,500 people were referred to Alcohol Misuse Service.
