 - iv) The organiser will adhere to the additional conditions requested by Public Safety:

No playing of music until the bands / dance groups are on Bank Street due to the fact there is a 14:00 hrs wedding taking place in the Signet Library.



Maximum 180 people allowed to cross Mound / Princes Street / Hanover Street junction.

The parade will only have one opportunity to cross the above junction within the allocated 5 minute closure, any person unable to cross within this time will be redirected into West Princes Street Gardens.

The parade must remain in the left-hand lane of the road (specifically the Northbound carriage way down the mound and up Hanover Street.

2) Edinburgh Stone of Remembrance

To make an order in respect of the proposed Legion Scotland – Edinburgh Stone of Remembrance parade on 11 November 2018 within the designated route and times imposing conditions that:
