## 1 Minute

**Decision**

## 2 Revenue Budget 2010/11 to 2012/13

The Joint Board's three year revenue budget for the period 2010/11 to 2012/13 was presented. Approval was sought for the proposed budget for 2010/11 and the indicative budgets for 2011/12 and 2012/13 were presented.

A detailed risk analysis had been undertaken as part of the 2010-2013 budget process which had identified a number of potential risks inherent in the process, not all of which could be quantified.

- 4) To note the savings targets for 2011/12 and 2012/13 as set out in paragraph 3.4 of the Treasurer's report.
- 5) To note the risks identified in paragraph 6.3 of the Treasurer's report.
