## 1. Deputations

### (a) Crammond and Barnton Community Council

Crammond and Barnton Community Council had submitted a request for a deputation in respect of the Local Development Plan

#### **Decision**

To continue consideration of the request to the meeting of the Planning Committee on 14 May 2015.

## (b) Friends of Granton Castle Walled Garden

The Committee agreed to hear a deputation from Kirsty Sutherland, Linda Garcia and David Leslie representing the Friends of Granton Castle Walled Garden.

The deputation made the following points:-

- The site comprised 7 hectares of walled Stuart-era garden, and use of the land for horticultural purposes dated back at least 500 years. While the castle itself had been entirely quarried in the 1920's, the garden had survived, though it had become very overgrown in the eight years it had been locked up following planning permission being given on a 'minded to grant' basis.
- The garden provided an important link with the past and had been connected with famous figures throughout its history. It was important to preserve this link for future generations.
- Given the site's significance, it did not appear to be the most appropriate land for development. Other sites along the Waterfront provided more suitable land for housing.
- In terms of planning procedures, 'minded to grant' status meant that the application could be left on hold for protracted periods. In the event that the applicant did not conclude the Section 75 agreement, the application did not

lapse, but neither was it cleared. This suggested that a review of the procedures was necessary, bringing in a time limit for the conclusion of agreements.

#### **Decision**

- 1) To thank the deputation for their presentation.
- 2) The Acting Head of Planning and Building Standards to submit a report to the Development Management Sub-Committee on the progress of the 2003 application (03/04595/FUL).
- 3) The Acting Director of Services for Communities to report to the Planning Committee on procedures for legacy applications and options available to timelimit the conclusion of legal agreements.

## 11. Motion by Councillor Mowat – Student Housing

The following motion by Councillor Mowat was submitted in terms of Standing Order 16:

#### "Committee notes:

- That the increasing numbers of applications for student housing in Edinburgh specifically in the Southside/Newington, City Centre, Leith Walk and Craigentinny/Duddingston Wards and that recent applications have raised concerns from residents that a large quantity of student housing is being granted in areas which require additional housing.
- That there are fewer burdens on the providers of student housing and is concerned that the market is being artificially skewed in their favour.
- That overwhelmingly responses to the Local Plan have asked that housing be kept off the Greenbelt and directed to brownfield sites some of which are the same sites being utilised for student housing and.
- Asks officers to compile a report in 2 cycles detailing the relative burdens placed on student housing and housing and proposals as to how the burdens could be equalised or removed."

# 12. Motion by Councillor Mowat – House In Multiple Occupation - License Requirements for Student Housing
