3 Houses in Multiple Occupation – Delegated Powers – Temporary Exemption Orders – Housing (Scotland) Act 2006

On 31 August 2011 the Scottish Government will bring into effect part 5 of the Housing (Scotland) Act 2006. From this date the statutory framework for

licensing of Houses in Multiple Occupation (HMO) will be transferred from the Civic (Government) Scotland Act 1982 to the Housing (Scotland) Act 2006

Sections 142 and 143 of the Housing (Scotland) Act 2006 Act introduced new provisions allowing a local authority to grant temporary exemption orders where the owner of a property operating as an HMO without a licence is taking steps to stop the property being used as an HMO. A temporary exemption order exempts a property owner from the requirement to obtain an HMO licence during the period of the order. Orders may be granted where a property owner identified the steps that were being taken to cease the use of the property as an HMO and has carried out works as required by the local authority to improve the safety or security of tenants during the period of the order. A temporary exemption order would have effect for a period of three months and may be extended once for a further period not exceeding three months on application of the owner.

Approval was sought to delegate authority to the Acting Director of Corporate Services to grant, vary, refuse, extend and revoke temporary exemption orders in terms of sections 142 and 143 of the Housing (Scotland) Act 2006

Decision

To recommend to the Council that authority be delegated to the Acting Director of Corporate Services to grant, vary, refuse, extend and revoke temporary exemption orders in terms of sections 142 and 143 of the Housing (Scotland) Act 2006.

1 Taxi Fare Review 2011

1.1 Deputation – Edinburgh Taxi Partnership

Bill Purnell of the Edinburgh Taxi Partnership advised that there had been no increase in the fees for three years and the trade were now asking for a fair deal from the council on this matter.

At a meeting with council officers on 12 October 2011, the trade's proposals which included an increase of 8.4% in the tariff, an increase from eighty pence to two pounds for hires commencing at the airport, fare reviews to be carried out every year rather than every eighteen months, and that the period covered by the higher tariff at New Year terminate at midnight on 2 January were presented.

Mr Purnell advised of the trade's dissatisfaction that the Council had not appointed consultants to undertake a fare review of their own, and that it had been left to the trade to bring forward proposals. The trade was also disappointed that council officials had decided to recommend only parts of their submission for approval.

He further indicated that the airport charged a fee of £2.10 which allowed the driver eight minutes to pick up the fare and exit the area after this the fee rose incrementally. Other authorities allowed this charge to be included in the tariff and recently the Northern Ireland Department of Environment had agreed to include airport charges in taxi tariffs. However, if the Council were not prepared to increase this charge then the trade would request that a 10.5% increase be introduced instead.

In conclusion Mr Purnell requested that the Committee support the trade's proposals.

1.2 Report by the Director of Corporate Governance

The Council was required to review taxi fares at regular intervals not exceeding eighteen months and set the maximum level of fares for all taxis. Discussions had taken place with the trade as to whether any changes were required and proposals for the Taxi Fare Review 2011 were presented.

Decision

- 1) To propose a taxi fare increase as detailed in appendix 3 of the report by the Director of Corporate Governance with the exception of the increase in fares for hires from the airport with a proposed implementation date of 27 December 2011.
- 2) To instruct the Director of Corporate Governance to place an appropriate advertisement and invite responses within the statutory period of one month of the advertisement
- 3) To not accept the request for a fare an increase for hires from Edinburgh Airport
- 4) To decline the request that fares be reviewed each year
- 5) To defer further consideration of the matter until the meeting of the Regulatory Committee on 6 December 2011.

Regulatory Committee

16 December 2011

1 Purpose of report

- 1.1 To provide the Committee with a summary of a number of outstanding matters arising from the Council's existing policy on street trading;
- 1.2 To offer guidance on proposals for changes to the Council's policy;
- 1.3 To suggest a process of consultation and further investigation.

2 Summary

- 2.1 This report seeks to draw together a number of issues which have been highlighted in connection with the licensing of street trading within the City of Edinburgh area over recent years, having regard to the Council's existing policy.
- 2.2 During the period in which the Council's current policy on street trading has operated, a number of specific issues have been identified as requiring further consideration. These include:-
 - (a) consideration of controls on street trading activity in specified geographical areas;
 - (b) conditions of licence;
 - (c) specific types of street trader activity.
- 2.3 Given that the Council last considered its overall policy relating to Street Trader Licensing in terms of a report (following detailed consultation) on 9th December 2004, it is considered appropriate for this matter to be considered further by the Regulatory Committee at this time.
- 2.4 Any change to adopted policy would require, in terms of relevant case law, consultation with those likely to be affected by such change.

3 Main report

3.1 The operation of street trader licensing in the City of Edinburgh is controlled by means of section 39 of the Civic Government (Scotland) Act 1982. The definition of street trading in the 1982 Act includes, within a public place, "offering to carry out or carrying out for money or money's worth any service to any person in the public place...".

The 1982 Act states that the licence is required "for street trading by a person, whether on his own account or as an employee".

- 3.2 The Council's current conditions of licence for street traders are appended to this report, (appendix 1). There are additional, general conditions attached to street trader licences for pedicabs.
- 3.3 The Council's current policy on street trading in the city was approved in December 2004, after extensive consultation (appendix 2). Representations were made with regard to pedicabs during that process and the Council agreed that the operation of pedicabs should form the subject of a separate report. A detailed report, to include consideration of areas for improvement of the existing regime is intended to be made available for the Committee's consideration in January 2012.

Hot Food Takeaway Units

- 3.4 On 15 October 2009, the Council, following consideration of a Motion by Councillor Mowat, asked the Director for a report on hot food takeaway units, specifically "whether it is appropriate to site such units within 200 metres of:
 - designated local shopping areas as they compete with rate paying businesses in the area and can create pavement congestion;
 - school boundaries as their presence within this boundary undermines the Council's commitment to promote healthy eating within our schools."
- 3.5 In considering applications for grant or renewal of street trader licences, the Committee is entitled to consider refusal of an application where it is considered that the unit "...is not suitable or convenient for the conduct of the activity having regard to-
 - (i) the location, character or condition of the premises or the character or condition of the vehicle or vessel;
 - (ii) the nature and extent of the proposed activity;
 - (iii) the kind of persons likely to be in the premises, vehicle or vessel;
 - (iv) the possibility of undue public nuisance; or
 - (v) public order or public safety",

all as provided in terms of paragraph 5(3)(c) of schedule 1 of the Civic Government (Scotland) Act 1982. The Act also provides for consideration of "other good reason for refusing" an application.

In light of the extensive grounds for refusal as stated above, it is suggested to the Committee that there are adequate powers available to enable the Committee to reach decisions on individual applications, on a case by case basis.

- 3.6 The adoption of policies has the benefit of ensuring that those applying for licences are aware of the locations and types of activity which may be favourably considered and those which will not. However in consideration of prescriptive zoning policies, the Council's powers are limited by the Provision of Services Regulations 2009, which give effect to the EU Services Directive.
- 3.7 The Regulations prohibit the following:

21(e) "the case-by-case application of an economic test making the granting of authorisation subject to-

- (i) proof of the existence of an economic need or market demand,
- (ii) an assessment of the potential or current economic effects of the activity, or
- (iii) an assessment of the appropriateness of the activity in relation to the economic planning objectives set by the competent authority..."
- 3.8 Regulation 22(2)(a) refers to "quantitative or territorial restrictions, in particular in the form of limits fixed according to population or of a minimum geographical distance between persons providing the service...". The effect of the regulation is that the licensing authority is required to ensure that it does not make access to street trading dependent upon such a requirement.
- 3.9 However such "quantitative or territorial restrictions" may be imposed, provided that the following conditions are met:-
 - (a) non-discrimination;
 - (b) necessity i.e. overriding reason relating to the public interest;
 - (c) proportionality

200m exclusion - competition issues

3.10 With regard to the first part of the 15 October 2009 Motion, it is suggested that adopting a general policy which seeks to control or prohibit street trader licensing with particular regard to other, competing businesses in a particular location would be challengeable in terms of the 2009 Regulations, and Regulation 21(e) in particular. Given that Paragraph 5 of schedule 1 to the 1982 Act requires to be read in such a manner as to give effect to the EU Services Directive, the Committee would be entitled to give consideration to such a territorial restriction on a case by case basis as at present, provided that

it continued to have regard to non-discrimination, necessity (for example, pavement overcrowding with regard to public safety) and proportionality.

200m exclusion - education/health reasons

3.11 With regard to the adoption of a 200 metre exclusion zone policy around schools, the Committee has previously considered individual applications in the vicinity of educational establishments, addressing these on a case by case basis. An exclusion zone policy would likely be considering to be a quantitative or territorial restriction in terms of Regulation 22(2)(a). The Committee would be entitled to consider the adoption of such a policy since the terms of Regulation 22(3) could be met, namely non-discrimination (applicable to all applicants), necessity (in relation to public health in particular) and proportionality (on the basis that the restriction would only be applicable around schools). Prior to formal adoption of such a policy there should be a process of consultation with those street traders likely to be affected and consideration of any responses received.

Grassmarket

- 3.12 During recent meetings of the Council's Licensing Sub-Committee, particular consideration has been given to the areas included in the Council's existing zoning policy for street trader licensing throughout the city, as detailed in appendix 3. Committee members have asked for further consideration of the Grassmarket area, on the basis that public realm works there have been completed. On 6 June 2008 a report was submitted to the Regulatory Committee regarding the Grassmarket area, referring to the public realm works there and advising of intended future use as a performance and events space. Following consideration of that report, the Committee agreed "(1) that only temporary street trader licences would be granted for the Grassmarket area and (2) that a further report on the future of street trading in the Grassmarket would be submitted when proposals for the future use of the locale had been finalised". This decision regarding temporary licences was only to have force for the remainder of 2008.
- 3.13 As highlighted above, any change to existing policy requires to be compatible with the provisions of the 2009 Regulations. The council already has well-established policies in place in relation to locations throughout the City of Edinburgh and it is suggested that these clear policies assist in ensuring non-discrimination and proportionality, as required by the 2009 Regulations. The Committee may wish to consider whether the Grassmarket area, as being an area with limited availability for trading activity would benefit from the adoption of a policy restricting the duration of grants of licence, i.e. temporary licences only, on a similar basis to that which is in place for the High Street and Hunter Square areas. It is not proposed however to restrict trading to non-food items only.
- 3.14 It is recognised that the Grassmarket area, whilst a central location with much commercial activity, is also a residential area. These may be factors to be considered by the Committee when deciding upon the necessity or otherwise of a policy controlling street trading activity in the area. Again however the

Committee is recommended to consult with those street traders likely to be affected, prior to the formal adoption of any policy in this regard.

Conditions of licence

- 3.15 During recent meetings of the Council's Licensing Sub-Committee regarding consideration of grant and renewal of street trader licences in the city centre area in general and particularly in the Mound Precinct and Playfair Steps areas, the Committee was asked to consider the imposition of an additional condition of licence, namely "that trading may be suspended on certain days specified by the Director of City Development on due notice being given to the licence holder". In agreeing to impose this condition, the Committee directed on 16 September 2011 that the Director "submit a report to the Regulatory Committee on the proposed implementation of the additional condition".
- 3.16 The Committee instructed an update on the operation of this condition of licence. However four licenceholders have lodged appeals at the sheriff court with regard to the addition of the condition to the grant or renewal of their licences. Further information on the progress of these appeals will be reported to the Committee when this becomes available.

4 Financial Implications

4.1 There are no financial implications arising from the proposals in this report.

5 Environmental Impact

5.1 Any adverse environmental impacts arising from the placing of street traders in the public domain, and the activities in which they engage, would be mitigated by means of licensing conditions.

6 Equalities Impact

6.1 On the basis that applications for street trader licences are each dealt with according to their respective merits, it is suggested that there is no adverse impact on the public sector equalities duty. There is therefore no direct equalities impact arising from this report.

7 Recommendations

- 7.1 The Committee is asked to note the terms of the report and, on the basis that a process of consultation and further reporting may be required, to give particular consideration to the following recommendations:
 - a) in light of the requirements of the Provision of Services Regulations 2009, not to introduce a policy which controls the siting of street trading units within 200 metres of designated local shopping areas;
 - b) to decide whether or not it would be appropriate to introduce a policy which controls the siting of street trading units within 200 metres of school boundaries;

c) to decide whether or not a specific policy relating to street trading activity is required in relation to the Grassmarket area and the terms of such a policy.

STANDARD CONDITIONS – ALL STREET TRADERS

- 1. The licenceholder shall not carry on business on any street so as to unreasonably obstruct road users or affect their safety.
- 2. The licenceholder shall carry on business subject to any direction which the police or authorised officers of the City of Edinburgh Council may reasonably be required to give.
- 3. The licenceholder shall sell or offer or expose for sale only good or articles described in the licence. In particular no goods or articles of an objectionable or indecent character shall be sold or offered for sale.
- 4. The licenceholder shall on all occasions, when carrying on business, behave in a proper and civil manner, and shall not carry on business in such a way as to cause a nuisance or annoyance to any person.
- 5. The licenceholder shall at all times conduct business and position any vehicle used in connection with the business in such a manner that no danger is likely to arise to any other person.
- 6. The licenceholder shall at all times when trading wear the identity card which is issued with the licence. The licence must be displayed on any vehicle or stance.
- 7. The licenceholder shall not lend or allow any other person to use any licence or identity card issued by the Council.
- 8. The licenceholder shall trade only between the hours of operation stated in the licence. At the end of trading hours the licenceholder shall remove and take away any stall, kiosk, mobile unit or vehicle and all other ancillary equipment placed on or in the vicinity of the trading stance.

STANDARD CONDITIONS - STANCES

- 9. The licenceholder shall trade only from the stance detailed in the licence.
- 10. The licenceholder shall obtain all necessary and appropriate consents prior to commencing trading from any stance and in particular the consent of the owners of any land on which a stance is to be situated or which is adjacent to any stance.
- 11. The licenceholder shall, during business hours and at the end of each day, ensure the collection and removal of any paper, food wrapping, food, litter or refuse, containers and drinks containers on any pavement around the stance within a distance of 25 metres either side. If adjacent stances, to which the street trading licence conditions apply, are within 25 metres, any distance to be cleaned shall be the mid-point between the two stances.

STANDARD CONDITIONS – VEHICLES AND MOBILE UNITS

- 12. The licenceholder shall trade from the vehicle or trailer detailed in the licence. If a vehicle or trailer is used by the licenceholder for trading in food the licenceholder must ensure that prior to the first and subsequent anniversaries of the commencement of the licence the vehicle is examined for and on behalf of the Council's Director of Environmental and Consumer Services. Any recommendations made by the Director as a result of the examination must be implemented within one month of the date of examination or such other date as had been mutually agreed. In addition the vehicle or trailer may require to be produced for inspection by the Council from time to time at such time and place as may reasonably be required by the Council. The vehicle or trailer shall be roadworthy and if it is to be used for trading during the hours of darkness it shall have sufficient light and reflectors as determined by the Council.
- 13. The licenceholder shall not use whistles or other sound producing devices apart from chimes and loudspeakers to attract business.
- 14. The licenceholder shall comply with all statutory provisions relating to noise and in particular with the provisions of section 62 of the Control of Pollution Act 1974 relating the to the use of loudspeakers in streets.

STANDARD CONDITIONS – STALLS

- 15. All temporary structures shall be designed, erected and maintained to suit their intended purpose. The design and erection shall be to the satisfaction of the Council's Director of City Development.
- 16.All stalls shall be demountable and shall be removed from the stance at the end of trading hours on each working day.
- 17. Traded goods must be kept on and traded from the stall. At no time shall such goods be permitted to lie on the surrounding area or be left against adjacent walls or railings.

STREET TRADING IN THE CITY

On 9th December 2004 the City Of Edinburgh Council adopted a new policy on Street Trading in the city, which came into effect on 1st January 2005.

The policy has determined:

- A. There will be a presumption <u>AGAINST</u> street trading in
 - 1. The New Town, and especially George Street, St Andrew Square and Charlotte Square.
 - 2. Areas around historic buildings, such as General Register House, the Royal Scottish Academy, the National Gallery, Parliament Square and St Giles Cathedral.
 - 3. Princes Street, the Lawnmarket, the World Heritage Site and Conservation areas and the Mound Precinct.
 - 4. South Gyle, Edinburgh Park and also high amenity business areas
 - 5. Important gateways to the City.
 - 6. Streets which are mainly residential
- B. There will be a presumption in <u>favour</u> of street trading in
 - 1. Areas of retail and entertainment activity
 - 2. Low amenity areas, such as industrial estates or within the curtilage of business premises.
- C. There will be a presumption in favour of <u>temporary</u> licences <u>only</u> certain areas, including
 - 1. The High Street
 - 2. Hunter Square

In which two areas only goods, and not food, may not be sold.

D. Hours of Operation

Traders selling food will be granted hours of operation no later than 11pm except street traders selling ice cream, confectionery, table waters and tobacco when the hours granted will be to 9.30pm and 10pm on Saturdays.

Applicants for licence are recommended to ensure that they are fully aware of the conditions which will require to be met prior to the Council's grant of such a licence. Full details are available on the Council's Licensing Website.

SPECIFIED ZONES FOR STREET TRADERS

The specified zones in the City of Edinburgh District in which street traders are permitted to trade shall be the streets within the including and following boundaries (with the exception of Princes Street, George Street, Rose Street, the Mound Precinct and the Royal Mile.

- 1. Queensferry Road, Hillhouse Road, Telford Road, Groathill Road North, Ferry Road, Pennywell Road, Marine Drive.
- 2. Marine Drive, Pennywell Road, Ferry Road, Groathill Road North, Telford Road, Queensferry Road, Dean Park Crescent, Comely Bank Avenue, East Fettes Avenue, Ferry Road, Granton Road, Wardie Steps to Lower Granton Road.
- 3. Granton Road from Wardie Steps to Ferry Road, East Fettes Avenue, Comely Bank Avenue, Dean Park Crescent, Queensferry Road, Queensferry Street to Princes Street, Waterloo Place, Regent Road, Easter Road, Leith Links to Seafield Road.
- 4. Seafield Road, Leith Links, Easter Road, Regent Road, Waterloo Place, North Bridge, South Bridge southward to Lady Road, Peffermill Road, Duddingston Road West, Duddingston Road, Southfield Place, Brighton Place, Bath Street to Promenade.
- 5. Bath Street, Brighton Place, Southfield Place, Duddingston Road, Duddingston Road West, Niddrie Mains Road, Newcraighall Road.
- 6. Newcraighall Road, Niddrie Mains Road, Peffermill Road, Lady Road, Gilmerton Road.
- 7. Gilmerton Road from City Boundary, Craigmillar Park northwards to North Bridge, Princes Street, Lothian Road, Earl Grey Street, Home Street, Leven Street, Bruntsfield Place, Morningside Road, Comiston Road, Biggar Road.
- 8. Biggar Road, Comiston Road, Morningside Road, Bruntsfield Place, Leven Street, Home Street, Earl Grey Street, Lothian Road, Shandwick Place, West Maitland Street, Dalry Road, Ardmillan Terrace, Slateford Road, Lanark Road.
- 9. Lanark Road, Slateford Road, Ardmillan Terrace, Gorgie Road, Calder Road.
- 10. Calder Road, Gorgie Road, Dalry Road, Haymarket Terrace, West Coates, Roseburn Terrace, Corstorphine Road, St John's Road, Glasgow Road.
- 11. Glasgow Road, St John's Road, Corstorphine Road, Roseburn Terrace, West Coates, Haymarket Terrace, West Maitland Stret, Shandwick Place, Queensferry Street, Queensferry Road.
- 12. In the north by the shire at South Queensferry, in the east by the Edinburgh City Boundary, in the south by the River Almond and in the west by the District Council Boundary.
- 13. In the north by the River Almond, in the east by the Edinburgh City Boundary, in the south by the Calder Road (A71) and in the west by the District Council Boundary.
- 14. In the north by the Calder Road (A71) in the eat by the Edinburgh City Boundary and in the south east, south and west by the District Council Boundary.

SUMMARY OF THE CODE OF PRACTICE ON NOISE FROM ICE CREAM VAN CHIMES ETC 1982

It is an offence to sound your chimes before 12.00 noon or after 7.00pm. It is also an offence to sound your chimes in such a way as to give reasonable cause for annoyance. A code of practie approved by the Government gives guidance on methods of minimising annoyance caused by your chimes. The main points of the code of practice are:-

Do not sound chimes

- 1. for longer than 4 seconds at a time;
- 2. more often than once every 3 minutes;
- 3. when the vehicle is stationary;
- 4. except on approach to a selling point;
- 5. when in sight of another vehicle which is trading;
- 6. when within 50 metres of schools (during school hours), hospitals, and places of worship (on Sundays and other recognised day of worship;
- 7. more often then once every 2 hours in the same length of street;
- 8. louder than 80 dB(A) at 7.5 metres;*
- 9. as loudly in quiet areas or narrow streets as elsewhere.

REMEMBER : It is an offence to sound your chimes before 12.00 noon or after 7.00pm. It is an offence to sound your chimes at any time in a way which gives reasonable cause for annoyance.

* Noise measurements should be undertaken with a meter which conforms to BS 5969:1981 (Type 1) (Specification for sound-level meters) set to the A-frequency weighting and the S-time weighting. The microphone should be held at a height of 1.2 metres above the ground, and at a distance of 7.5 metres from the loudspeaker. The microphone should, where necessary, be fitted with a windshield and the meter should be calibrated prior to use.

Request for Approval of Smart Car as Private Hire Car– Edinburgh City Private Hire Ltd

Regulatory Committee

16 December 2011

1 Purpose of report

1.1 For a decision whether to approve the two-seater Smart Car for licensing as a private hire car.

2 Summary

- 2.1 Edinburgh City Private Hire Ltd has asked for approval of the two-seater Smart Car for use as a private hire car.
- 2.2 It is recommended that approval be given.

3 Main report

- 3.1 S 10(1) of the Civic Government (Scotland) Act 1982 states that a licensing authority should not grant a private hire car licence unless they are satisfied that the vehicle is suitable in type, size and design for use as a private hire car and is safe for such use.
- 3.2 A request has been made by Edinburgh City Private Hire Limited for approval of the two-seater Smart Car for Two for use as a private hire car. A copy of their letter is attached at <u>Appendix 1.</u>
- 3.3 The Smart Car is a mass produced vehicle, subject to usual safety and design testing. It is available in a range of engine sizes from a 799 cc diesel (producing 54 bhp) up to a 999 cc petrol (producing 84 bph). The engine capacity is less than the 1500 cc stipulated in existing Conditions of Fitness. However, with a gross weight of only 1050 kg, this produces a power to weight ratio for the lowest powered model which is just below that of a TX4. Its performance is regarded as satisfactory for private hire car use.
- 3.4 The vehicle has limited luggage space. As its operation would be limited to prebooked hires, it would be for the booking office to ensure that passengers were made aware when they booked of the limited luggage space and provide them with an alternative vehicle if more luggage capacity was required.
- 3.5 Oxford City Council has licensed a Smart Car for use as a private hire vehicle.

- 3.6 The Cab Inspector has no objection to approval being given.
- 3.7 It is recommended that this vehicle be approved as suitable for licensing as a private hire car and that the Conditions of Fitness, requiring a minimum engine capacity of 1500 cc, four doors and having at least 4 seats for passengers, should be disregarded in relation to this vehicle. It is suggested any vehicle would be licensed to carry only one passenger.

4 Financial Implications

4.1 The introduction of such vehicles might result in an increase in the total number of vehicles requiring inspection. However, any additional costs would be recovered through licence application fees.

5 Equalities Impact

5.1 None.

6 Environmental Impact

6.1 The use of smaller vehicles with low emission levels and lower fuel consumption when only one passenger requires to be carried should be encouraged.

7 Recommendations

7.1 That approval is granted.

Ref. Proposed addition to the Approved Vehicles list

Whilst researching practical ways in which Edinburgh City Private Hire Ltd could reduce its carbon footprint, it came to our attention that many journeys booked with us carry only one passenger. However, our fleet vehicles are licensed to carry a varying number of passengers, ranging from four to eight.

With an aim of reducing the environmental impact of one passenger journeys we researched the marketplace for currently available small, low environmental impact vehicles. The car that

stands out in terms of low CO2 emissions (less than 90g /km), excellent safety rating (4* NCAP rating for passenger safety), type M1 approval, and a small size eminently suitable for city traffic, is the Smart ForTwo.

We believe that we could successfully promote the use of this vehicle, particularly in the ever more environmentally conscious corporate market, and a survey of some our larger contract customers supports this view. Transporting one passenger is an especially common occurrence arriving at or departing from Edinburgh's main transport hubs, and these hubs would be the focus of our marketing strategy for this particular vehicle type.

The licensing of this vehicle would obviously require a variation or change in the local licence conditions which govern the types of vehicle which are approved for Private Hire use.

We formally request that the City of Edinburgh Council considers the addition of the Smart ForTwo car to it's list of approved vehicles for Private Hire use, on the basis of being licensed to carry 1 passenger only. The required changes in licence condition will necessitate our request being put forward to the appropriate committee for consideration, and we ask that this be done as soon as possible. Representatives from Edinburgh City Private Hire Ltd are of course available for discussions should the committee require it.

The management team here are enthusiastic about this concept, and see it as a sensible step forward in our drive towards more environmentally friendly transport solutions. We sincerely hope that the City of Edinburgh Council share this view.

Request for Permission for Advertisement on Private Hire Cars – Edinburgh City Private Hire Ltd

Regulatory Committee

1 Purpose of report

1.1 For a decision whether to permit the name, logo and telephone number of a Booking Office on the rear passenger doors of private hire cars.

2 Summary

- 2.1 Edinburgh City Private Hire Ltd have asked for permission to place an additional sign on the rear doors of their private hire cars containing the company's name, logo and phone number.
- 2.2 Company names and phone numbers are permitted on private hire cars by the majority of Scottish councils. Scottish Government Best Practice Guidance endorses their use. Lothian and Borders Police consider they would help with enforcement.

3 Main report

- 3.1 Condition 68 in Private Hire Car licences states "The holder of a private hire car licence shall not display in or on their private hire car any signs for any purpose of advertising other than those approved by the Council."
- 3.2 A request has been made by Edinburgh City Private Hire Limited for the display of advertising on private hire cars on their rear passenger doors. A copy of their letter and of the proposed advert is attached at <u>Appendix 1</u>. The advert reads "To book this car call Edinburgh City Private Hire Ltd 0131 477 4000." The sign is shown in <u>Appendix 2</u> and is similar in shape and size to existing front door signs which read "Pre-booked hires only."
- 3.3 Lothian Borders Police Cab Inspector has indicated that he has no objection to approval being given. The presence of the signs could assist enforcement in tracing private hire vehicles and drivers to particular booking offices.
- 3.4 The Scottish Government's Best Practice Guidance on Taxi and Private Hire Car Licensing in 2007 states –

- 30it is reasonable, and in the interests of the travelling public, for a PHC operator to be able to state on the vehicle the contact details for hiring. In this regard authorities might consider introduction of a licence condition which requires a sign on the vehicle in a specified form. This will often be a sign of a specified size and shape which identifies the operator (with a telephone number for bookings) and the local licensing authority, and which also has some words such as 'pre-booked only'. This approach seems the best practice; it identifies the vehicle as private hire and helps to avoid confusion with a taxi, but also gives useful information to the public wishing to make a booking.
- 3.5 In relation to a similar request last year, all other Scottish Licensing Authorities were contacted to enquire as to their policies in this regard. 26 out of 31 responded. Of these, 18 (69% of responding councils) permitted the name and telephone number of a booking office to appear on private hire cars.
- 3.6 The current position in other Scottish cities is -

<u>Glasgow</u> – The council has, since 1996, required the name of the booking office and its telephone number to be on the rear window of phc's.

<u>Dundee</u> – Booking offices are permitted to display their name, logo and telephone numbers on phc's.

<u>Aberdeen</u> – Approval can be sought to display any advertisements on phc's but none carry advertisements.

Ref. Application for enhanced signage for Edinburgh City Private Hire vehicles

We have previously made applications for enhanced signage for our vehicles, on the basis that it would help create a safer and more certain experience for our passengers. The issues already raised about the matter of unlicensed or unauthorised vehicles picking up unwitting members of the public, remain valid, and we wish to make a renewed application.

In a bid to greatly improve identification of properly Licensed vehicles, and thus reduce the likelihood of members of the public being induced into getting aboard the wrong car, or worse, an unlicensed car, we wish to formally apply for permission to use an additional and more informative rear door sticker on our vehicles.

This would improve the effectiveness, in terms of vehicle identification, of the currently authorised 'PreBooked Hires Only' sticker, thus aiding both passenger safety and enforcement. The proposed position of the new sticker is on the rear door, and would replicate the 'PreBooked Hires Only' sign's shape and size format. The additional information contained would be the company name and phone number. We will provide samples for your examination.

The Taxi trade and others may object by saying that enhanced identification of Private Hire vehicles may mislead the public into approaching or flagging down Private Hire cars for ad hoc hires, which is of course the preserve of the Taxi trade. However, it is worth pointing out that enhanced vehicle identification will make any offending drivers, and the companies they work for, very much easier to identify than is presently the case. This would assist enforcement officials, police, members of the public, and indeed Taxi drivers, in attacking an important if unrelated secondary issue.

We believe this request is reasonable, and we respectfully ask that this proposal be given serious consideration. Beyond Edinburgh there is wide support for this viewpoint, including the Scottish Governments Taxis and Private Hire Best Practice Guidance for Councils, a document which we assume is endorsed by the City of Edinburgh Council. Please see overleaf for the relevant vehicle signage extract from this document.

38. In addition to the specified local authority licence plate or disc identifying the vehicle as a private hire car some clearer identification is best practice. This is for two reasons: firstly, to ensure a more positive statement that the vehicle cannot be hired immediately through the driver; and secondly because it is reasonable, and in the interests of the travelling public, for a phc operator to be able to state on the vehicle the contact details for hiring. In this regard authorities might consider introduction of a licence condition which requires a sign on the vehicle in a specified form. This will often be a sign of a specified size and shape which identifies the operator (with a telephone number for bookings) and the local licensing authority, and which also has some words such as "prebooked only". This approach seems the best practice; it identifies the vehicle as private hire and helps to avoid confusion with a taxi, but also gives useful information to the public wishing to make a booking.

Late Hours Catering – Request from City of Edinburgh Licensing Board

Regulatory Committee

16 December 2011

1 Purpose of report

1.1 To request the Committee's views on the terminal hour of premises affecting two applications for variation of alcohol premises before the City of Edinburgh Licensing Board ('the Board') for decision.

2 Summary

- 2.1 On 28 November 2011, the Board deferred a decision in relation to two applications for variation of premises licence which sought terminal hours for a late hours catering business at variance with the City's policy on late hours catering as laid down by the Regulatory Committee.
- 2.2 The Board decided to seek the Committee's views on the hours sought in the applications prior to making a final determination.

3 Main report

- 3.1 The Board's Statement of Licensing Policy adopted 22 November 2010 supports the Council's policy on late hours catering hours of operation. The relevant section from the Statement comprises Appendix 1 to this report.
- 3.2 On 28 November 2011 the Board deferred a decision in relation to two applications for variation of premises licence which sought terminal hours for a late hours catering business at variance with the City's policy on late hours catering as last amended 25 October 2002. The Board decided to seek the views of the Committee on the hours sought.
- 3.3 The first application relates to premises at 23 Edinburgh Road, South Queensferry. The premises enjoy core hours permitting the sale of alcohol to 0100 hours the following day Mondays to Saturdays and 2300 hours on Sundays. The Chief Constable has provided the Board with a report indicating that the applicant intends to offer takeaways as an activity and that the premises fall within Zone 3 of the late hours catering policy i.e. a street with low night ambient noise attracting hours of 11pm to 12pm Sundays to Thursdays.

- 3.4 The second application relates to premises at 107-109 Fountainbridge, Edinburgh. The premises operate as a restaurant with a significant takeaway food provision. The premises enjoy core hours permitting the sale of alcohol to 0200 hours the following day Sundays to Thursdays and 0300 hours the following day Fridays and Saturdays. The Chief Constable has provided the Board with a report indicating that the applicant seeks to increase on-sale hours by extending the terminal hour to 3am Sundays to Thursdays and 4am Fridays and Saturdays. Fountainbridge falls within 'Zone 1' of the late hours catering policy i.e. a busy main road or junction used by large volume of late night pedestrians – high ambient noise levels until closure times. This attracts hours of 11pm to 2am Sundays to Thursdays and 3am Fridays and Saturdays.
- 3.5 The Board would welcome an indication from the Committee whether or not a departure from policy is indicated in the case of either or both applications.

6.1 The policy is intended to preserve amenity in the city and minimise the impact on the local environment from premises trading during night-time hours.

APPENDIX TO FOREGOING REPORT

Extract from City of Edinburgh Licensing Board Statement of Licensing Policy 2010

22 TAKE-AWAYS

- 22.1 Premises which supply hot food and hot drink for consumption off the premises (take-aways) and which are open after 11pm can attract large groups of customers and act as a focus of noise and disturbance. Until the Act came into force, the Board was of the view, notwithstanding the exception in section 42(4)(a) of the Civic Government (Scotland) Act 1982, that premises selling alcohol required an additional late hours catering licence to permit the facility of take-away food and refreshment between the hours of 11pm and 5am. Most premises licensed by the Board which operated a take-away business between the hours of 11pm and 5am held a late hours catering licence from the Council.
- 22.2 The Civic Government (Scotland) Act 1982 as amended provides at section 42(4) that a late hours catering licence shall not be required in respect of (a) the use as such of licensed premises within the meaning of the Act. The new operating plans allow the Board more control of the operation of licensed premises and it is no longer necessary or appropriate to require premises to have two licences.
- 22.3 On 10th September 2002 the Council adopted a new policy on permitted hours of operation. This followed a review of zoning guidelines which were originally introduced in 1985 to preserve amenity in the city and minimise the impact on the local environment from premises trading during night-time hours. The provisions of this policy affecting take-aways are set out in Appendix 5 to this statement. The Board acknowledges the significance of this policy and will expect applicants to accept that similar hours of operation should apply to take-away operations falling within its area of licensing responsibility. This will both ensure a level playing field within the city and promote the licensing objectives.

LATE HOURS CATERING - COUNCIL POLICY ON HOURS OF OPERATION

Takeaway premises

All premises are categorised by location and in order to prevent crowd migration from clubs to takeaway premises, no Late Hours Catering licences will be granted with a terminal hour beyond 3am.

CATEGORY	TIME OF CLOSURE	LOCATION
1	11pm to 2am (Sundays to Thursdays) 11pm to 3am (Fridays and Saturdays)	Busy main road or junction used by large volume of late night pedestrians. High ambient noise levels until closure times.
2	11pm to 1am (Sundays to Thursdays) 11pm to 2am (Fridays and Saturdays)	Main road or very busy street. Ambient noise levels coincide with closing hours.
3	11pm to 12pm (Sundays to Thursdays) 11pm to 1am (Fridays and Saturdays)	Street with low night ambient noise.
4	11pm to 12 midnight (Fridays and Saturdays only)	Street or area with very low night ambient noise or premises with a history of complaints.

Festival and Festive periods – there will normally be a recommendation to grant an additional one hour to the usual terminal hour.
