Education, Children & Families Committee 7 November 2023 Item 7.10 – Early Years Capital Programme Update

- 1.2 In particular Committee notes:
- 1.2.1 The funds available for the Capital programme are now approximately £800K short of the projected cost of delivering the programme.
- 1.2.2 The current inflationary economic environment is likely to see costs increase further.
- 1.3 Committee acknowledges:
- 1.3.1 Contingency allocations are generally not designed to cover significant inflationary pressures.
- 1.3.2 When the Contingency of £3.1mil was allocated it represented 7.85% of total cost but now represents only 4.69% of revised total cost.

Committee therefore instructs Officers to review the Capital Programme and present a Report to Committee in one cycle with recommendations for a revised programme including an updated Contingency reflecting the revised Programme Costs.
