

- 1. Committee recognises that people's interests in the Council budgets go beyond their immediate neighbourhoods, and that public engagement should give people opportunities to express their priorities and aspirations for the whole city;
- 2. Therefore, Committee approves the launch of phase one of the budget engagement programme with the following changes:
  - 2.1 The first question should be clarified to remove ambiguity about what is being asked
- 2.2 An additional question is added to obtain views from respondents about the wider city, not just their local neighbourhood
- 2.3 Space should be made in the survey for respondents to tell us their priorities and values, and what they want to see for the future
- 3. Additionally, Committee requests that phase 2 proposals include consideration of engagement with third sector organisations and schools to hold focus groups with particular under-represented groups, including children and young people.
- 4. Finally, Committee requests that the phase 2 proposals include a process for integrating IIAs into the budget engagement programme in order to both inform the public about the impacts of any proposals, and ensure that public views and equalities considerations are both given due consideration during the budget setting process.

Deletes 1.3.3 and replaces with:

- 1.4 Welcomes the fact that the EADP have directed officers to join the national group exploring the development of Drug Checking Services and will be working towards a costed proposal to be returned to the EADP by September 2024.
- 1.4.1 Agrees that whilst national UK Government may ideologically struggle to grant a license that allows a drug checking service aimed at recreational drug users, Edinburgh is in a strong position to deliver such a service in partnership with Crew:2000 which could have an extraordinarily positive effect on reducing drug harm among the younger population and provide crucial public health data about the drug supply.
- 1.4.2 Therefore, agrees that this is proactively considered in options development work alongside the more clinical drug checking service that is currently likely to be granted approval.
- 1.4.3 Requests that the EADP will once again provide their commentary in a report to Policy and Sustainability regarding drug checking costed proposal once they are prepared to do so.
- 1.5 Agrees that introducing an SDCF should come at no detriment to existing services that reduce drug and alcohol-related harms but acknowledges that the evidence is clear SDCF provision will save lives, produce wider community benefits and potentially help people access other services.
- 1.5.1 Notes that one quarter of drug related deaths happen within the homeless population and agrees that development of SDCF proposals should include conversations with homelessness and temporary accommodation service providers.
- 1.5.2 Further notes the existing network of needle exchanges across the city that should be considered in the development of SDCF proposals.



- 1.5.3 Understands that the EADP and EIJB require confidence that additional financial support will be forthcoming on conclusion of the service development and approval from the Lord Advocate.
- 1.5.4 Agrees that in the first instance discussions should begin with national government to ascertain the potential additional financial support for provision.
- 1.5.5 Further agrees that should additional funding be needed beyond Government allocations, the council, EIJB and NHS should also explore options for funding on the basis of a third each with final proposals being brought to full council for approval in light of the global evidence on cost-effectiveness suggesting that SDCF provision can lead to overall savings for all three bodies.

- 1.1.2.1 Notes that the Chinese government has imprisoned around 1 million Uyghur people and it is estimated 100,000 Uyghurs and other ethnic minority people may be working in conditions of forced labour.
- 1.1.2.2 Notes that in 2021 the USA's Bureau of International Labor Affairs added polysilicon to the list of goods produced by forced labour of Muslim minorities in China.
- 1.1.2.3 Notes that, as Shenzhen has been called 'China's Silicon Valley' and a large proportion of its economy is in the technology sector, there is a substantial chance that companies based in Shenzhen are using polysilicon produced by Uyghur forced labour.
- 1.1.2.4 Committee therefore requests that the Lord Provost will seek assurances that none of the businesses mentioned in items 4.5.1 and 4.5.2 of the report use forced labour or products made with forced labour.
- 1.1.2.5 Committee further agrees that if such assurances cannot be given then Edinburgh city's memorandum of understanding with Shenzhen will be put on hold until they can be given and the proposed visit in May will be cancelled.


