# Education, Children and Families Committee 16 April 2024 Item 7.1 Quality Improvement and Scrutiny Update

- 1.1.3 Committee is concerned that recently two schools, one primary and one secondary, have received weak evaluations from Education Scotland Inspectors. In the case of East Craigs Primary School the evaluation was weak in all four quality indicators. For Forrester High, the evaluation was weak for attainment only.
- 1.1.4 Committee notes that these evaluations are amongst the lowest, not just in Edinburgh, but in Scotland as a whole and that there are very few schools in the country in this category.
- 1.1.5 Committee therefore requests a report in one cycle on the progress which has been made with identified Priority Schools to include -
  - How are the Priority Schools identified?
  - What are the current Priority Schools?
  - What interventions have been implemented to improve outcomes?
  - How have these interventions been assessed?

How successful have these interventions been?

#### 7.3 – Early Years Cross Boundary Places

In point 1.1 replaces the word "decision" with "recommendation".

Replaces point 1.2 with:

"Committee agrees this is clearly a policy decision, not an operational decision, and therefore any proposed changes are for Councillors to decide through committee decision."

#### Adds 1.1.4

Notes assurances to families that existing funded children who are not Edinburgh residents will continue to be funded but that funded sibling placements for cross boundary places will cause concern for parents and families as they only cover one year.

#### Adds point 2:

- 2.1 Agrees that further information is needed to understand the full impact of this change.
- 2.2 Agrees that the current plan to phase out funding for cross boundary places in private settings from August 2024 is very short notice for families to consider alternative plans.
- 2.4 Agrees not to proceed with these changes at this time to allow for discussion with COSLA, Scottish Government, and other local authorities to reconsider best recharge mechanisms for funded nursery placements. Agree officers will aim to secure agreement of funding following the child to allow for easier allocation of funded cross-boundary placements at no financial detriment to local authorities.
- 2.5 Agrees for officers to bring an update report in one cycle on the above points with a completed equalities impact assessment back to ECF committee for final decision. Agrees officers will immediately communicate that any changes will not proceed until Committee has formally agreed.

- 1.1.5 Recognises that Scot Gov's desire for a no charging policy set out in point 4.14 is a recommendation and not enforced policy.
- 1.1.6 Notes that the only cross boundary approach CEC has explored is the same as the West Partnership Agreement.
- 1.1.7 Agrees with the commitment to the principle of Best Value as set out in point 4.1 and recognises that this can only be delivered if the costs of EY provision in Local Authority settings can be fully understood and compared with other settings.
- 1.1.8 Committee therefore instructs Officers to report back with:
- i) An analysis of the Council's internal funding structure so a direct comparison can be made between the cost of a) funding in-house provision and b) funding of PVI settings, to ensure Best Value to Edinburgh's residents can be delivered.
- ii) Additional options for cross-boundary approaches other than the one explored along with a summary of discussions had with the 9 Local Authorities

# Item 7.4 – Early Years Partner Provider – Hourly Rate for Funded Early Learning and Childcare

#### Committee notes:

- 1. The COSLA recommendation of a fixed percentage uplift of 7.6% on hourly rates for childcare providers.
- 2. The funding provided by the Scottish Government would provide for a 4.8% uplift and therefore does not fully fund the recommended 7.6% leaving a shortfall of £700,000.
- 3. That options on how to meet the £700k shortfall should be reviewed and decided at Committee.

#### Committee therefore agrees:

- 4. To approve at a minimum the 4.8% uplift and a preference to approve the 7.6% recommendation but that the latter is dependent on identifying the funding options and any impact on other Education, Children & Families services.
- 5. To delegate to the Director to identify options for meeting the £700K shortfall and bring these back to the June meeting of the Education Committee for determination.
- 6. To refer the June committee decision to Finance & Resources for their information due to the substantial amount involved and potential impact on any budget decisions made in February.

- 1) There has been no communication between the Scottish Schools Pipes and Drums Trust (SSPDT) and Council officers since early 2023.
- 2) No formal offer of £120,000 was made by SSPDT and initial conversations discussed a potential offer of £44,550 per year for two years. However, there was no formal written offer put to City of Edinburgh Council at that time.
- 3) Music tuition is of great benefit to our young people, and it is important that pupils have fair and equal access to tuition.
