## **Transport and Environment Committee**

### 1. Citywide Ban on 'A' Boards and Other Temporary On-street Advertising Structures – 12 Month Review

### (a) Deputation by Living Streets

The Committee agreed to hear deputations from Living Streets, the Edinburgh Access Panel and the Royal National Institute of Blind People (RNIB) in relation to the Citywide Ban on 'A' Boards and Other Temporary On-street Advertising Structures – 12 Month Review.

The deputations highlighted the following issues:

- That the deputations commended the Council for the implementation of the ban on 'A' boards and temporary on-street advertising structures that caused obstruction to access for those with disabilities.
- That 'A' boards and advertising structures on the streets caused injuries for those with sight or mobility impairments and made them fearful to walk the streets.
- That the ban had significantly improved the walking environment of Edinburgh's streets and granted freedom to those with disabilities.
- That there were still issues impeding access on the streets including bins, road works, signage poles and overhanging hedges.

The deputations requested that the Committee considered:

• That the ban became permanent and generated cross-party support.

### (b) Report by the Executive Director of Place – Citywide Ban on 'A' Boards and Other Temporary On-street Advertising Structures – 12 Month Review

Following approval of the citywide ban on 'A Boards' and other temporary onstreet advertising structures at the Transport and Environment Committee of May 2018, the findings from the 12 month post-implementation review were set out.

### 2. Kirkliston and Queensferry Traffic and Active Travel Study

As requested by Councillors Young and Lang at the Council meeting of 29 June 2017, a detailed Automatic Number Plate Recognition (ANPR) traffic study was undertaken in June 2018 in the Kirkliston and Queensferry area following the opening of the Queensferry crossing. The study results identified current route choices in the area and recommended transport and active travel interventions that could increase mobility and reduce the impact of traffic on key routes and junctions.

Councillor Young attended committee to answer questions as a ward councillor for the Almond ward.

### 9. Gilmore Place Driveway Parking Overhanging Footway – Response to Motion

Gilmore Place was a residential street in the city centre ward. Over several years, property owners had created parking spaces replacing front gardens along Gilmore Place that were accessed by driving across the footway. Some vehicles subsequently overhung the public footway, which caused an obstruction of the footway adjacent to a busy road due to insufficient depth of garden space.

In response to a motion by Councillor Mowat to the South East Locality Committee on 21 January 2019, the enforcement regimes (planning, parking and regulatory) available to the Council to enable free access along the footway for pedestrians were set out.
