1. City Mobility Plan – Draft for Consultation

As part of the approved programme to transform Edinburgh's city centre, the City of Edinburgh Council (CEC) would soon be asked to consult on the main issues in the Choices for City Plan 2030 for the next Local Development Plan (City Plan 2030). This would consider how the city can develop in the future whilst becoming a carbon neutral city.

To support this, a new plan for mobility and transport was prepared in order to address the challenge of dealing with carbon emissions and how to move people, goods and services into and around the city – the City Mobility Plan (CMP). The plan also addressed air quality, congestion, accessibility and inclusion, cost of travel and convenience of payment, safety and how to use the space in the city for people.

Motion

- 1) To note that engagement with stakeholders and the public during 2018 and 2019 on the City Mobility Plan (CMP), combined with Edinburgh City Centre Transformation (ECCT) and Low Emissions Zones (LEZ), had informed the basis of the 'City Mobility Plan – Draft for Consultation'.
 - 2) To agree that stakeholder and public consultation would be undertaken in respect of the CMP in parallel with the City Plan 2030 (pending its approval by Planning Committee on 22 January 2020) for an 8-week period from 31 January 2020 to 27 March 2020.
 - 3) To agree to delegate to the Senior Manager - Transport the authority to make final design, layout and minor editorial changes to the consultation document.
 - 4) To agree that following consultation a finalised Plan would be brought back to Committee in the third quarter of 2020.

- 1) To agree the need for a credible long-term vision governing the movement of people and goods around Edinburgh.
 - 2) To note the public consultation undertaken to date.
 - 3) To agree with the draft plan that it was essential that such a vision “requires public consent and support.”
 - 4) To not consider it a sensible use of taxpayer funds, citizens’ time or council resources to consult on the draft plan in its current form, given it lacked the most basic indicative costings. To consider this information essential to allowing stakeholders to contribute any meaningful view and to understand the likelihood of project delivery.
 - 5) To express concern at the presumptive tone of the document, the language in several places pre-judging committee decision making which had yet to be taken on several issues, including on a Low Emissions Zone and Workplace Parking Levy.
 - 6) To express concern that the City Mobility Plan appeared in places to duplicate elements of the ECCT and to question the strategic coherence of the latter having been decided by Committee prior to the former.
 - 7) To agree for a revised draft plan be returned to Committee in one cycle that would include indicative costings prior to agreeing to public consultation.

2. Smarter Choices, Smarter Places 2020-21

The Council had been running annual programmes of behaviour change initiatives, to encourage the uptake of active and sustainable travel and reduce single car occupancy trips, each year since 2015. These were externally funded by the Smarter Choices, Smarter Places (SCSP) grant, which was Paths for All's active and sustainable travel behaviour change programme.

On 6 December 2018, authority had been delegated to the Service Manager – Transport Networks, in consultation with the Convener and Vice Convener, to further develop and deliver the proposed outline programme for 2019-20 and to develop and deliver programmes annually for future financial years, on an ongoing basis. A discussion between these key personnel took place on 3 December 2019 to agree the content of the programme for 2020-21.

 - 3) To discharge the action to report to the Transport and Environment Committee within three cycles on encouraging car sharing schemes during the primary festival season, that arose from Councillor Rae's Motion "Greening the Fringe" to full Council on 19 September 2019.
