Revenue Budget 2020/21 Update - referral from the Policy and Sustainability Committee

The Policy and Sustainability Committee had referred a report which provided an update on the current assessment of approved savings delivery, management of service pressures and, most materially, the emerging cost and income implications of the coronavirus pandemic on the Council and its ALEOs' activities, to the Council for approval.

Details were provided on an overall reduction in the in-year funding gap from £56.5m to £29.9m, mainly through management of savings delivery shortfalls and residual pressures, use of reserves and corporate budgets. Given the potential for this gap to increase further based on the pace of the city's recovery, however, action was urgently required, with the enduring impacts also likely to require a re-assessment of both the content and affordability of the 2020/23 revenue budget framework and tenyear capital budget strategy.

10 Dolphin Gardens West Park Rangers – Motion by Councillor Webber

The following motion by Councillor Webber was submitted in terms of Standing Order 14:

"Council:

- 1) Would like to thank the tremendous work and initiative of this group of residents from Currie and invites the Lord Provost to write to the group recognising this.
- 2) Throughout the COVID 19 lock down period, they took it upon themselves to maintain key areas using their own grass cutting machinery and even ensured the arisings were all carefully removed and disposed of appropriately.
- 3) Their focus was the long-neglected park at Dolphin Gardens West where they have also painted and had a blacksmith repair the swings. They have cleared detritus from the safety matting and have resewn areas of grass that had long suffered damage from vehicles cutting corners and mounting the kerbs.
- 4) They also came together to ensure Currie Kirk Cemetery and the surrounding grounds were maintained through the period of lock down. This has been of immense importance to those visiting loved ones buried there and has been a huge symbol of respect that has moved the entire community to recognise and thank them for their work and dedication.
- 5) The group is now looking to develop a formal arrangement for the ongoing maintenance and investment in Dolphin Gardens West. They have requested support from Parks and Greenspaces and the Waste and Cleansing Services to permit this, primarily via their local councillor. As such requests that we look to facilitate and encourage their endeavours and support the DGW Park Rangers wherever possible."

12 50th Anniversary of Garvald Edinburgh – Motion by Councillor Wilson

The following motion by Councillor Wilson was submitted in terms of Standing Order 14:

"Council notes that:

- a) In order to improve creative opportunities and support for people with learning disabilities in Edinburgh since 1969, they have provided creative working environments focusing mainly around craft, catering and artistic skills for over 200 people.
- b) Their approach brings together all the factors that are important for any person in their daily life. A work like environment provides meaning, structure and stability. The physical environment is even more important for people with learning disabilities. Their day facilities are calm and creative spaces and they encourage respect for the natural world around them. This nourishes the senses and develops a feeling of community and respect that would be otherwise very difficult for their members to experience.

- c) They now support people across four locations. They are also one of the founding organisations of get2gether Edinburgh, which arranges social activities for people with disabilities in safe and friendly places throughout.
- d) The Art and Design Studio at Garvald Edinburgh enables artists with learning disabilities to develop and exhibit their work. The artists have access to high quality materials and support, giving them space to explore and express their creative voice. Each artist is facilitated to produce a body of work to exhibition standard and their work is shown in a variety of locations in Edinburgh and beyond. Social Therapy.

In acknowledging the positive work of Garvald Edinburgh, Council requests that the Lord Provost, marks the 50th Anniversary in an appropriate way."

13 Signage for Scotland's Largest Historical Mural – Motion by Councillor Arthur

The following motion by Councillor Arthur was submitted in terms of Standing Order 14:

"Congratulates the Colinton Tunnel Mural Team (SC048476) on the progress they have made to date in creating Scotland's largest historical mural and the interest the project has attracted from around the world.

Recognises the strength of support for the project in the local community, not least from the many local children who have supported artist Chris Rutterford.

Notes that although the Colinton Tunnel Mural is not yet complete it has attracted up to 1,000 visitors each day throughout lockdown. Although many people approach Colinton Tunnel along the Water of Leith Walkway (National Cycle Network Route 75), it is recognised that others come via the road network (whether on foot, bicycle, car or bus).

Notes the Colinton Tunnel Mural team and local Ward Councillors are receiving increasing numbers of reports that some people find it difficult to find the tunnel from Colinton village although it is clearly marked on Google Maps.

Notes the longstanding support the City of Edinburgh Council has provided the Colinton Tunnel Mural project due to its cultural and economic benefits.

Asks that the Traffic Signs Team brings forward a plan within two cycles to improve signage in the Colinton Area for those trying to find the Colinton Tunnel Mural and National Cycle Network Route 75."

14 Safe Re-opening of Businesses in Edinburgh – Motion by Councillor Lezley Maron Cameron

"Council welcomes the positive public engagement with the Spaces for People programme, designed to ensure the safety of people walking, cycling and wheeling; and the contribution of this, and other holistic measures which support the allocation of public space, towards a sustainable, economic recovery for Edinburgh.

Council notes officers across relevant departments are working up a clear framework within which Edinburgh businesses can safely reopen and operate within all social distancing guidelines; and without detriment or compromise to accessibility; and to health and safety.

Council requests an update report on work to support business reopening, including actions taken to support business operating in outside spaces as soon as practicable."

- 2) To recognise the key themes emerging include the narrowness of pavements, limited space to queue and the speed to traffic.
- 3) To note that our city is diverse and retail and hospitality businesses operating in different locations from the city centre to village high streets face shared and differing challenges and the key to understanding and meeting these is through consultation with business owners and residents.

19 Liberton Primary School – Motion by Councillor Lezley Marion Cameron

(a) Deputation – Liberton Primary School Association

A written deputation was presented on behalf of Liberton Primary School Association.

The deputation requested that that any refurbishment undertaken at Liberton Primary School made the most of the opportunity to equip the school to meet standards and guidelines for 2020 and not 1954 when the school was originally built. They indicated that this would mean increasing classroom capacity, communal space and indeed providing for further rising rolls in the future and that following on from the recent fire, safety was a priority for the families of the school.

Whilst still facing potential further months of uncertainty the deputation felt that the proposal of temporary units could be utilised to minimise this, with the possibility of an August return for all pupils and felt that this should be considered and prioritised by the Council. The deputation asked that both parents and staff be consulted on both plans and progress

(b) Motion by Councillor Lezley Marion Cameron

The following motion by Councillor Lezley Marion Cameronwas submitted in terms of Standing Order 14:

"Following Council's approval of a Motion on 12 March on the rebuilding and refurbishment of Liberton Primary School; and the subsequent onset of COVID-19 lockdown on 23 March, Council notes the recent request from LPSA to their Liberton Gilmerton Ward Councillors, seeking an update on rebuilding and refurbishing progress and timescales; and confirmation that, given COVID-19 lockdown, plans to site temporary classroom units would still happen in good time before schools reopen on 11 August.

Council notes that work to install temporary units on site is ongoing as well as classroom space secured in neighbouring community centres. Officers are planning, alongside third sector partners, to ensure children have all the necessary support and facilities for the schools reopening in August, without decant to other schools.

Council agrees an update report to the Policy and Sustainability Committee in three cycles setting out the timescale and progress made to date on the rebuilding and refurbishing of Liberton Primary School to a quality and standard which meets 2020 guidelines for class sizes and communal areas; and which also creates the necessary additional space to accommodate continually rising school rolls."

QUESTION NO 1

By Councillor Burgess for answer by the Convener of the Education, Children and Families Committee at a meeting of the Council on 30 June 2020

Question

What steps have been taken to consult parents and take feedback on their experience to date regarding arrangements for the re-opening of schools on 12 August?

Answer

Councillors and Officers have met on two occasions (3rd and 26th June) with the Consultative Committee with Parents, which includes Parent Council Chairs.

Officers have also met with Locality Groups, across the city and including Special Schools. Parent Council chairs were able to provide feedback.

Individual Headteachers have been working with their own school communities throughout lockdown on arrangements for their particular school. Headteachers had been asked to update parents on the plan for Blended Learning by 24th June. The recent update from the Deputy First Minister may now change those plans.

A number of parents have also contacted one of the Senior Education Officers to ask about Flexible and Home Schooling for August, as they feel that the full time return to school is not the best thing for their child.

Supplementary Question

Thank you Lord Provost and I thank Councillor Perry, the Education Convener for his answer about how the Council's been consulting parents about teaching during lockdown and the return to school in August. Parents are understandably concerned about whole range of issues as we saw from a two hour sessions mentioned in the answer held with the Consultative Committee with parents last week, it's very welcome that the Council's agreed to keep up communication with parents through the summer holiday period before the return to school, but can I clarify with the

Convener if the council will consider actively seeking out hard to reach groups of parents, who don't routinely engage through the CCWP, for example, families from the Black Asian and Ethnic Minority communities who are being disproportionately impacted by the COVID-19 pandemic, the Convener will be aware that there are some very active engaged BAEM advocacy groups that could be engaged with, if the Council would wish to do that, thank you.

Supplementary Answer

That's a good suggestion, there have been a number of suggestions about how we reach out. At the moment there's a web page on which information goes out and every parent's got access to that web page. We've agreed to meet with the CCWP at the beginning of August again, and it's something we've discussed with the CCWP on a number of occasions, about how we reach harder to reach parents who don't normally engage, so that something I'll take up.

QUESTION NO 2

By Councillor Mitchell for answer by the Convener of the Transport and Environment Committee at a meeting of the Council on 30 June 2020

Question

Please could the Convener confirm how much of the recent £5m funding from the Scottish Government for creating safe, accessible routes has been:

- 1) spent and allocated so far per Ward and in total?
- 2) spent and allocated so far on newly developed projects via 'Spaces for People' per Ward and in total?
- 3) spent and allocated so far to advance projects started and/or stalled prior to the pandemic and creation of 'Spaces for People' per Ward and in total?

Answer

This information is not currently available but further information on expenditure on the Spaces for People programme will be included in the August update to Policy and Sustainability Committee.

Supplementary Question

Thank you Lord Provost and thank you to the Convener for responding. I was just wondering if it's a point of clarity why the data isn't available and is this because officers aren't keeping track at the minute or if that's just going to be worked out later?

Supplementary Answer

Thank you for the supplementary Councillor Mitchell. It just seems both premature and slightly skewed in terms of a focus around this particular initiative. As you're aware this city wide process that were going through in terms of this spaces for people initiative, we've been very happy recipients of substantial funding from the Scottish Government and we're only partly through the processes of both assessing the schemes that need to go in, where we can get the better degree of benefit and how quickly we can implement those schemes. As you know we've taken on board enormous numbers of suggestions, about

approximately 3000 suggestions from the public across the city and both in those terms and in terms of the structure of the projects that we're doing, they do not define neatly into ward areas and so it's very difficult for us to come up at this stage, partly through this process of being able to allocate spend according to ward boundaries. There is no doubt that we'll be looking back at this project as we progress further and hopefully get towards a degree of completion on it where we will be able to bring forward a lot more information about what the spend has been, what it has been spent on and hopefully the achievement, our objectives attached to this scheme, but right now it's too early and looking at it through a ward perspective is not particularly helpful given the parameters of the project, thank you.

QUESTION NO 3

By Councillor Rust for answer by the Leader of the Council at a meeting of the Council on 30 June 2020

On 6th February the Council Leader confirmed in response to my written question regarding the burning of memorial benches by the Council that an internal investigation was being undertaken in line with the Council's disciplinary procedure and that the investigation will be concluded as soon as possible.

Question

(1) Has the investigation now concluded and if not, why not?

Answer

(1) At the outset of the COVID-19 pandemic in the UK, along with all disciplinary investigations on-going in the Council, this investigation was suspended. Disciplinary investigations are now re-starting and this one is being progressed and is expected to be completed within the next four weeks.

Question

(2) When will the findings of the promised report offering assurance to elected members and the public be made available?

Answer

(2) As was set out in the answer provided on <u>6 February 2020</u>, the findings of the disciplinary investigation will not be made public. If it is found that there have been breaches of the presentation seat policy, these will be set out in a report to the appropriate Committee.

(3) Is it now known how many benches were burned?

Answer

(3) From the information we have so far 25 benches were burned.

Question

(4) What contact has been made with relatives or organisations associated with the memorialised benches?

Answer

(4) At the time of this incident, relevant donors were contacted and given options about they wanted to proceed, such as whether they wanted to receive the plaque or obtain another bench.

Supplementary Question

Thank you Lord Provost and I thank the Convener for his answer to the question. Given that we are referring incidents that were publicly reported in January and I asked the question in February regarding the contact which should have been made with relatives in relation to our organisations associated with the benches, and the answer was that no contact had been made in February. In answer to 4 today the answer's given that at the time of the incident relevant donors were contacted, so I just wondered which is accurate, and if the previous answer was inaccurate, will the minute from February be changed.

Supplementary Answer

Thank you very much. The previous answer was accurate and the second answer was accurate. As soon as information was known people were contacted, if that's not clear in the wording of answer 4 in terms of the timing, I'm more than happy to get Councillor Rust subsequent information about exactly when that took place, but both answers are accurate.

Answer

(1) The table below shows the number of reports of full litter bins in both 2019 and 2020 for the months March, April and May.

Question

(2) What, if any, changes have been made to the container capacity or frequency of collection for litter bins located in parks and other beauty spot areas in the last three months?

Answer

(2) There has been no change in container capacity at parks and other beauty spot areas in the last three months. However, additional larger bins have been placed in areas of high footfall, generally coastal locations and parks. Due to COVID-19 there have been significant challenges in servicing bins in parks and other beauty spots however arrangements have been made to increase the frequency of collections at locations with high footfall during periods of good weather.

Supplementary Question

Thanks very much and thank you to the Convener for the answer. I'm sure the Convener would join me in thanking all of those Council staff who have frankly gone I think, above and beyond over the last few weeks in clearing litter left across the city. I think those in particular who undertook the heroic efforts in clearing up the mess of the Meadows deserve I think special recognition. Nevertheless, the answer which the Convener's provided I think has underlined the increasing concern which we are seeing around litter and the increasing complaints we got. The Convener mentions that larger bins have been placed in parks and beauty spots, would it be possible for councillors to get a list of the places where this actually happened?

Supplementary Answer

Thank you Councillor Lang for the supplementary I see no problem in providing that list and will get that circulated as the Lord Provost has indicated to all Councillors, post this meeting. I think you're absolutely correct to highlight the work that's going on by an enormous range of council staff to try to support the city through these strange times and waste collection and litter collection is one of the key areas in which I think we're seeing an enormous degree of success. You are quite correct to highlight the meadows, some of the litter that's been left behind there's been quite shocking in its scale and the fact that we've had crews out early morning to clear that to make it as acceptable as possible to other residents who want to use it at other times of the day, has been quite remarkable. I know it's produced a lot comment on social media but I do appreciate the work that that staff does both in that location and right across the city at other hotspots. I just wish some of our residents and indeed now visitors did not choose to leave their litter behind in such a way, if you can carry it in, you can carry it out and take it home with you, so thank you for your comments.

Question

Can the Convener list the changes which have been made to improve walking and cycling as a direct consequence of suggestions received from local communities since 14 May, broken down by ward.

Answer

The temporary measures implemented to create safer spaces for walking and cycling have not been broken down by ward. Breaking measures down by ward is contrary to the spirit of initiative which needs to focus on creating the fastest and greatest benefit across whole of Edinburgh, rather than defining measures to fit ward boundaries.

A full list is however provided on the <u>Council's website</u>. These schemes have generated a high level of interest and positive feedback from residents and stakeholders.

As a direct result of suggestions received from local communities, the following have been or are being implemented:

- **Braidburn Terrace** a one-way system has been created in response to local community feedback, to manage impacts from the closure of Braid Road.
- Maybury Road a temporary crossing at the Maybury Road / Cammo Walk junction is expected to be in place by the end of June to respond directly to safety concerns raised by the local community. While the crossing was already identified as a measure for future implementation, its delivery has been brought forward in response to feedback.
- Paths for Everyone local feedback has called for reminders for users to be considerate of each other, particularly on shared paths. The Council's 'Paths for Everyone' campaign was updated to reflect this

feedback and messaging is being targeted in direct response to this issue around shared paths and parks/open spaces. Whilst not a physical measure, clear communication has been critical to assisting path/road users in practicing safe physical distancing.

Since the launch of the suggestion email and subsequent addition of the Commonplace tool a significant number of responses have been received. The closing date for comments was 29 June 2020. The feedback and suggestions received so far relate to both schemes already implemented, planned and new suggestions. These are all being reviewed and plans made to incorporate these in future phases of the implementation programme where it is possible to do so.

An update on how public views have informed proposals will be included in the Policy and Sustainability Committee progress report in August 2020

Supplementary Question

Thank you and again, I appreciate the Convener providing the answers that she had, although I did specifically ask about responses to community suggestions that had been received since the 14th of May because that was when the council started asking for suggestions, and I'm conscious that I think Braidburn Terrace, the one way system, was actually before then and similarly the Paths for Everyone campaign was, I believe, signed off before then too. So my supplementary really follows on from Councillor Mitchell's one, is she not as frustrated as I am, that almost seven weeks on from asking, it seems as though just one idea received from Community suggestions has been implemented.

Supplementary Answer

This has been a really interesting process for me because we've seen an absolute clamour for action around this from across the city whether that includes councillors and whether or not that includes the kind of suggestions that are emerging through the consultation tool that we put out there, a tool I hasten to add that has only just finished collecting its process, only finished yesterday. So in the process clearly

there's been a lot of monitoring going on, there's been a lot of feedback provided, around some of the projects we've got going forward between councillors and other interested stakeholder groups. It is a mammoth task to respond to all of those suggestions and there is inevitably a sifting process going on between those suggestions, the work that we know already requires to be done, and trying to make those marry up. The one thing I would say is that all of those suggestions that comes out, what I can say is that we've tried to make it very clear from the very beginning that not every suggestion of those approximately 3000 that have come in so far plus additional ones that have come in through routes like the Community Councils and so on, whilst - we have had an enormous range of suggestions come forward, we are attempting to sift through those to make sure that they marry up with what we know needs to be done from our own knowledge of the city, the attempt to marry those together is real, it's complex, and it involves an enormous amount of hard work. There has already been a great deal of feedback sent back around questions that have been raised around the proposals that have come forward so far and that's a process that will continue as we go forward with this particular project. We are only part way through this process, the continuing opportunity to take action based on those suggestions and to provide further feedback will be there and will be followed assiduously as we go through the project. I'll follow up separately with Councillor Lang if he wishes to in person after this meeting

Comments by the Lord Provost

Question

Following extension of the Unsuitable Accommodation Order to all homeless people on 6 May, how many homeless households are in temporary accommodation which is classified as unsuitable:

- a) Without applying the time limited exemptions related to Coronavirus:
- b) Without reference to whether that use is for more or less than 7 days.

Answer

As at 22 June 2020, there were 1051 households in accommodation which would be deemed as unsuitable. Thirty of these households are in Rapid Access Accommodation, which are shared houses, but are likely to be exempted from the changes to the order, due the emergency nature of the access and support provided.

Supplementary Question

Thank you Lord Provost, I thank the Convener for her reply. Please could she clarify what action the Council is taking to ensure that the good progress in providing accommodation for homeless people during COVID-19 is not reversed as the lockdown eases whilst at the same time ensuring that accommodation meets the needs of homeless people and delivers good value for money.

Supplementary Answer

Thanks very much for your question Councillor Booth. I think there's a lot of work that we were doing already prior to the pandemic that was setting us on the right path around the type of accommodation that we need, so we've already prioritised increasing temporary furnished flats because they are recognised as probably the best form of accommodation for the majority of people while they are experiencing

homelessness. We've done work around the PSL scheme. we've also been looking, as you'll be aware, at purchasing properties for homeshare, so where a number of people are able to share a house or a home, rather than going into what would have been more traditional B&B or shared housing, but there's also a need for other types of accommodation so supported accommodation is really important, it's one of the things I think has become very clear to me is actually everyone has different needs and we have to make sure that we're providing for those needs so for example, through the Homelessness Task Force we've been looking at managed alcohol programme and how we can provide that in partnership with health and social care and that is something that housing are very keen to provide, the accommodation aspect, but we need to work with the health and social care partnership because there's a clinical aspect of this as well. So it's really about making sure that we are looking across the piece at the varying needs that we have and making sure that we're finding the right type of accommodation. So this is something that's been embedded and enshrined in our rapid rehousing plans for some time. I think one of the things that we've learned and that we've seen that's been quite phenomenal is the way that our officers have worked with partners across other public sector bodies and also across the third sector and been able to engage people in a way, people who've been rough sleeping who have multiple and complex needs that we've maybe not been that successful at engaging with, enable to engage with services so that they're able to access more stable long-term accommodation, making sure people understand the Housing Rights, addressing any issues they might have around no recourse, so I think there's a lot of learning that's come out of that and a lot of learning that we will absolutely want to hold on to and make sure we are embedding in our practice as we go forward.

NB: If statistics are unavailable at short notice to parts 1 and 2 I am willing to accept a deferment on those questions but would like an answer to part 3 even if that is the case.

Answer

(3) It is the responsibility of the individual operator to ensure they have all the necessary permissions and consents in place prior to the use of a property as a short stay commercial let. The Council's planning enforcement team continues to pursue reported cases of unauthorised short stay commercial lets and reviews information held on the Scottish Assessors website in relation to non-domestic rates as part of their evidence gathering to determine whether there has been a material change of use in planning terms. The business rates would be a strong indicator that the property is not in residential use, but the team would still need to assess a range of other factors to determine whether planning permission is required.

Supplementary Question

Thank you Convener. Given that the Scottish Government has so generously ensured that over 350 potential homes will remain short-term lets despite the Covid crisis, does the Vice-Convener agree with me that the Scottish Government should also assist us in finding those short-term lets that are operating without planning permission?

Supplementary Answer by Councillor Child

Thank you for the supplementary Councillor Staniforth. I do agree that this is a particular issue particularly during the Covid crisis. I think what you're referring to is, should we have a licensing regime, I think in terms of the planning function we're doing the best that we possibly can to ensure that every short-term let that is operating does indeed have planning consent and we've been quite successful in refusing those that are in shared stairs that cause issues in terms of local amenity, but I think to tackle this issue of difficulty with short-term lets, they are part of welcoming visitors to the city, so they're not all bad by any stretch of the imagination, but we need to get it under some kind of control and a licensing regime is going to be part of that. I hope that answers your question.

By Councillor Jim Campbell for answer by the Leader of the Council at a meeting of the Council on 30 June 2020

Question

(1) Is the Council Leader aware that a condition of the UK Government's Coronavirus Job Retention Scheme (JRS), is that employees can only be furloughed that would otherwise be made redundant or laid off?

Answer

- (1) For each category of employee/ worker where the Council applied to the JRS, the service area was required to consider the following matters:
 - whether the proportion of the service area's budget that comes from central government public funding was less than 50% of the overall budget;
 - whether the money in the service area's budget that comes from central Government public funding adequately covers staff costs for the area;
 - whether the affected employee/worker could be redeployed to assist with the Covid-19 response;
 - whether the service area lost some or all of its normal income due to Covid-19; and,
 - whether, if the service area did not get access to the JRS, could the alternative be a review, with the intention of considering efficiencies/ cost savings.

Consideration of those matters in totality provided a basis to determine whether distinct application to the JRS would be permissible.

Question

(2) Can he confirm that for the circa 500 City of Edinburgh Council Officers recently furloughed, that all redeployment options were investigated, but that had UK Government JRS not been available, these officers would, with regret, had to be made redundant?

Answer

(2) Relevant service areas were required to consider whether the affected employees could be redeployed to assist with the Covid-19 response and, in the event that this was not possible, consideration was given to JRS arrangements.

Question

(3) Given these potential redundancies and the recent redundancies his Administration has made at Council owned ALEOs, what reassurance can he give Council Officers that his Administration will make no further redundancies in this Council term

Answer

(3) The Council's Administration remains wholly committed to its Political Commitment of no compulsory redundancies within the Council's directly employed workforce, in direct opposition to the Conservative Group, which has consistently tried to undermine the job security of Council employees by promoting the use of compulsory redundancy.

The Administration has made no redundancies in Council owned Arm's Length Organisations (ALEOS), as these are decisions for the Boards of these organisations. As legal employers in their own right, ALEO Boards are responsible for determining their employment policies and workforce requirements.

(4) Would he accept that recent staff surveys suggest that Council Officers do not consider "a no compulsory redundancy" policy as immutable in the future delivery of high-quality Council services?

Answer

(4) As stated in response to 3) the Council's Administration remains wholly committed to its Political Commitment of no compulsory redundancies within the Council's directly employed workforce.

With no clear signage across the city advising that parking fees had been suspended until Monday 22nd June can the convenor confirm:

- 1) The revenue raised via Ringo Service / App despite the suspension?
- 2) The process to claim refunds for payments made via Ringo Service / App?

Answer

The RingGo website, application and telephone service all provided clear messages to customers confirming that parking charges were not in place across Edinburgh. All pay and display ticket machines across the city also displayed similar messages.

Pay and display charges were suspended on Tuesday 24 March 2020. Despite the messaging to customers, a total of £101,537.50 was received through the RingGo service during the suspension of charges.

We're on the cusp of one of the most significant economic downturns in almost a century during which we will be hurtling out of the EU with no credible plan and it's quite telling that the Conservative party, the supposed party of business, chooses to ask the Economy Convener about the smallest ALEO that we have and one that's already in hibernation. Is this about the economic well-being of our city? In terms of his questions Councillor Johnson is well aware, and I've taken governance advice on this, that these questions are not questions to a Convener, they're questions to the chair of an ALEO. I am very happy to answer these questions if he wants to write to me as Chair of Marketing Edinburgh, I will be happy to answer them, but he knows full well that this is absolutely not the appropriate forum, I have taken advice on this and I think this is just grandstanding.

With the re-activation of the public spaces grass maintenance teams, and the update to councillors that no grass cuttings would be collected, but instead left to disperse, there is likely to be a significant amount of loose grass in our open spaces. While recognising the approach to encourage more 'wild flowers/areas' and that loose cuttings may be a good nutrient for the soil underneath, our open space still need to be inviting to enjoy, and practical for some physical activities.

As such please provide information on the following:

Question

(1) What is the cost of suitable equipment to collect grass cuttings (cost per machine/vehicle)

Answer

(1) The cost varies depending on size and type of machine/vehicle. A typical ride on mower with lifting unit costs approximately £11,000 - £15,000.

In addition to the vehicle costs, there are also significant operational costs arising from the transportation and disposal of the grass cuttings.

Question

(2) How many are already owned by the Council and how many are currently operational?

Answer

(2) The Council currently owns one and this is operational.

Question

(3) What discussions have taken place with potential private contractors to undertake the collection of cuttings?

Answer

(3) There have been no recent discussions as there is no budget allocation to engage with a private contractor for the collection of cuttings.

Question

(4) Is the Council still pursuing a desire for 'wild areas' and how is the determined so as to maintain a balance with usable space?

Answer

(4) Approximately 13% of the Council's former standard amenity grasslands are now maintained with a less frequent cut. These and other potential locations are constantly reviewed, with the principal factors considered for naturalisation suitability being recreational use, proximity to other landscape features (e.g. under trees), aspect, biodiversity benefit, and aesthetics.

Supplementary Question

Thank you very much Lord Provost and thank you very much to the Convener for a very helpful answer. Could I just ask you please to confirm where the one operational machine that we do have currently services, and how do councillors request or book that in for their own ward for any particular problem spots.

Supplementary Answer

Thank you Lord Provost and thank you Councillor Young for your question. There is only the one, yes and we had discussions before about this and financially there is no money available for the purchase of more equipment although replacement of failing equipment was put on pause for the present crisis, but the contracts have now gone in for that so we should see an improvement in efficiency very soon now, but if there are particular areas that Councillor Young has in mind then if she could let me know about those then we will target them. Obviously we've prioritised parks and courts and other areas where the length of the grass is absolutely paramount and I would like to commend our park staff for making a really good job of that and again going above and beyond at this difficult time. De-prioritising other areas has been an ongoing issue, but we are getting to them now and the one machine does have to range across the entire city. If you have a particular area in mind, if you let me know will make sure that gets attention.

Recognising the unprecedented situation faced by teachers to provide remote teaching, there has however, been an wide ranging provision across the city in terms of the approach to online face to face group or individual teaching and support (video enabled or one-way only). This has been an area of significant concern to many families.

Question

(1) What guidance was given to schools on the use of virtual meetings with pupils?

Answer

Guidance around the use of video meetings with learners (1) has been in our EdinburghLearns@Home Digital Support Page since April 2020. This informed schools that one-way video with learners using Teams Meetings (teacher to learner, where the learner can view the teacher but the teacher cannot view the learner) is possible, and that, continuing to follow national guidance, two-way video is not enabled across all Edinburgh schools. As we considered the best way to enable two-way video in response to requests from schools and the benefits to learners of live interactions, a short life working group was set up and draft responsible users' protocol, staff protocol, and parents', carers' and learners' getting started guide created. A number of schools opted to be two-way video pilot schools and these documents have been, so far, provided to two-way video pilot schools only.

Question

(2) Why was a consistent approach not taken across the city that, while recognising the importance of pupil safety, understood the importance of interaction and face to face engagement?

Answer

(2) Digital learning is a fast-growing area of activity within the City with learners, parents and staff all developing new skills at a rapid pace. To ensure that our strategy and support are appropriate, officers have risk assessed the provision and produced risk management, and action, plans to ensure safe and beneficial practices are in place. At this moment in time we are following national guidance and have not fully enabled live video lessons. This is due to concerns over safeguarding, equity of provision, concerns raised by teaching unions and the requirement to develop the necessary skills in learners, parents/carers and staff. None of these is insurmountable, however there are some issues which are pressing: not everyone has a device and not every child or young person can access live taught content. We are also not confident that all children and young people can safely manage the capabilities that enabling live video would bring until these issues are addressed and supported. We recognise that there are benefits to live video in teaching and learning, and we are working methodically, and systematically, to ensure that the learners who need this most have safe, equitable access This includes learners with severe and complex additional needs, and a limited number of secondary and primary schools. Thereafter, we will work with other groups to enable live video, in a managed way. We are currently in the pilot phase of taking forward this aspect of practice. I must stress that in most mainstream schools this will not be for live teaching of whole class lessons and cannot be to the detriment of learners do not have a device, or access to the internet, which would create potential inequity. Rather this will be for health and wellbeing check-ins and assessment tutorials which is of paramount importance. As more devices become available. and when we can ensure equity of provision, this will of course be reviewed. This is an area of rapid policy development, requiring significant resource, negotiation with teaching unions, and professional learning, together with a review of the Responsible User Protocol governing this area of practice. We absolutely want to get this right for learners, and in risk managing, preparing new protocols and training, and ensuring union support, we are confident it won't be

(3) What is the official position/guidance as we move to blended schooling, for virtual classes or 121 contact with teachers and with wellbeing support staff, to ensure that children across the city have the same opportunities?

Question

(1) Can the convener give an overview of the grass cutting equipment CEC own?

Answer

- (1) The Council owns or hires:
 - Five tractors are owned, three tractors are temporarily hired
 - Five rotary cutting units and four flail units suitable for tractor
 - Two midi tractors with rotary mowers and grass collection facilities (these are used for meadows and occasionally sport pitches)
 - 26 ride-on mowers
 - 35 pedestrian mowers 36" cutting units
 - 40 pedestrian mowers 18" cutting units

Question

(2) What proportion of grass cutting machinery is currently available?

Answer

(2) This fluctuates on a daily basis due to repair and servicing requirements. On 22 June 2020 there were two ride-on mowers and one flail cutting unit under repair

Question

(3 What is the area of grass land within CEC ownership that requires cutting?

Answer

(3) Approximately 734 hectares are maintained as standard amenity grass and mowed on a regular basis during the growing season. Around 100 hectares are maintained as naturalised grass and mowed 2-3 times per year.

Question

(4) What is the normal annual cost of grass cutting?

Answer

(4) Approximately £1.57m

Question

(5) What is the anticipated impact of the coronavirus epidemic on this year's grass cutting budget?

Answer

(5) The 2020/21 revenue budget for grass cutting is not expected to change significantly as a result of the coronavirus epidemic. While some savings may have been achieved, there have also been additional costs incurred for vehicles to ensure that physical distancing arrangements are in place for grounds maintenance operation teams.
