#### **4 Outcome of the Statutory Consultation Process on the Proposal to Realign the Catchment Areas of Queensferry Primary School and Echline Primary School**

---

Details were provided on the outcome of the statutory consultation process undertaken on the proposal to realign the catchment areas of Queensferry Primary School and Echline Primary School as new housing developments were progressing within the Queensferry Primary School catchment area but there would not be enough capacity at the school to accommodate the additional pupils.

#### **Decision**

- 2) To agree that a P1 place at Queensferry Primary School be guaranteed for children (if they wished to take it):

- whose parent(s) or guardian were resident in the area on 11 March 2021; and
  - that would have an older sibling in Queensferry Primary School at the time they would attend the school.
- 3) To note that the implications of the sibling guarantee offered and its continued application would be reviewed as part of a future statutory consultation concerning a new school building as part of the 'Builyeon Road' housing site.

## **8 Princess Alexandra Eye Pavilion - Motions by Councillors Whyte and Lezley Marion Cameron**

---

The Lord Provost ruled that the following motions, which had been submitted in terms of Standing Order 17, be considered together:

### **Motion 1 - By Councillor Whyte:**

“Council

- 1) Notes with concern that the Scottish Government has withdrawn the funding promised in 2018 to provide a replacement for the Princess Alexandra Eye Pavilion in Edinburgh;
- 2) Notes that the current building is over 50 years old and has been deemed “not fit for purpose” by NHS Lothian and that this has implications for the care received by patients in Edinburgh and the Lothians;
- 3) Understands that waiting times for routine treatments, such as for glaucoma, and removal of cataracts can be extremely long and notes that NHS Lothian has been consistently underfunded by the NRAC funding model over many years;
- 4) Agrees that the Council should work with our partners in NHS Lothian to restore the promised funding to retain these vital services in Scotland’s capital giving access and equity to residents in Edinburgh and across all the Lothians rather than see them “dispersed” to West Lothian.
- 5) Instructs the Council Leader to write to the Cabinet Secretary for Health demanding reinstatement of this cut in infrastructure funding for NHS Lothian and seeking that our partner NHS Board is fully and fairly funded in future.”

### **Motion 2 – By Councillor Lezley Marion Cameron**

“Council notes:

Since opening in 1969, the Princess Alexandra Eye Pavilion (PAEP) has delivered eye health care and treatment services to countless patients, of all ages, from across Edinburgh, the Lothians and South East Scotland; and is a world-renowned centre of excellence in this field.

The facility was deemed ‘unfit for purpose’ in 2015, and in 2018, the Scottish Government committed to fund a new eye hospital to replace the Princess Alexandra Eye Pavilion to continue the high standard of ophthalmology services to people from Edinburgh, the Lothians and South East Scotland;

The widespread and growing public concern about the loss of the Princess Alexandra Eye Pavilion from Edinburgh; and the lack of available, affordable and fully accessible travel options which provide timeous access to services, currently provided by the PAEP, in facilities located out with Edinburgh. Notes recent comments by the Cabinet Secretary on this issue.

Council therefore calls for the Council Leader to write to the Cabinet Secretary for Health and Sport requesting an urgent meeting on the replacement of the Princess Alexandra Eye Pavilion; so as to ensure the people of Edinburgh, Lothians and South East Scotland can continue to have access to eye healthcare, hospital and treatment services in a facility located within Edinburgh.”

- 7) Further agrees that the Council should work with our partners in NHS Lothian and other local authorities to restore the promised funding to retain these vital services in Scotland’s capital giving access and equity to residents in Edinburgh.
- 8) Therefore instructs that the Council Leader and Deputy Leader write to the Cabinet Secretary for Health and Sport requesting an urgent meeting on the required funding form Scottish Government’t to support NHS Lothian’s replacement of the Princess Alexandra Eye Pavilion with a new facility; so as to ensure the people of Edinburgh continue to have access to eye healthcare, hospital and treatment services in a facility located within Edinburgh and seeking that our partner NHS Board is fully and supported in that aim.

## **9 United Nations Anti-Racisms Day #worldagainstracism Day of Action – Saturday 20<sup>th</sup> March 2021 – Motion by Councillor Lezley Marion Cameron**

---

### **(a) Deputation – Stand Up to Racism Edinburgh**

A written deputation was presented on behalf of Stand Up to Racism Edinburgh.

The deputation welcomed the motion which they hoped would be supported.

They indicated that they had organised demonstrations across the UK for a number of years now on International Anti-Racism Day which would usually take place in Glasgow, Cardiff and London, but this year, with safety concerns due

to the pandemic, they stressed that it would not be appropriate to hold those mass demonstrations. On that basis, Stand Up to Racism Edinburgh had taken the decision to hold an online rally from 1pm to 2pm on 20 March, which was to be followed by a UK-wide online event at 5pm.

The deputation urged the Council to take a lead, not only in supporting UN Anti-Racism Day, but in challenging racism within the city on a long-term basis.

**(b) Motion by Councillor Lezley Marion Cameron**

The following motion by Councillor Lezley Marion Cameron was submitted in terms of Standing Order 17:

“Council notes:

That Saturday 20 March 2021 is the UN Day Against Racism, with events taking place in cities, communities and countries via online rallies around the world.

That people will come together across the globe, united against racism, Islamophobia, antisemitism and fascism; and stand in solidarity with our residents, and people across the world to convey a powerful, global message of zero tolerance to racism.

The City of Edinburgh Council confirms support for the UN Day Against Racism 2021 and its aims and reaffirms that this reflects the will of Council, from June 2020 and agrees to fly the UN flag on March 20th 2021.”

**10 Uber – UK Supreme Court Decision - Motion by Councillor Watt**

Notes the potential impact of this decision for workers in sectors within the Capital.

Requests a report within three cycles to the Housing, Homelessness and Fair Work Committee to further explore and update members on any impacts of the Court’s decision in relation to fair work.”

## **11 Mobility as a Service – Motion by Councillor Jim Campbell**

The following motion by Councillor Jim Campbell was submitted in terms of Standing Order 17:

“Council:

Recognises the role Edinburgh plays as a centre of data driven innovation and the existing strengths and ambitions the City has in data analytics and human behaviour.

Notes that innovation will be vital to the success of Edinburgh and the Scottish economy as we move out of the acute phase of the Coronavirus Pandemic.

Notes that Mobility as a Service could be a significant disrupting force in the near future; albeit it is reliant on some underlying emerging technologies coming to maturity, such as the electrification of transport, the development of intelligent streets and the emergence of automatic and autonomous vehicle control. Recognises the value of public transport to Edinburgh but accepts that mass transport solutions may see a reduction in the level of public patronage on which they depend.

Agrees that, in light of recent announcements from HM Treasury, the Executive Director of Place should explore with all Edinburgh City Region Deal Partners the appetite for undertaking a feasibility study to investigate the use of emerging transport technologies within a defined city network to facilitate Mobility as a Service solutions for individuals or small groups at an affordable price.

The study would:

- consider how data for intelligent streets could improve efficiency and reduce the impact of movements around the city;
- examine the opportunities and challenges that electrification and autonomous vehicle technology (augmented by intelligent streets) might create for public transport;
- Set out the legal, operational, data and power requirements necessary to support such a system;
- Gauge the appetite of commercial partners to see Edinburgh as a useful location to undertake such innovative development;



- detail the full economic and social case for such a system in a city of Edinburgh's size. The Executive Director is asked to report on the interest in undertaking such a feasibility study amongst City Region Deal Partners within four cycles."

- c) In 2003, Ella became Chief Executive Officer at The Rock Trust, and focussed upon embedding a culture of improvement and consistent advocacy for young people across Edinburgh.
- d) In September 2009, Ella became Director of EVOC, working to;
  - (i) steer the organisation through a period of substantial change,
  - (ii) grow involvement of the City’s third sector in partnership, cross-sector and strategic working,
  - (iii) advocating the benefits of working with city charities,
  - (iv) achieving tangible change for our most vulnerable citizens, and
  - (v) celebrating 150 years of EVOC and its extraordinary impact across our communities of interest and place.
- e) Ella leaves her Director’s post with EVOC and her place on our strategic partnerships with a strong legacy of a vibrant third sector, cooperative working, and the continuing need to focus upon addressing inequalities in our city. Key partnerships and initiatives that have benefitted from Ella’s input, include; Edinburgh Partnership, Compact Partnership, Edinburgh Health and Social Care Partnership, Edinburgh Thrive and Edinburgh 2050 City Vision.
- f) Throughout her volunteering and career, and in particular 12 years with EVOC, Ella has been a robust and honest and independent voice for the social and economic importance of the third sector in Edinburgh, helping to raise the profile of the sector in the City and beyond, and in working to help communities-in-need at local, national and international settings.

- g) Ella will enjoy her well-deserved retirement with her family and the wider community in East Lothian. In acknowledging the long-standing and substantial contribution of Ella Simpson to the social, community and charitable fabric of Edinburgh, the City of Edinburgh Council is asked to congratulate Ella Simpson on her achievements and invites the Lord Provost to mark her contribution in an appropriate way.”

- Answer**
- (1) The total anticipated cost of running the consultation, taking into account the items outlined above, is expected to be approximately £60,000 (including officer time).
- Question**
- (2) Please confirm any anticipated costs payable to bodies/organisations external to CEC, including Social Marketing Gateway consultancy (SMG).

**Answer** (2) The total anticipated costs payable to external organisations is expected to be approximately £45,000. This covers the costs for assisting with tabulating and analysing comments made in the consultation questionnaire, as well as costs of market research and of measures (e.g. on-street adverts) to raise awareness of the consultation.

**Question** (3) Please confirm amount of officer time/resource scheduled to be involved in making *Spaces for People* projects permanent.

**Answer** (3) There is currently no officer time/resource scheduled to be involved in making *Spaces for People* projects permanent.

**Question** (4) Please advise from what budget will such spend be made i.e. the existing *Spaces for People* Budget or from which CEC Budget?

**Answer** (4) The cost of the consultation has been met from the funding received for the *Spaces for People* programme.

It is anticipated that any costs incurred for extending schemes on an extended trial or permanent basis would be met from the Scottish Government's *Spaces for People* programme or *Paths for All's* 'Sustainable travel behaviour change' programme.

Obviously a large sum of money is being spent and if that's been spent wisely in terms of a genuinely objective survey that makes sense but does the Convener accept that money would have been better spent earlier to allow residents to comment on schemes which have been put in place already against local wishes?

Unfortunately in terms of what this consultation is designed to do, is designed to bridge the gap between the temporary measures that have been put in place quickly in order to respond to Covid, and then under encouragement from the Scottish Government who provided all of the funding to start with for those temporary measures we've been asked to look and see how much we can then convert into permanent infrastructure for the benefit of the city, it's that that we're consulting on nothing to do with the temporary measures other than their existence at the moment, so that's the point of it and that's why it's necessary to do that now, thank you.

Thank you very much Lord Provost. My supplementary relates to question 2 because at last year's Committee, it approved 52 different footways for resurfacing and the Convener's answer suggests that only 2 have been done, has she got any explanation as to why that's the case?

**Supplementary Answer**

My understanding from officers is that it relates very much to the day in which we pulled this report, I would suggest that given the detailed nature of this that it might be useful for us to have a specific meeting with officers to go over these particular aspects as I know you'll have an interest from a ward point of view as well Councillor Lang, so I think my own preference would be to have that meeting and established the answer correctly and fully at this particular time in order to answer your question, thank you.

**QUESTION NO 3**

**By Councillor Lang for answer by the Convener of the Transport and Environment Committee at a meeting of the Council on 11 March 2021**

- Question** (1) How many households are currently registered for the garden waste collection service?
- Answer** (1) There are 74,539 households currently registered for the garden waste collection service, with 82,355 permits issued.
- Question** (2) What is the anticipated impact of the 40% rise in the garden waste collection charge on
- a) the numbers registering for the service and
  - b) the tonnage garden waste recycled in the city each year?
- Answer** (2) a) In preparing the proposal for increasing Garden Waste charges, the calculation of cost recovery was based on a low sign up scenario, with a stretch target which equates to a 1% reduction in registrations per £1 of increased cost.
- b) The charge is for the collection of garden waste only so no modelling has been done on the impact on tonnage
- Supplementary Question** Thank you again Lord Provost. Again my supplementary relates to 2(b) on tonnage and given the experience from the introduction of the charge last time, my supplementary is whether the Convener thinks herself whether recycling tonnage will go up or down as a result of the increase in the garden waste charge?
- Supplementary Answer** Given the fact of the impact on the tonnage going through the garden waste service it's almost impossible to give you a yea or nay on that because of course the tonnage is impacted by all sorts of things beyond the number of bins that we've got out there, it's also impacted by the length of

the growing season, by how well gardens are growing, how much effort people are putting in to cutting back etc etc, so it's actually too broad a topic for me to give you an immediate yes or no. I would however hope to see that with the garden waste, despite what we expect might happen, a slight reduction in the number of registrations but that was, as we've seen since the original introduction of the garden waste that those will go up again over time, a relatively short time, every time we've opened a registration window the number of people who want to opt-in to the service will go up. I would hasten to add also that the level of price that we have attached to the garden waste service is still very much at the low end of what other local authorities are charging and that should be remembered in how we consider this particular service and there are other parts of the UK that are charging £90 up to £100, we are very much at the low end and we're trying to keep it there as much as possible. This is likely to be a one-off rise and then the rest will revert back to the standard fees and charges rises at a later date. So in this particular instance I hope that people will not see the need to step back from this garden waste service, it's been a great success, people are very comfortable with it, it's delivering what people need, and I think it's an important one to keep going on. It reinforces the level of adoption, reinforces the fact that it was the right decision for do, and it also underlines the fact that the concerns that were being raised in this Chamber and out in the community about the terrible impacts of it don't appear to have materialised and that's something which I'm very pleased about because I think it means that we can continue to provide a service to the gardens, a service which is not given to other local authority residents, in the Borders my understanding is that they don't have a service at all for garden waste so I am very pleased that with these kind of changes that we're able to keep that service in a broadly consistent form, delivering what it is that the people of Edinburgh need, thank you.



#### **QUESTION NO 4**

**By Councillor Rust for answer by the Convener of the Transports and Environment Committee at a meeting of the Council on 11 March 2021**

- Question** (1) “Retaining ‘Spaces for People’ measures” consultation opened on 22<sup>nd</sup> February and closes on 21<sup>st</sup> March. “Winter Festivals 2021 onwards” opened on 24<sup>th</sup> February and closes 19<sup>th</sup> May 2021. Why is a consultation which impacts all wards in the city, open for response for only a third of the time of another current consultation?
- Answer** (1) The consultation on moving forward with Spaces for People measures by potentially extending some of the existing measures for a trial period or making some schemes permanent has been developed to ensure that the Council is prepared as COVID-19 restrictions are gradually lifted. The next stage would then be reporting back to Transport and Environment Committee.
- Question** (2) Due to the delay in making the telephone number and paper copies of the “Retaining ‘Spaces for People’ measures” consultation available, will the deadline be extended to ensure adequate time for residents to request copies, for the Council to distribute and for residents to complete and return?
- Answer** (2) To date, all requests for paper copies of the consultation have been received by email rather than through the telephone line (which went live four days after the consultation launched) and paper copies have been issued within 3-4 working days of the request being received. However, I agree it is vital that all residents have the chance to be heard and have instructed officers to extend the consultation deadline by a further two weeks to ensure appropriate time for postal feedback to be received.

Question**

Thank you Lord Provost and thanks again to the Convener. In terms of the answer to question 2, I note the phone number went live 4 days later but there's been no request to date, my question is where is the phone number being promoted on existing adverts about the survey and I ask that because my understanding is it's not, and so how does anyone know about the phone number if they don't have digital access?

**Supplementary  
Answer**

In terms of the presence of a telephone number I think it's available in various forms, it's certainly available online which I appreciate that will not suit everybody who is requiring to use the piece but as it happens and the fact that it's out there, and presumably councillors have been sending it out, there's been various methods of people getting, particularly those who are phoning into the Council customer care service etc, then it's quite clear that there's not that much of a demand for the telephone service. Now in terms of the precise details of where it's being advertised, I'll ask the service to provide you with that detail but my understanding is clearly that there is not that much demand emerging from the telephone route, the vast majority of people have moved over onto online presence and that's how we're obviously getting most of the responses in, thank you.

**QUESTION NO 5**

**By Councillor Rust for answer by the Convener of the Transport and Environment Committee at a meeting of the Council on 11 March 2021**

**Question** (1) In relation to Spaces for People has the Council sought/obtained any external legal advice, including from private practice or Counsel?

**Answer** (1) Yes. This has previously been highlighted to Elected Members in a written briefing and at Transport and Environment Committee.

**Question** (2) If so, please advise:

- (a) in relation to which specific schemes or if generally?
- (b) who provided the advice?
- (c) the cost of the advice, invoiced or anticipated?

**Answer** (2) (a) This is subject to legal privilege and cannot therefore be provided as an answer to a Council question. Further information is available to relevant elected members on a confidential basis through the Member/Officer Protocol.

(b) Given the multiple threats of legal action, both internal and external legal advice has been provided. External advice was provided by CMS Cameron McKenna Nabarro Olswang LLP.

(c) The cost of the external advice to date is approximately £5,400 (exclusive of VAT). It is not possible to estimate anticipated costs as that is wholly dependent on any correspondence or action brought forward

**Question** (3) Is any legal input from within CEC sought/given in relation to delegated decisions on Spaces for People made at CIMT?

**Answer** (3) A process is in place for all matters which are considered at the Council Incident Management Team. This includes relevant teams taking legal advice as appropriate in relation to any matters taken to that forum for consideration.

**Question** (4) How much CEC officer time in Legal and Risk has been budgeted/recorded against dealing with Spaces for People enquires /complaints/ providing advice/ reviewing schemes/ internal meetings etc?

**Answer** (4) Approximately 230 hours of internal legal work has been recorded.

**QUESTION NO 6**

**By Councillor Johnston for answer  
by the Convener of the Transport and  
Environment Committee at a meeting  
of the Council on 11 March 2021**

**Question** (1) Can the Convener explain why every design for a proposed Spaces for People programme is not automatically put on the Council website?

**Answer** (1) The designs for proposed schemes are distributed to ward members, Transport Spokespeople and key stakeholders, in line with the notification process agreed by Policy and Sustainability Committee on 14 May 2020.

**Question** (2) Does the Convener agree this inconsistent approach is causing confusion within communities and will she now commit to publishing detailed comprehensible plans as a matter of course?

**Answer** (2) The notification procedure is consistent for all schemes as noted above. Plans for some of the deployed schemes are not currently available on the Council website but will be uploaded shortly.

**Supplementary Question** Thank you Lord Provost and thank you Convener for your answer. Can I clarify, in point 2 of my question with regards to the consistency of approach regarding putting all plans on the Council website at the same time, am I to understand that will be the process going forward, so no matter what the project everything will go online so anyone can interrogate it?

**Supplementary Answer** What I can confirm Councillor Johnston is that as everybody who has been involved in Spaces for People should have observed we're moving very quickly outside our normal methods of doing things wherever possible we'll get those schemes up on the website at the appropriate point in the process. That's all I'm going to commit to at this point as if not it puts undue pressure on a very stretched team at the moment. I will endeavour to ensure that as much as

possible will be put on the website as I've indicated in the answer and that the notification process follows the process that was agreed by this Council back in May. I know there have been numerous attempts to portray that somehow we're breaking promises in terms of how we're doing that notification process, that is not the case, we're following the process that we had before and we're doing it under extremely difficult circumstances. So I'm very hopeful that people will be able to find the information that they require at the time that they require it, but I will not guarantee it at this point because of the pace of change that we're going through. As we move forward from the spaces that have been put in on a temporary basis, as we move forward into the permanent process, I hope that that information will be more readily available and can be interrogated by anyone quite easily because it will be a fairly straightforward process once we have completed our June Committee report on that, thank you.

## QUESTION NO 7

**By Councillor Rose for answer by the Convener of the Transport and Environment Committee at a meeting of the Council on 11 March 2021**

On 18<sup>th</sup> November 2020, the Cabinet Secretary for Transport, Infrastructure and Connectivity stated, in response to a question about passenger services on the South Suburban Rail Line, “. . .the issue has already been identified as part of the pre-appraisal work for STPR2, which has been shared with regional transport partners, the city council and other Lothian councils. It is now for them to look at the details of that and consider what further work is necessary in order to take it forward.”

At City of Edinburgh Council (CEC) Transport and Environment Committee on 19<sup>th</sup> February 2021, an emergency motion was passed including the following: “Asks that Officers liaise with Transport Scotland and Network Rail, and report to Committee within 2 cycles on the possibilities surrounding the South Suburban Line being considered for use”

Given that the issue was identified as part of the pre-appraisal work for the Strategic Transport Projects Review shared with the Council, and that the Cabinet Secretary stated it was for CEC (inter alia) to look at the details and consider what further work is necessary to take it forward, can the Convener advise:

- Question**            (1) What work was undertaken by CEC to progress this issue prior to 18<sup>th</sup> November 2020?
- Answer**             (1) Since summer 2019 the Council been engaging with Transport Scotland as part of the Edinburgh and South East Regional Transport Working Group to inform the Strategic Transport Projects Review 2 (STPR2). Once complete, STPR2 will set a programme of strategic transport investment opportunities for the period 2022-2042.

The Regional Working Group is led by Transport Scotland and is attended by all of the local authorities in the regional

area, we well as by regional partnerships. The Group meets once a month and additionally at key milestones. STPR2 is being published in two phases. Phase 1, published in February 2021, sets out the first recommendations for transport investment, focussing on projects or interventions that significantly contribute to STPR2 objectives, align well with National Transport Strategy priorities, can be progressed or delivered within the current spending period and will help support a green recovery from the COVID-19 pandemic. It includes a commitment to consider the south suburban line as part of the city's future mass rapid transit system.

**Question** (2) What work was undertaken by CEC to progress the issue between 18<sup>th</sup> November 2020 and 19<sup>th</sup> February 2021?

**Answer** (2) The Council has continued to contribute to the Regional Working Group during this period.

The Council will provide feedback to Transport Scotland on the Phase 1 report and will continue to engage on Phase 2 of STPR2, which is expected to be published later this year.

A meeting specifically to discuss the south suburban line is in the process of being arranged with Network Rail and Transport Scotland in response to the [Coalition Motion](#), approved at Transport and Environment Committee on 19 February.

**Supplementary Question**

Thank you Lord Provost, thank you for the response. My question was quite specifically and very pointedly about the passenger service on the south suburban railway. The responses that we have are about general interaction with the Regional Working Group and Transport Scotland rather than the South Sub itself otherwise why would the Convener have brought an emergency motion to the Transport and Environment Committee meeting on the 19th February. Be that as it may, does the Convener now agree that full consideration will be given to the use of the South Sub for passenger services and that that is necessary consideration going forward?



**Supplementary  
Answer**

The reason I brought forward an emergency motion was in order to respond to a clear desire that emerged through the consultation that the Edinburgh South Sub was a good idea to follow up and it was quite clear that what I wanted to do was to raise its profile within the city mobility plan. However what I will commit to is essentially the spirit of what's contained in the city mobility plan which is about network partnership. We need to, this is not a decision for the Council alone, and I will repeat that, it is not a decision for the Council alone, it's for Network Rail, it's for the Scottish Government, there are number different partners in it, so I cannot commit to the kind of work that would commit those organisations to coming in on work like that in this context. What I can commit to is the fact that the officers have enshrined it within the city mobility plan and as demonstrated by the last of the answers that are provided for you there is considerable work going on since that commitment through Transport and Environment Committee to further the conversation in the way that you've described, so that's what I can commit to, further work on it.

**QUESTION NO 8**

**Question** (1) In terms of the Council's existing Housing Revenue Account stock, how many of the 20,000 new homes planned by 2027 are to replace existing units?

**Answer** (1) The 20,000 new homes will be developed by the Council, Registered Social Landlords (RSLs) and private developers.

There are currently no planned demolitions, other than 21 homes at Coatfield Lane. Further disposals or demolitions may be required if it is not technically or financially feasible to bring them up to standards. The HRA Business Plan includes an assumption that up to 400 may be disposed off or demolished by 2027. This will be subject to annual update as part of the business plan process.

**Question** (2) Can a brief explanation be given for the most likely reasons that existing units will need to be replaced by 2027?

**Answer** (2) In the past homes have been replaced if they form part of wider area regeneration or where it is not financially viable or technically feasible for them to meet housing standards.

Any proposal to demolish homes in the future would be informed by up-to-date stock condition information, together with an assessment of required investment to bring the them up to required energy efficiency standards, including net zero carbon and the economic viability of the required investment.

**Question** (3) How many Council Houses were let to tenants on:

a) 1<sup>st</sup> January 2017?

b) 1<sup>st</sup> January 2021?

**Answer** (3) There are no figures currently available for the number of Council homes let to tenants on 1 January 2017. The information that is available sets out overall Council social housing stock available to let at the end of the financial year for comparison nearest to the requested dates.

2016/17- 19,709\*

2020/21 –20,194 (projected)

**Question** (4) How many Council Houses would the Convener anticipate being let to tenants on:

a) 1<sup>st</sup> January 2023?

b) 1<sup>st</sup> January 2028?

**Answer** (4) The future tenancy figures are based on projected Council social housing stock as at the end of the financial year nearest to the requested dates.

2022/23 – 20,729

2027/28 – 24,200

**QUESTION NO 9**

Please could the Convener confirm:

**Question** (1) The total number of comments received by Spaces for People in relation to the Queensferry Road/A90 scheme during the feedback window.

**Answer** (1) 36 separate comments. However, some comments had more than one query/response required.

**Question** (2) The total number of comments received by Spaces for People in relation to the closure of the junction at Clarendon Crescent, Oxford Terrace, and Learmonth Terrace.

Of these,

a) How many supported the closure?

b) How many did not support the closure?

**Answer** (2) a) 4 comments supported the closure

b) 25 comments did not support the closure

**Question** (3) What consideration was given to footway build-outs at the junction of Orchard Drive and Queensferry Road?

**Answer** (3) Protected footway build-outs were considered at the junction of Orchard Drive and Queensferry Road during the design development stage. However, due to the location of a number of driveways at this location and the temporary measures available to the Spaces for People programme it was not possible to bring forward improvements at this location.

Officers are currently investigating if an un-protected hatched solution can be delivered that would help to visual narrow the junction and slow traffic which would make this junction safer for pedestrians and cyclists.

- Question** (4) When a full summary of feedback on the Queensferry Road/A90 scheme will be distributed to Ward councillors, Transport spokespeople, and stakeholders?
- Answer** (4) It is hoped that the summary of feedback will be circulated by the end of this week.
- Supplementary Question** Thank you Lord Provost and could I thank the Convener for her answer and as well actually for accepting my amending of the typo, she responded very quickly and was very gracious in accepting. So just in relation to answers 1 and 2, 80% of responses were about this one junction and 86% of those, were opposed, so could the Convener please clarify if she is or is not listening to the wishes of residents when responding to these schemes?
- Supplementary Answer** One thing which officers have told me is that a number of the comments that came in relating to the Oxford Terrace closure, they've not dismissed the proposal completely, so there was work to be done and I know that certainly three Council responses suggest a slightly revised layout and officers looked at that and came to the conclusion that it wouldn't work because there were some aspects to it that would not give the safest option for pedestrians, many of whom of course will be local residents. The question about resident responses on these Council schemes is actually quite a difficult one because we very much welcome the input from residents in terms of shaping this, we've seen, all over the city we've seen schemes and designs we've put in and have then subsequently changed because we had input either from residents or from businesses I can quote you half a dozen examples of those easily off the top of my head and I know that the spaces for people team have gone to strenuous efforts to try to accommodate some of the most obvious changes that are required, you can see that on for example on Lanark Road, reinstatement of parking for example, specifically to suit the needs of some of the businesses that are there, there have been various other pieces around Morningside Road where we've made changes as well, but it may not be all of the changes that people are looking for but they are some of the changes and

that's in order to keep the integrity of the scheme to deliver what it should be doing but also to meet the needs of local residents so that's what I am committed to, the try then modify process that we've gone through on this set of temporary measures and then see how we can accommodate that as we move into any permanent measures which we decide, democratically decide as a council to retain, thank you.

**QUESTION NO 10**

**By Councillor Webber for answer by the Convener of the Transport and Environment Committee at a meeting of the Council on 11 March 2021**

Can the Convener please indicate the following given that the report provided to Governance, Risk and Best Value Committee does not provide the data:

**Question**            **(1)** How many open road repair issues are there across the city in TOTAL as of 28 Feb 2021?

- a) By Ward or postal code if not possible
- b) When were they logged? (date)
- c) How were the logged? (eg Online, email, elected member)
- d) What is the mean time for an initial repair?
- e) What is the median time for an initial repair?
- f) What is the mode time for an initial repair?

**Answer**            **(1)** a) Tables 1 and 2 below show the number of open road repairs at 3 March 2021, for category 1, 2, 3 and 4 defects.

b) Table 3 shows the date and time that each open defect was logged.

c) The data source does not currently exist to enable this information to be provided. It should also be noted that the defects represented in the data provided come from both enquiries from members of the public as well as from the team of Roads Officers on programmed inspection routes who inspect the city's roads all year round. All enquiries are logged on the Confirm system.

d - f) Table 4 below provides this information by defect category due to the different response time targets.

- Question**            **(2)** What proportion of completed repairs present for re-repairs in TOTAL and then...?
- a)     What is the mean time for re-repair to present itself?
  - b)     What is the median time for a re-repair to present?
  - c)     What is the mode time for a re-repair to present?
  - d)     What is the mean time for re-repair to be repaired?
  - e)     What is the median time for a re-repair to be repaired?
  - f)     What is the mode time for a re-repair to be repaired?

**Answer**            **(2)** This information is not currently held on the Council's Asset Management System. However, the Council has recently invested in additional software to enable spatial analysis of defect history alongside network inspection and survey information. This will help to identify areas of multiple/repeat defects.

- Question**            **(3)** In relation to the TOTAL number of repairs required for each original issue reported:
- a)     What is the mean number of repairs carried out for each original open issue?
  - b)     What is the median number of repairs carried out for each original open issue?
  - c)     What is the mode number of repairs carried out for each original open issue?

**Answer**            **(3)** See response to Question 2.

- Question**            **(4)** How long is it anticipated it will take to carry out ALL the open repairs / re-repairs?



**Answer**

- (4) In line with response to Q1 d – f, it would take on average approximately two weeks to make safe the defects that are currently on the list (prioritised within their categories). However, in this two-week period, a number of new defects will be added to the live list from new enquiries and officer inspections and these would need to be prioritised accordingly and would subsequently influence decision making

**Supplementary Question**

Thank you Lord Provost and thank you Convener for your answer. I suppose I am a bit disappointed that we don't have the information to my questions on the total re-repair costs, the number of visits etc and you do make reference to there being a new system coming on line Councillor Macinnes so I'm at wondering what timeline we can expect that because after all that will be key to us evaluating total value for money for council and every pound that we spend and to go back to an old adage "A stitch in time does save nine", so I am so looking for a little bit more information around when that management system might be up and running, thanks Convener and Lord Provost rather, sorry.

**Supplementary Answer**

I will have to come back to you on the matter of the timescales attached to that new system coming in, it's clearly an operational matter so I'll ensure that that is circulated to both yourself and to the other members of the Transport Committee so that they understand that too since this is very heavily a transport issue. I would however in providing the answer to you, I would however draw your attention to table 4, because actually what that indicates quite clearly is that in the categorisation of defects on the road we have a range of 1 to 4 and there is a statutory obligation on us to repair those either as a temporary repair or as a permanent repair within a certain number of days and table 4 indicates quite clearly that we are hitting those deadlines and then some. So for example, for category 4 there's a 60 day turnaround on some of these and we're turning those on an average of approximately 9 days to fulfil those, the same thing goes for the more urgent end of the range of defects and how we deal with those and so table 4 is the one I would suggest most people take a look at to see

the real efforts that are being made to try to keep the road defects down as much as possible, try to provide temporary repairs where there is quite clearly a danger to, for example vulnerable road users on bikes or by foot and I think the team are to be congratulated on that. We have clearly seen a major deterioration in the roads following the winter weather, the extended winter weather period and the team are working as hard as they can to fulfil the requirements that have emerged out of that period and I expect to see further progress on that, thank you.

**Question**

Since the council set its budget on 18 February 2021, additional funding from the Scottish Government is expected to be available for use in 2021-22.

Can the Convener detail:

- a) the level of funding expected;
- b) how the funding will be matched to council priorities;  
and
- c) the process by which decisions over the additional funding will be made.

**Answer**

- a) The Revenue Budget Update report considered by the Finance and Resources Committee on 4 March 2021 provided, in Paragraphs 4.10 and 4.14 to 4.16, details of a number of recently announced funding streams, some of which are available for use in 2021/22. These sums comprise a combination of funding with specific corresponding additional expenditure liabilities and general funding available for allocation in accordance with the Council's own priorities.

The latter category includes £275m of non-recurring additional COVID funding, including for lost income, where, following consideration by COSLA Leaders on 26 February, Edinburgh's anticipated share is around £33.6m. While being provided in 2020/21, this sum may be carried forward to be offset against pressures in 2021/22. This sum is in addition to £259m of non-recurring COVID-related funding included within the Local Government Finance Settlement, Edinburgh's anticipated allocation of which is £20.5m. This funding is being held as a contingency against pressures in excess of the level of provision contained within the budget framework in 2021/22 and future years.

Following the announcement by the UK Government of £1.1 billion of additional COVID-related Barnett Consequentials

for Scotland on 15 February, the Cabinet Secretary for Finance confirmed on 16 February that an element of these sums would be allocated for additional investment in 2021/22 for mental health (£120m), affordable housing (£120m), low-income support (£100m) and pupil catch-up (£60m). At this stage, however, further details of these funding streams and any associated distribution amongst authorities are awaited.

The precise level of resources available to the Council may also be influenced by consideration of the Scottish and UK Budget announcements. No additional resources were introduced at Stage One of the Scottish Budget Parliamentary debate, although there remains the potential for changes to emerge prior to the Stage Three debate on 9 March. This debate may in turn be influenced by the announcement, on 3 March, of the UK Budget, which intimated the availability of £1.2 billion of Barnett Consequentials in 2021/22 compared to the £0.5 billion assumed in setting the Scottish Government's budget

- b) Taking due account of monies being provided in respect of COVID-related impacts, officers will develop proposals for consideration aligned, in the first instance, to the principles and priorities set out within the Council's Business Plan. These proposals will then be brought forward for consideration by all members as noted in the response below.
- c) Given the complexity of the funding landscape, a further Members' Briefing will be circulated following the Stage Three debate on 9 March, with the intention that a more detailed update and associated recommendations then be brought back Committee on 20 May for members' consideration. This timescale will allow for a more informed assessment of the pandemic's on-going impacts based on available information as that time.

Thank you Lord Provost, just one point of clarification please. The Convener will acknowledge that the level of resources after our own budget is set is significantly greater than has been the case before, all be it it's one year only in unique circumstances of the pandemic, but that being the case, does he recognise some of the compelling arguments put forward by the Edinburgh Climate Commission for

accelerated investment in green recovery this year ahead of COP26 in Glasgow and will he welcome spending before those to invest that green recovery?

  - b) the rigorous academic process used when considering which sites should be included?
  - c) the professional standing, it terms of the study of Scottish history, of the authors?
- Answer** (2) See answer 1.
- Question** (3) What action would the Leader like to see regarding
- a) Bute House?
  - b) the Burns Monument?
  - c) any other site named in the Sunday Telegraph article?
- Answer** (3) The Review Group has been tasked to consider all options and responses available to redress this legacy, including the removal or re-interpretation of features.
- A set of recommendations, featuring both short- and long-

term measures addressing how aspects of the public realm which perpetuated racism and oppression in the past can be re-configured, will be produced as part of the Review Group work. The Independent Chair will report publicly on the Review's findings.

This legacy is still having an impact in perpetuating and validating racism in modern day Edinburgh and deserves to be treated with more seriousness and sensitivity than this line of questioning.

**Question**

What is the status of the project to develop a walking/cycling route along the old Powderhall Railway initiated by a motion by myself and Councillor Rae to the North East Locality Committee 18th Feb 2018?

**Answer**

Council officers, with support from Sustrans, are in the process of finalising a feasibility study that will form the basis of land acquisition discussions with Network Rail and other third parties, with the aim of constructing a desirable green active corridor on as much of the Powderhall spur line as possible. This corridor would extend the North Edinburgh Path Network and help to link communities and new developments in the east of the city.

Officers are aware that Network Rail currently has a sidings lease in place with a freight operator for the former Powderhall Waste Transfer facility which requires the spur line to be maintained as operational.

Following the completion of the feasibility study, the next stage of the project will require further engagement with Network Rail and the freight operator to confirm that the lease can be terminated and the land acquired.

Once the Council has established confidence regarding land negotiations required to deliver the green corridor (or coherent elements of it) further design and investigative work can then be commissioned.

I am very pleased to see this project is moving on, obviously land ownership issues are complex and necessarily slow everything down, but there doesn't seem to be even an estimated timeline given with this, I understand estimated timelines will be just that and could change, but is there any sort of timeline that goes along with these actions?

**QUESTION NO 15**

**Question** (1) Given the strategic importance of the ETRO/SFP retention survey and the scale of the number of schemes it relates to (around 120) which means the outcome will shape decision making impacting nearly everyone in Edinburgh directly or indirectly, what pre-testing of the survey was carried out and what was the scale and profile of the test sample?

**Answer** (1) Given the timescale for development and delivery of the engagement, it was not possible to pre-test the survey. The questionnaire was developed in discussion between officers in Place and the Council's Strategy and Insight team and approved via the Spaces for People Board. The questionnaire seeks to enable people to express support or opposition to retaining some or all of the measures introduced, or being introduced, under Spaces for People, to comment on individual measures and to give views on both the advantages and disadvantages of retaining the interventions.

**Question** (2) Specifically, what was the methodology used to ensure bias was removed and questions were structured to support ease of comprehension across residents and businesses

**Answer** (2) Answers enable respondents to express either support or opposition in equal measure. They also enable people to list both benefits and disadvantages of measures, including the ability to mention benefits and disadvantages not listed in the questionnaire. In drawing up lists of benefits and disadvantages for consideration by respondents, consideration was given to comments that have been made on SfP measures whilst they have been in place.

**Question** (3) How was sampling for this pre-testing undertaken for all resident groups in Edinburgh according to age, location, mobility, socio-economic group, road user groups etc?



- Answer** (3) See answer to question 1. Measures, for example social media posts, radio adverts and on street advertising, are being taken to raise awareness of the current engagement and to encourage participation by residents from across the city. In addition to the consultation questionnaire, a parallel piece of Market Research is being carried out behalf of the Council. This will seek to achieve responses from a representative cross section of Edinburgh's population.
- Question** (4) How was the sampling for pre-testing of the business survey undertaken e.g. by business sector, size etc?
- Answer** (4) See answer to question 1. Various measures are being taken to encourage responses from businesses across the city, including contacting via relevant businesses associations as well as promotion via on street adverts, social media posts etc as mentioned above.
- Question** (5) Who carried out this pre-testing and how was it reported?
- Answer** (5) As noted in the answer to question 1, it was not possible to carry out pre-testing of the questionnaire.
- Supplementary Question** Thank you Lord Provost and thanks again to the Convener for her answer. A fundamental flaw is the survey assumes knowledge, people are telepathically supposed to know our plans that have not been published. I see at point 1 of the answers it states, "Given the timescale for development and delivery of the engagement, it was not possible to pre-test the survey.", yet the Convener has shown that the consultation time-limit can now be extended by 3 weeks. Does the Convener accept that by pre-testing which I understand is the norm of such a survey could have been done at the outset within two weeks?
- Supplementary Answer** I hear of many different ways in which we can approach the question of survey and consultation and so it's not necessarily the norm for this particular type of consultation which is different. Commissions surveys tend to have major resources attached to it which would allow for pre-testing of the survey, consultations tend to be centred around our own staff. As is the case with many of the council surveys, not specific to this one, officers from the relevant service work with colleagues from Strategy and Insight in order to

develop the approach and the questions for the survey and that was done very carefully this time in order to ensure that there was a really bias free set of questions despite what some people out in the communities are saying, it gave people an opportunity to say yea or nae on particular projects, it gave people the opportunity to provide comment and it also provided an opportunity for people to provide the overview of the Spaces for People process as well. So I would argue that it would have been very difficult for us to find another format that would not have fallen into the bias category and we were working strenuously to ensure that that was not the case. So the survey itself was signed off by the Spaces for People Programme Board after all of that consideration, so I do somewhat resent the tone that you introduce in your first few sentences Councillor Rust about how people expect to be telepathic, we run an enormous number of consultations and surveys out of this Council, many more than other local authorities and we do across a whole range of topics and each and every time the effort is made by officers to try to reach as many people as possible but there will always be a limit to that, there's been a limit to people's interest in terms of responding and there'll be a limit to how well we can reach people. We're doing the best we can with that and that's the case for this topic and the other consultation surveys. So I think that is something that's worth bearing in mind as we go through this next stage.

**Question** (1) As regards the Tram Extension to Newhaven, have there been any changes to the contract since award?

**Answer** (1) Aside from changes in the ordinary course of contract management, there have been three changes:

MOV1

Deferred the date on which Professional Indemnity insurance and performance bond would be required to align with programme; and

Removed certain contractor risk costs from the Council's payment should Notice to Proceed not have been given – this has since fallen away as the Council has issued Notice to Proceed.

MOV 2

Amended the end date from 1 February 2023 to 17 March 2023 to reflect the end date agreed at the end of the Early Contractor Involvement (ECI) period;

Amended the delay damages payable to reflect the construction phasing agreed during the ECI period; and

In the Siemens sub-contract that was attached to the Infrastructure and Systems Contractor (ISC) contract, the requirement to pay an incentive payment to Siemens was removed.

MOV 3

Amendment to payment of Siemens' pain share so that the Council will bear the cost of overruns 50/50 with Siemens (as opposed to 25% the Council, 25% ISC and 50% Siemens) up to 120%.

**Question** (2) If so, what were the changes and how were they reported to Committee or Council for scrutiny?

**Answer** (2) Changes were as noted above. They were approved in accordance with the Contract Standing Orders and by the Project Board, and reported to the Finance and Risk Group for the project.

**Supplementary Question** Thank you Lord Provost and I thank you Convener for the answer. There may well be very good reasons why this contract has been changed, it may well have been the right thing to do but does the Convener not agree with me that it would be useful if councillors could be scrutinising these kind of changes to understand what they mean and what the impact could be?

**Supplementary Answer** Thank you for the question Councillor Johnson. There is a very well established democratically decided process of scrutiny attached to the tram programme, there has been a number of features that have been put into that scrutiny process, to use a broad term, that should give us a degree of security, so for example, there's an agile audit going on all the time on the tram, marked contrast to the previous tram project, there are internal officer checks that are going on, there's all sorts of work between the Tram Team and the contractor's and in addition to which we also have what I think is quite a well informed all party oversight group, not a decision making environment but it does give people who have an interest to transport and through local area interest, an opportunity to really drill down into some of these and there have been questions of a similar nature to the ones that you've brought forward that have been aired before in that forum, so I'm confident that there isn't a requirement at this stage to make the change to the way in which it was set out for scrutiny and verification, the way it was set out under the full business case at this point. Clearly there is always a requirement to keep a close eye on what's happening around this tram extension project at this point, I'm comfortable with the level of scrutiny that's going on at the moment, we have seen no major issues emerge at this point, thank you.

**QUESTION NO 17**

**By Councillor Whyte for answer by the Leader of the Council at a meeting of the Council on 11 March 2021**

Following a Council Question in 2018 the Leader set up a formal “annual” appraisal process for the Chief Executive.

**Question**           **(1)** Given the Council has a policy of formal annual appraisal process (Annual Performance Conversation) can the Leader outline why he has only ever ensured that one such process has been undertaken for the Chief Executive since he became Council leader in 2017

**Answer**           **(1)** The last 360 review took place in Spring 2019. In Spring 2020, when the next scheduled review would have taken place, the Chief Executive was focused on dealing with the consequences of a global pandemic for both the Council and the City, including the Council’s statutory responsibilities arising from the Civil Contingencies Act and providing direct leadership of the Council’s Incident Management Team, which continues to operate now. In addition, given the Chief Executive’s experience he was rightly supporting national response activities, working with the Scottish Government and other agencies on behalf of SOLACE Scotland. While the demands on the Chief Executive have been unique this year, the approach adopted is consistent with other officers through the pandemic.

**(2)** Can the Leader explain why, given the Chief Executive works for and reports to the whole Council as a corporate body, the results of that process and input to future objectives was not shared with the Leaders of all political groups on the Council as had been practice for previous Chief Executives?

**(2)** The process agreed upon for the last review did not include this action, this process included Councillor Whyte’s participation in the 360 review. I have no record of Councillor Whyte asking for this to be done at any point.

**(3)** Can the Leader describe the objectives set for the Chief Executive and explain how he intends that these are overseen by the whole Council

- (3) These were based on the feedback and themes of the 360 review, facilitated by the Local Government Association, and in relation to wider Council performance. It would go against any sense of good governance to have 63 elected members trying to line manage the Chief Executive. Councillors should however use the Council's annual performance reporting to carry out their responsibilities of holding officers, including the Chief Executive, to account.

To repeat a part of my answer to Councillor Whyte from November 2018 "the Chief Executive is uniquely accountable to the whole Council, in its capacity as employer, **through the Leader of the Council**" which is the normal approach in local government.

- (4) Can the Leader explain whether any of the areas for action/improvement mirrored those from the Best Value Audit of the Council, what action he took as Leader to seek improvement in these areas prior to that audit?
- (4) There is a difference between the Chief Executive's personal performance conversation, (which is split into 4 themes and 24 competencies) and the policies, practices and strategies of the Council. There are clear synergies between the Council's previously approved business plan (reported to Council annually), the review of competencies and the Best Value Assurance Review outcomes
- (5) Will the Leader indicate the process he intends to take forward in future to ensure a formal annual appraisal for the Chief Executive?
- (5) This will follow the same 360 review process during 2021, when appropriate to do and subject to the availability of the Local Government Association's facilitators.

Question**

Thank you Lord Provost. The Council Leader reminds us in answer to Question that what he says, that the Chief Executive is uniquely accountable to the whole Council in its

capacity as employer through the Leader of the Council, now Lord Provost notwithstanding that previous Chief Executives were accountable through the Group Leaders meeting to undertake their appraisal, it's interesting that the Council Leader has taken this on himself. Given that, then he must therefore be accountable to the whole Council for this process, can he tell us how many full appraisals the Chief Executive has had since joining us in 2015, some 6 years ago and whether the Chief Executive currently has a set of objectives and how as Council Leader he is going to demonstrate to the Council that these are relevant and valid in current circumstances and being monitored?

Thank you, a couple of questions in there that I'll try and work through. As I've made clear, yes the Chief Executive is effectively, line managed would probably be a strong word, but through the Council Leader. I'm not entirely sure what Councillor Whyte expects in terms of the process, but to have an individual person's criteria and everything else going to account I don't think would be appropriate at all. I made clear in Answer 3 or Answer 2, let me just find it, I think Answer 3, that members who are looking for that should look corporately, it is not for, I don't think, the Council to scrutinise one individual's performance in that way, I do not think that is good governance at all, if you had a Board of a company that was anywhere near the size of ours it would be done by a committee. Now Councillor Whyte says quite clearly that before it was done by the Group leaders, however I do note that Councillor Whyte wasn't Group Leader before I became Council Leader and I wasn't Group Leader before I became Council Leader, so in terms of the practice before that, I don't think either of us can speak with authority as to how that was done, you would have to write to the Chief Executive for that.
