In its consideration of items 1 and 2 below the Board deliberations were broadcast using the Council's webcast system. A copy of the webcast can be viewed <u>here</u>.

1. Convenor's Update

Meeting with Licensing Forum – noted that the first joint meeting between the board and the Licensing Forum had been held. While it had been difficult to find a consensus view on some key issues the meeting had generally been successful. The Youth Forum confirmed that it was happy to engage in policy development.

2. Minutes of meeting of 29th May 2023 and matters arising

The minutes and the decision list for applications considered at the meeting of 29th May 2023 were approved.

Councillor Booth noted that the minutes did not set out whether there had been discussion at the meeting about webcasting future meetings. Councillor Young confirmed that no such discussion had taken place but that she had asked officers to take a preliminary step of contacting individuals who had made objections or representations at past meetings and seeking an informal view as to whether their interaction with the Board meeting would have been different if they had been advised that the meeting would be webcast.

3. Premises Licence Review Hearing – 58 Lochend Road South

The depute clerk referred to the Board's decision that a review hearing should take place in relation to the premises licence for 58 Lochend Road South following a request for a review hearing from Police Scotland.

The Board considered a preliminary representation from the agent instructed by the licence holder. He submitted that the matter set out in the police representation was *sub judice* and that neither he nor the police representative could therefore go into any details in making their case to the Board. There was currently no court date set for proceedings against the licence holder.

The Board agreed to continue the matter until the Procurator Fiscal had indicated whether or not criminal proceeding would go ahead.

APPLICATIONS TO EXTEND PROVISIONAL PREMISES LICENCES

1. Purpose

1.1 To ask the Board to consider applications to extend the duration of provisional premises licences.

2. Main Report

- 2.1. A number of requests for extension of provisional premises licences have been received.
- 2.2. A provisional premises licences is granted for a period of four years from the date of issue of the licence. If not confirmed before the end of the provisional period, the licence is revoked. Confirmation is obtained upon receipt by the Licensing Board of clear <u>Section 50</u> certificates (Planning, Building Standards and, where necessary, Food Hygiene).
- 2.3. A provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.4. In granting such an extension, the Board must be satisfied in terms of <u>Section 45(8)</u> of the 2005 Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.4 Details of premises for which requests have been made are provided below, with expiry details.

3. Recommendation

3.1 In the event the Board is satisfied with the reasons given, the Board is asked to reach a decision on the duration of any extension of the provisional premises licence for each of the requests.

PREMISES LICENCE REVIEW HEARING – THE WOODHALL ARMS, 135-137 LANARK ROAD WEST, EDINBURGH

1. Purpose

- 1.1 To advise the Board of the premises licence review application for the Woodhall Arms, 135 Lanark Road West, Edinburgh, on which the Board previously agreed to hold a hearing.
- 1.2 To advise the Board of a request from the licence holder's agent for adjournment of the review hearing.
- 1.3 To set out the options available to the Board, in the event it decides to proceed with the hearing.

2. Main Report

- 2.1. The grounds for review of a premises licence are as set out in <u>section</u> 36(3):-
 - (a) that one or more of the licensing conditions has been breached;
 - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or
 - (c) any other ground relevant to the licensing objectives
- 2.2. A review application was submitted by MBM Commercial LLP, legal agents for neighbours of the Woodhall Arms premises. The initial application consisted of a letter and supporting documents as listed at para 4.1 below. The applicants' agents have submitted further detailed documentation, photographs and video footage in support of the application. This was received earlier in July. It was only possible to forward this material on to the agent for the licence holder on 21st July 2023.
- 2.3. The premises licence holder is Punch Partnerships (PTL) Limited. The company holds a significant number of premises licences and is noted as having been bought by Star Pubs & Bars Limited. They are represented by Janet Hood.
- 2.4. The Council's LSOs prepared a report on the terms of the review application. When the Board gave initial consideration to the review application at its meeting on 27 February it agreed to ask Police Scotland to consider reporting on the review application. The police have provided reports for the Board's consideration.
- 2.5. The licence holder's agent has submitted a request for the review hearing to be adjourned to a later date. This has been communicated to the agents for the applicants, who have advised they oppose adjournment. The Board will therefore have to decide whether or not to adjourn the hearing.
- 2.6. In the event the Board decides to proceed with the hearing, the Board should first hear from the review applicant and then from the LSO representative. The Board would then hear from Police Scotland and finally from the licence holder or their agent in response. At the

conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-

- (a) issue a written warning;
- (b) make a variation of the licence;
- (c) suspend the licence for such period as the Board may determine;
- (d) revoke the licence.

3. Recommendation

- 3.1 The Board is required:-
 - (a) To consider the request for adjournment of the review hearing to a later date and, if agreed, to set that date;
 - (b) In the event it decides not to adjourn, to proceed with a premises licence review hearing;
 - (c) To decide at the conclusion of the hearing what action requires to be taken, having regard to the licensing objectives;

1. Purpose

- 1.1 To advise the Board of the premises licence review application for the Mousetrap, 180 Leith Walk, on which the Board previously agreed to hold a hearing.
- 1.2 To set out the options available to the Board, in the event it decides to proceed with the hearing.

2. Main Report

- 2.1. The grounds for review of a premises licence are as set out in <u>section</u> <u>36(3)</u>:-
 - (a) that one or more of the licensing conditions has been breached;
 - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or(c) any other ground relevant to the licensing objectives
- 2.2. The application was submitted by Police Scotland. The premises licence holder is Star Pubs & Bars Limited. A copy of the review application was sent to the premises licence holder. The Council's LSOs were asked to prepare a report on the terms of the review application and this was also provided to the licence holder's agent.
- 2.3. The Board agreed at its meeting on 29 May to schedule the review hearing for its meeting in August. The agent for the licence holder has confirmed their readiness for the hearing proceeding at an earlier date and will be in attendance at the meeting with a representative of the licence holder.
- 2.4. Police and Licensing Standards have been informed of the possibility of the hearing proceeding one month earlier, and both have provided update reports for the Board's consideration, copied to the licence holder's agent.
- 2.5. If the Board decides to proceed with the review hearing, the Board should first hear from Police Scotland as applicant, then from the LSO Manager. The Board would then hear from the licence holder's agent in response. At the conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-
 - (a) issue a written warning;
 - (b) make a variation of the licence;
 - (c) suspend the licence for such period as the Board may determine;
 - (d) revoke the licence.

3. Recommendation

3.1 The Board is required:-
