### 1. Welcome and Introductions

The Convener welcomed everyone to the first meeting of the Consultative Committee with Parents (CCWP) under the newly appointed Council administration at the Local Government elections in May 2022.

The CCWP would be an important consultation forum and critical friend to allow elected members and Council officers an opportunity to engage and discuss with the parent/carer body a whole range of education business across the school estate.

## 2. CCWP Membership and Remit

The CCWP membership and remit agreed by the Education, Children and Families Committee in August 2022 was presented for noting.

The principle aim of the committee would be to provide a collaborative, solution-oriented discussion and consultation space with parents and carers on local and national issues.

The following issues were raised and discussed:

- Voting rights for parent/carer representatives on the Education, Children and Families Committee and the rationale for these representatives not having voting rights on that Committee
- It was noted that parent representative did have voting rights in past political administrations but these had been removed in 2017 by the previous Council Administration taking into account relevant legal advice from officers
- Parents/carers expressed strong views that the parent/carer representatives voting rights should be reinstated in line with the three religious representatives on the Education, Children and Families Committee
- It would be useful to find out from other local authorities if parent/carer representatives were afforded voting rights on Education Committees

### Decision

- 1) To note the CCWP membership and remit.
- 2) To note there was an outstanding action for the Council to consider voting rights for religious representatives on the Education, Children and Families Committee.
- 3) To note that the Political Management Arrangements report was scheduled to be submitted to the Council meeting in December 2022 for consideration.

## 3. Appointment of Parent Representatives to the Education, Children and Families Committee

Nominations were sought to appoint a parent/carer representative to the Education, Children and Families Committee.

### Decision

- 1) To agree that Alex Ramage be nominated as the parent/carer representative on the Education, Children and Families Committee to represent the secondary sector

- 2) To note that two expressions of interest had been received for the proposed additional second parent/carer representative on the Education, Children and Families Committee, subject to full Council agreeing in December 2022 that a second position be added to the membership as part of the political management arrangements report.
- 3) To note that officers would request biographies from the two parents/carers and have informal discussions about taking on the role on a shared basis.

#### 4. Briefing on the National Discussion Consultation

Stephen Kelly, Senior Education Manager delivered a presentation on the Scottish Government's reform of Scotland's education system which included:

- A national discussion on education
- An independent review of qualifications and assessments
- Reforming educating bodies the Scottish Qualifications Authority and Education Scotland Scotland – merging the curriculum and assessment function and removing inspection from Education Scotland
- Post-school education and training

Included within the consultation was a specific discussion guide to gather the views of young children.

#### **Decision**

To note updates in the presentation (slide pack attached at the appendix to this minute).

#### 5. Parent/Carer Representatives on the City of Edinburgh Placing in Schools Appeal Committee

An update was provided on the membership of the City of Edinburgh Placing in Schools Appeal Committee. There was a shortage of parent representatives on the Committee which was impacting appeals being able to be scheduled within a reasonable timescale. The Council's communications team had carried out a recruitment campaign which had resulted in multiple hits on social media but only a handful of notes of interest.

A review of the admissions and appeals process was being undertaken with a report planned to be submitted to a future meeting of the Education, Children and Families Committee.

#### **Decision**

To note the position.

## 6. Update from Connect

Patrick McGlinchey from Connect shared the following updates:

- Connect's aims were to unleash every child's potential with healthy home/school relationships and they provided support to parent/carer groups in communities and encouraged educators to embrace effective parental engagement
- Connect's vision was children at the centre and parents by their side
- Membership had increased and Connect now had members in every local authority in Scotland with 27 out of the 32 local authorities having full members
- Connect offered support and communicated with parents and parent groups Monday to Friday via email, phone and social media
- The Connect closed Facebook group was available to all parents, as a helpful site for parents for sharing ideas and information
- Training and information sessions were offered to all parent groups eg. UNCRC and grant funding
- Survey ongoing at this time is on parental engagement and the role of parents on committees and if they should have voting rights
- Advocacy work which provides an independent voice for parents nationally

Naomi Barton shared the following update on behalf of the National Parent Forum:

- NPF work in partnership with Connect most recently the work around the national discussion which closed on 5 December 2022
- NPF are made up of volunteers representing the voice of parents/carers nationally
- The NPF Vice-Chair role was vacant and expressions of interest to fill this role would be welcome via the NPF email [edinburgh@npf.org.uk](mailto:edinburgh@npf.org.uk)
- Increase in mental health issues were being addressed with Scottish Government
- Independent Review of National Qualifications which closed on 16 December 2022

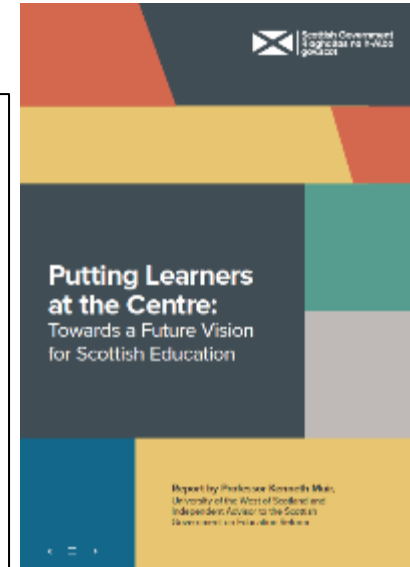
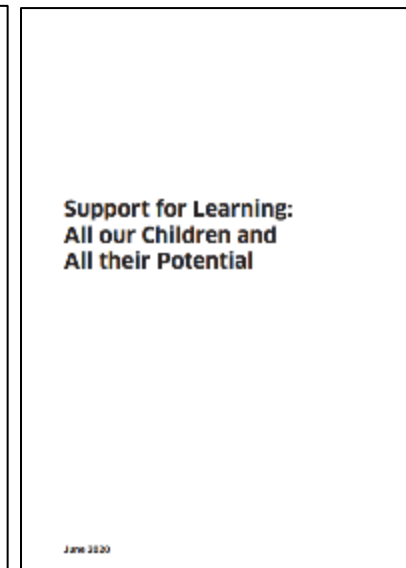
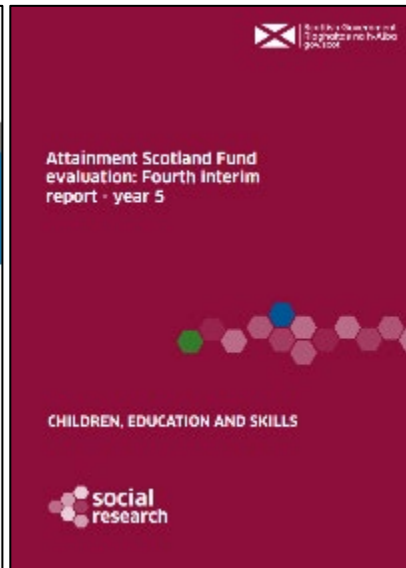
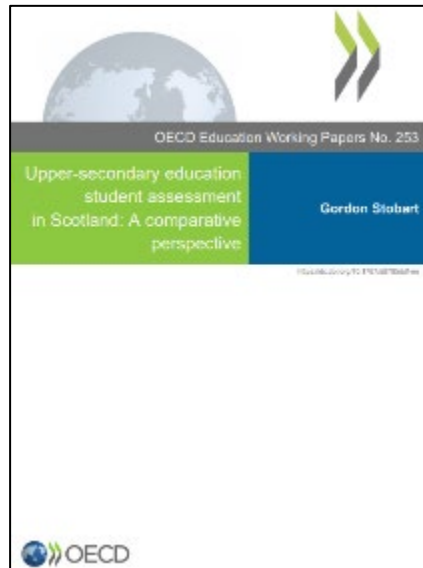
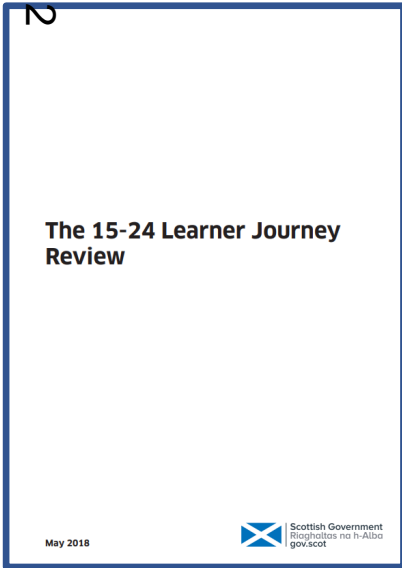
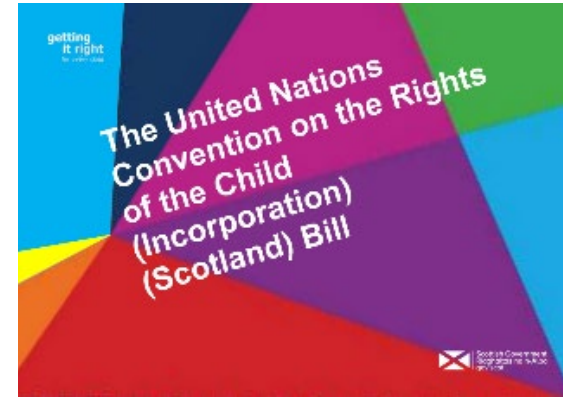
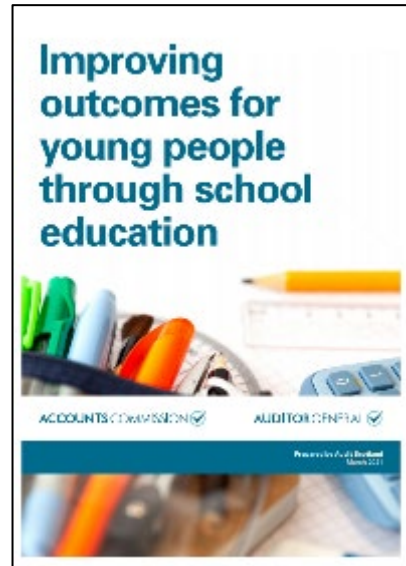
# OUTCOMES OF REFORM VISION FOR EDUCATION IN SCOTLAND

Our overall vision for the education system in Scotland is rooted in achieving excellence and equity for all learners, within a framework of human rights (including children’s rights). The 2022 National Improvement Framework and Improvement Plan includes this vision, which is:

**Excellence** through raising attainment and improving outcomes: ensuring every child achieves the highest standards in literacy and numeracy, as well as the knowledge and skills necessary to shape their future as successful learners, confident individuals, responsible citizens, and effective contributors

Achieving **equity**: ensuring every child has the same opportunity to succeed, no matter their background or shared protected characteristics, with a particular focus on closing the poverty related attainment gap.

We are developing a programme of reform to make specific changes that will take us towards this vision. We will strive to create coherence across our work and that of colleagues in the early years, tertiary and skills sectors, for the benefit of all of our stakeholders.
