1. Deputations

a) Citadel Youth Centre

(in-relation to item 7.14 – Whole Family Wellbeing Fund, Edinburgh 2024-26 Grant Programme)

The deputation requested that council grants processes be re-considered to ensure that there is transparency of decision making. They felt that recommendations should be made publicly available in advance of elected members making decisions. The deputation noted that in 2016 and 2020 recommendations for third party grants to third sector organisations had been made publicly available prior to final decisions being taken by Committee. It was noted that prior to the decisions regarding Connected Communities Grants on 18 December 2023, there had been no public papers published with grant recommendations and that a public list had not been made available subsequently. The deputation noted that they would anticipate any future grants rounds, including this fund would be considered in a transparent way.

b) Edinburgh EIS

(in-relation to item 7.4 – Education Budget)

The deputation noted that the Education service area receives the most money in the budget. They felt education was an investment in the future. They requested that members do not cut the education budget further. EIS research showed 73% of teachers reported the constant stress, 57% absence for mental health increase. The deputation noted an increase in young people with additional support needs. It was noted that parent councils have been echoing what the schools and headteachers have been saying. Taking a further 8.2 million would be completely detrimental to our

education system. The deputation noted that there are instances of teachers having buying pens, snacks, materials with their own money. The deputation noted the potential impact of cuts on already deprived communities.

c) Trinity Primary School Parent Council

(Written Deputation in-relation to item 7.4 – Education Budget)

The challenges facing society today were well documented. The deputation noted that we are living in an era of low economic productivity and extensive global competition, with an ageing population that will require increasing levels of support to sustain and care for it.

In order to address these issues, they felt we need to be investing in education. Schools are supposed to be the places that support learners and their families, overcome differences in experience, aspiration and opportunity and equip all learners with the knowledge and skills that they need to become productive members of society. The deputation asked that members reflect on the following

1. Agree that you will do everything in your powers to ensure that the Council Gets It Right For Every Child. Ideally this will mean increasing funding from current levels to adequately deliver the service that is required, and certainly not imposing further cuts.
2. Consider whether there are other areas of council spending where cuts would have a smaller economic or social impact than in education, and prioritise these. Not all cuts in expenditure are equal in impact and to target a service that is time-limited and delivering a universal human right will do considerable harm. The Education Committee could send a strong signal here by encouraging this approach.
3. Pause any proposals to allow for proper consultation with parents and, fundamentally, with your own teaching and support staff.

d) Steading Owners Association – Kirkliston

(Written Deputation in-relation to item 6.1 – Business Bulletin, Statutory School Consultation Update)

The deputation sought to summarise the timeline of consideration of options for secondary school provision in the Kirkliston area and represent the views of local residents in the Steading Owners Association. The deputation felt that more could have been done by the council to ensure participation of local residents in the Statutory Consultation process during October 2023. The deputation noted that the site of the current Kirkliston Leisure Centre was the only council-controlled site available to build a new secondary school and brought forward considerations in relation to other potential sites.

e) Bruntsfield Primary School Parent Council

(in-relation to item 7.4 – Education Budget)

The deputation noted that budget cuts for teaching and support staff reductions is detrimental to classroom management. These were significantly more disproportionate to the vulnerable and disadvantaged. Cuts had the potential to reduce the imagination and the opportunities that can be built into school. Putting extra stress on those delivering the learning as well as the standard of learning. Schools can only do less with less, the gaps being filled by parents which is not sustainable as a long-term solution. The deputation noted that this was only going to get worse if the proposed budgets are approved.

f) Stockbridge Primary School Parent Council

(Written Deputation in-relation to item 7.4 – Education Budget)

The Parent Council recognised the pressure the Committee is under to find savings. they noted that this report does little robust assessment or analysis of the impact of these cuts. It also makes broad assumptions about schools' abilities to absorb further cuts on the back of an already-stretched service. they highlighted four concerns in particular. In doing so we share examples from our school of the impact cuts to the DSM can have.

1. Cutting teaching and support staff
2. Additional needs are not being met
3. Child Protection and Health and Safety
4. Impacts on Leadership

g) Royal High School Parent Council

(Written Deputation in-relation to item 7.4 – Education Budget)

The deputation noted that the report proposes a 1.2% cut to the school budget which we expect to be prorated across schools, with the Royal High School potentially being impacted by a larger cut given it is not protected in relation to the deprivation criteria. Therefore, they wished to formally log their concerns with the Education Budget proposal. Their main concerns are the following.

- Cutting teaching and support staff
- Additional needs not being met
- Impacts on leadership

The deputation requested members reflect on the proposals regarding:

1. 'Getting it right for every child'. This proposal does not. Funding levels need to,

quite simply increase

2. Opportunities to explore other areas to reduce spending. Why focus on a cohort of society who will support our aging population? This proposal is short-sighted and ill thought out.
3. Support a democratic, structured consultation with the right bodies – parents, teachers and educational professionals.

7. Quality Improvement and Scrutiny Update

This report covered a range of Education Scotland scrutiny and Local Authority reviews undertaken by the Quality Improvement Service. The relentless focus of the work of the Quality Improvement Service is to raise standards in our schools. Our model of proportionate support meant that Intensive support is provided to the schools who need it most (Priority Schools). This was informed by the information held in the Capacity & Risk Register which relates to levels of attainment, schools' self-evaluation data, information gathered through scrutiny activity and leadership capacity. Schools that were in receipt of intensive support access high quality professional learning,

provided by the Edinburgh Learns Teaching and Learning Team, on a priority basis. This professional learning has been designed to develop a highly skilled workforce of teachers and practitioners who deliver high quality learning experiences consistently. Where concerns were identified, our model of intensive support has been shown to be highly effective, resulting in improvements in learners' attainment and in quality indicator evaluations.

The Edinburgh Learns Teaching, Learning & Assessment and Improving Quality in Learning Boards, have clear action plans to address areas for improvement and to share examples of strong practice. We continued to incorporate learning from scrutiny activity to strengthen models of support and challenge to raise standards to improve outcomes for learners. Progress with identified areas for improvement is tracked rigorously, on a weekly basis, by Quality Improvement Officers and is shared with the Education Senior Leadership Team monthly. This ensured actions for improvement are met within agreed timescales.

8. Education Budget

Almost one third of the city's budget was used to provide education for children and young people (£350m), with most of that being controlled at school level through the Devolved School Management process. DSM is a regulated process with guidelines as to decisions are taken, and a Board that oversees these. The council have forecast budget gap of £50.5m next financial year and this report provided detail of how £8.2m could be met through savings applied to DSM. A Budget Reference Group consisting of officers, and Headteachers from all sectors was consulted to shape proposals.

Within Education, in common with most other areas of the council, the biggest element of funding meets staffing costs, with the other budget lines for resources and curriculum forming a smaller portion. It is therefore unavoidable that funding cuts will have an impact on staffing groups. It should be noted however that due to rising rolls in Edinburgh and ongoing demographic investment we will continue to maintain overall numbers in compliance with the Scottish Government's commitments to teacher and support staff.

During COVID, additional non-recurring funding was distributed to support COVID recovery. These funds were distributed via DSM to provide additional teachers and support workers. The funds were then confirmed as recurring and part of the overall budget. It was predominantly these funds that have been identified for efficiencies, though the impact of COVID is noted to persist.

Decision

To note the proposed options put forward but are unhappy recommending options that reduce Education budgets, in particular DSM at option 5. Our recommendation is for referral of this paper to the Full Council for consideration but to look to mitigate the cuts identified as options 1-5, with one-off funding options as identified by the Convenor of Finance & Resources. These would mitigate against the 2024/25 budget year.

9. Whole Family Wellbeing Fund (Edinburgh) 2024-2026: Grants Programme

This report detailed how the Edinburgh Children's Partnership proposes to distribute

the Scottish Government Whole Family Wellbeing Fund for the financial years 2024/25 and 2025/26. This was for the figure of £5.2m as a two-year grant and a further one-year fund distribution for 2025/26 which is dependent on further Scottish Government payments.

The funds should assist local Children's Services Planning Partnerships (CSPP) with the commissioning and establishment of holistic whole family wellbeing supports or services in line with the Scottish Government framework. These services should be an upscaling of existing transformational practice in order to build capacity for whole system transformational change required to reduce the need for crisis intervention shift investment towards prevention and early intervention.

As a requirement for this funding, Scottish Government directed that 'Decision making in relation to this funding is expected to be in accordance with the collective agreement and direction of the local CSPP, with accountability resting with each strategic Children's Services Planning governance forum'.

10. Hong Kong Scotland Improvement Partnership (HKSSIP)

This report provided information about opportunities for Edinburgh secondary schools to develop partnerships with schools in Hong Kong. The programme was devised by Archie McGlynn, former Chief Inspector of Schools in Scotland. On retiral from HMIE, Archie took up a post in the Ministry of Education in Hong Kong and developed a quality improvement framework based on How Good is Our School. In 2016 Archie and three Edinburgh schools (Boroughmuir, James Gillespie's and the Royal High School) formed an international collaboration between Scotland and Hong Kong on school improvement. The programme ran until the pandemic with visits from Hong Kong Schools to Edinburgh on 3 occasions and 1 visit of Edinburgh Schools to Hong Kong (fully funded by the Swire Chinese Language Centre Edinburgh). All the Hong Kong schools are state run schools.

11. Unaccompanied Asylum-Seeking Children

An increase in Unaccompanied Asylum-Seeking Children (UASCs), through spontaneous arrivals and the National Transfer Scheme (NTS) created unprecedented demand on social work, accommodation, and support services. This is not matched by additionality of resource. This unpredictable demand had left young people of 16 plus years being placed in residential and homeless accommodation.

This approach risked the unintended consequence of displacing Edinburgh's young people to out of area placements, when local accommodation options are at capacity. Service delivery is being reviewed to consider how best, to offset the need for emergency responses leading to high-level and costly packages of residential care. Any strategy needed to embrace the needs of all children and young people as belonging to Edinburgh and having equality and rights at the fore.

12. The Early Years Service

The Scottish Government committed to deliver an increase in funded Early Learning and Childcare from 600 hours to 1140 hours for every child aged 3-4 years and Eligible 2 year-olds to address poverty and to enable parents into work and training. The Local Authority successfully planned and implemented this strategy within the agreed budget and continues to deliver a high-quality service. Since 2020, there had been an increase from 35% to 42% of families accessing their funded provision via Partner Provider Nurseries despite a decline in the quality of provision; the increased number of children equates to a significant cost increase from the central budget.

The Scottish Government reviewed its grant funding for Edinburgh ELC from £46.4m

in 2021-23 to £41.3m in 2022-23 and then reduced again to £40.4m in 2023-24. The overall reduction of £6m is therefore a major budget pressure. To continue to deliver a high-quality service, we need to reshape the model of delivery for ELC.

Phase 2 focused on the Leadership of Literacy, identified through fieldwork evidence from Phase 1, which highlighted a gap in the strategic direction and overview of the learning, teaching, and assessment of Literacy.

The current Integrated Literacy Strategy was written in 2018. Evidence from both phases of the review had supported the direction and content of a new Integrated Literacy Strategy to be implemented from 2024. This strategy was designed to raise attainment in literacy across our schools and outlines key actions to be taken at local authority, learning community and school levels.

It should be noted that the new Integrated Literacy Strategy linked directly with our Digital Learning Strategy to ensure that developments in Digital practice enhance approaches to teaching, learning and assessment.

22. Inclusion in City of Edinburgh Schools – Annual Report 2023

In the City of Edinburgh Council schools there are currently 45.9% (n=24,760) children and young people recorded as having an additional support need. Additional support needs are recorded as 10% higher in the secondary sector than the primary sector. The percentage of pupils with additional support needs is relatively high compared to national figures and those of other Local Authorities and work is taking place to fully understand this situation.

Following the National Review of Inclusion in 2022, Edinburgh undertook a Collaborative Learning Review into approaches to Inclusion. This included Senior Education Managers, Education Scotland and colleagues from the Association of Directors of Education. This review found that the city's vision for inclusion was current and clear and that there was a comparatively high level of resource available.

The review made a number of recommendations for improvement that the Inclusion Review Programme is addressing.

The Inclusion Review Programme has 4 current workstreams. Recommendations that arise as part of this Programme of work will be brought before Elected Members for approval as required.

A number of key actions are noted that will be the focus for improvement activities over the next 12-months and beyond that will aim to strength inclusive practice across the learning estate and ensure the needs of our learners with additional support needs continue to be met.

Our evaluation of Stretch Aims (targets to close the poverty related attainment gap - Appendix 1) indicates that there is progress in the closing of the poverty-related attainment gap. New Stretch Aims have been set for 2023-2026 and these relate to core measures determined by Scottish Government and core plus measures identified by the local authority.

 - 5) To note that in terms of climate and nature emergency implications, Committee understands we have a duty to promote access to fair work in Edinburgh that aligns with our approach to a just transition to green jobs as a preventative action against unemployment.
 - 6) To request that the Children, Education and Justice Services department engage with colleagues in Sustainable Development to align work around 'positive destinations' to the objectives of the Council's climate strategies, and that this should involve engagement with and learning from Capital City Partnership and officers involved in the redrafting of its Service Level Agreement with the Council, following the decision at Housing, Homelessness and Fair Work committee in October 2023 to develop a new workstream / programme within that SLA to focus on green skills.
 - 7) To understand the development of a more inclusive labour market that equally benefits people in Q1 through to Q5 and aligns with our Climate Strategy 2030, requests a report in 3 cycles that includes:
 - a) How the Council engages in the Facing up to Poverty in Schools Practice Network
 - b) Explicitly how poverty manifests as barriers to education and leaving education.
 - c) How we ensure young people in 'high deprivation' areas are supported to access Fair Work that provides enough to live on.
 - d) How we ensure a focus on green skill opportunities and apprenticeships when considering leavers' destination.
