1. Welcome and Introductions

The Convener welcomed everyone to the meeting of the Consultative Committee with Parents (CCwP).

2. Note of the Meeting

Decision

To approve the note of the meeting of the Consultative Committee with Parents of 8 November 2022 as a correct record.

3. Directors Update

The Executive Director of Education, Children and Families gave an update on the recruitment of the Service Director for Education. This would be a new post for the directorate, which would cover education and wider achievement.

The post had gone out to advert, with a wide recruitment search taking place, and final interviews coming to an end. The post would be selected through an Elected Member recruitment panel, with recommendations being made to the City of Edinburgh on 9 February 2023.

4. Update from Connect Representative

Patrick McGlinchey from Connect shared the following updates:

- Since August 2022, Connect had ran 14 live information sessions for parents, which received great feedback.
- A further 16 sessions were scheduled on a wide range of topics, available to all members of parent forums and parent councils.
- There was continued work on the review of assessment qualification, in partnership with the National Parent Forum for Scotland, and leading collaborative communities for parents and carers.
- A focus group with parents of children with additional support needs (ASN) provided detail that flexibility and creativity were both needed in order to make suitable ASN adaptations in order to put the child at the centre.
- Connect had ran a consultation on the state of parental engagement, which fed into the national discussion.
- Connect, along with other aspects of Scottish education, were entering a phase of review. Looking into what their service offers, their value for money to local authorities and parent councils, what they provide vs what is expected from them etc.

5. Vaping Issues

Janice Watson, Quality Improvement Officer delivered a presentation on vaping issues which detailed:

- Figures from the Health and Well Being (HWB) Census, which asked 'How often do you use e-cigarettes/vape at present?' that of 4691 responses, around 400 pupils or 9% of S2 and S4 respondents had used an e-cigarette/vape.
- The latest national (UK) data showed the proportion of children vaping had risen from 4% in 2020 to 7% in 2022.
- The HWB curriculum supports children and young people to assess and manage risk around topics such as vaping and explains the impact this can have on children and young people health.
- Resources such as ASH Scotland and I Am Me Scotland Learning Platform are signposted to primary and secondary pupils to support this aspect of the curriculum.

Jackie Reid, Acting Senior Education Manager delivered a presentation on Edinburgh Learns which included:

- The vision of Edinburgh Learns for Life is to create a fairer, healthier, greener future for everyone, where learning for life happens at home, in school, in the wider community, and in the workplace.
- 3 main objectives of the business plan; Climate Justice, Social Justice and Wellbeing.
- Offering members of the CCwP to take up a position on the Edinburgh Learns for Life boards, explaining the variety and function of the 16 boards.

- NPF collaborated with Police Scotland and Education Scotland to create a Cyber Resilience First Aid Box for parents and carers (<https://www.cbrfa.com>)
- As part of the national discussion, NPF had engaged with parents and carers and passed on their views to the Scottish Government.

- Entering into the third stage of the independent review of the national qualification and assessment. As part of NPF, engaging with parents and carers to hear their views.
- NPF are supporting the National Qualification Working Group and support for parents and carers during the exam period.
- NPF are gathering reactions from parents and carers on their responses to strike action.

Vaping – update 19.1.23

Background

- A paper on vaping in schools was prepared by a group of Parent Council members
- We are aware that vaping is becoming an issue in schools with some evidence suggesting young people are vaping in class, corridors and in school toilets.
- Vaping is not for children. While it can help people give up smoking, the advice is, if you don't smoke don't vape.
- Most children who try vaping, have also tried smoking, and vaping is far less harmful than smoking, which kills up to two thirds of smokers.
- Vaping is not permitted in Council premises. It is illegal for young people under 18 to buy vapes or for someone to buy a vape for a young person under 18.
- Currently we do not have a consistent policy on vaping in our schools.

Data - CEC

The HWB Census administered last session asked the following question to S2 and S4 pupils;

How often do you use e-cigarettes/vape at present?

4691 responses were given to this question across the city.

Around 400 pupils, or 9%, of S2 and S4 respondents had used an e-cigarette/vape. This was 6% in S2 and 13% in S4.

Data – National

- The latest national (UK) data shows the proportion of children vaping is rising, up from 4% in 2020 to 7% in 2022, alongside the growing popularity of disposable vapes.
- The number of children who admit to ever trying vaping has risen from 14% in 2020 to 16% in 2022. However, the vast majority of under 18s who have never smoked, have also never vaped, and only 1.9% have vaped more frequently than once or twice.

HWB Curriculum

Supports children and young people to assess and manage risk, to understand about topics such as vaping and any impacts on health. It also supports them to access practical and emotional help. Specifically, children and young people learn the following in relation to substance misuse;

- The impact of substances on health - positive and negative and legal implications(E – 4th level)
- Pressures (peer/culture/media) and substance use (2nd - 4th level)
- The impact of substances on behaviour and decision making (2nd – 4th level)
- Assessing and managing risk in relation to substance use (2nd – 4th level)
- The impact of substance use on health (2nd – 4th level)



The lead for this resource is to present at the next Primary HWB Network meeting. This will then enable us to update our HWB Early to Second Level progression frameworks to include this resource.

NHS Support

Robbie Preece, Health Improvement Lead Tobacco Control, NHS Lothian


NHS Lothian agree that vaping is not for children, but that as a public health approach, it is supporting the reduction of combustible nicotine use which is the number one cause of ill health in the UK. In terms of risk-taking behaviour, vaping is considerably less harmful than other behaviours young people experiment with, therefore a proportionate approach to this issue is advised.

A careful selection of resources are advised to ensure a balanced approach to the curriculum. ASH Scotland (as opposed to ASH) resources are considered to be slightly out of sync with academic research.

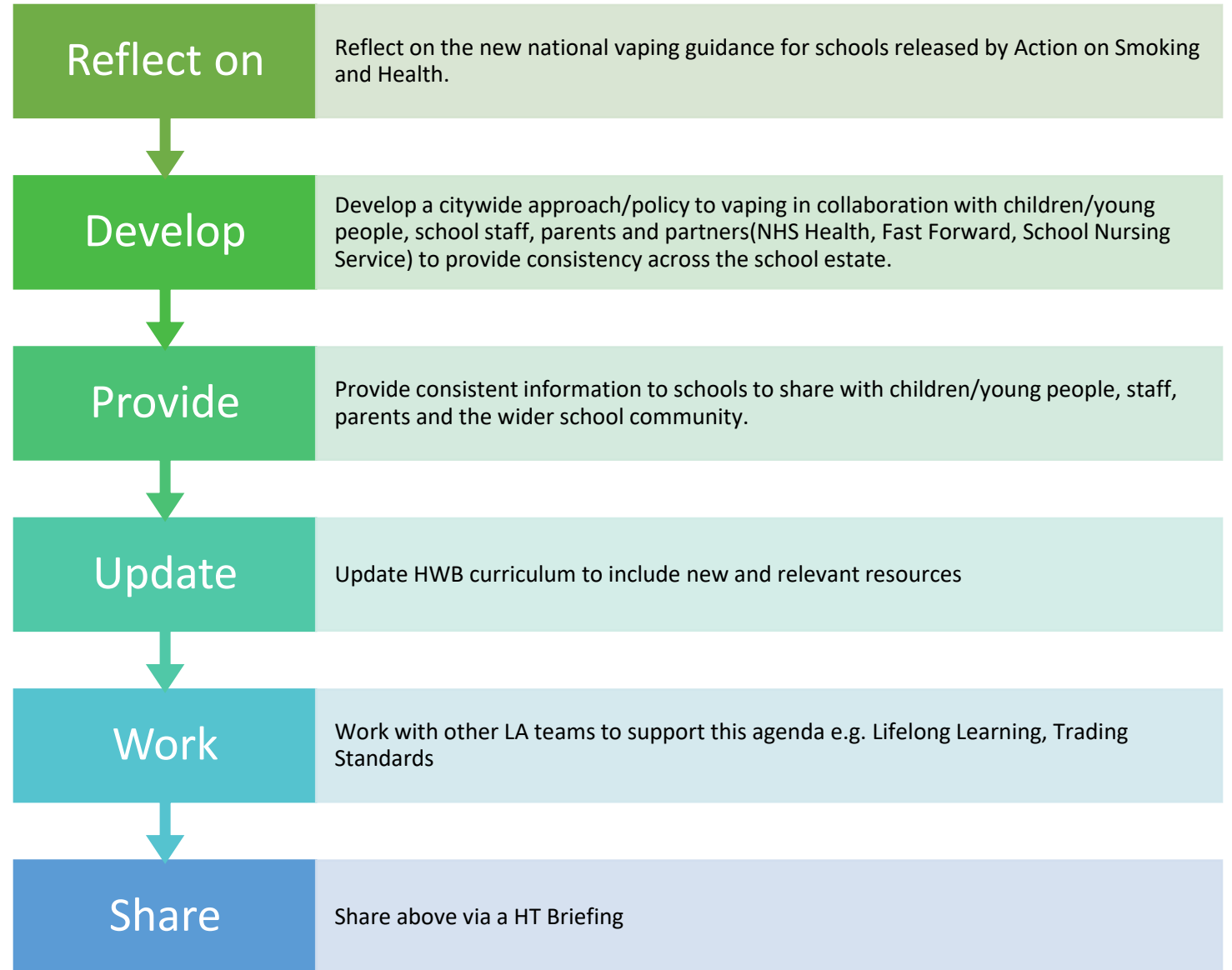

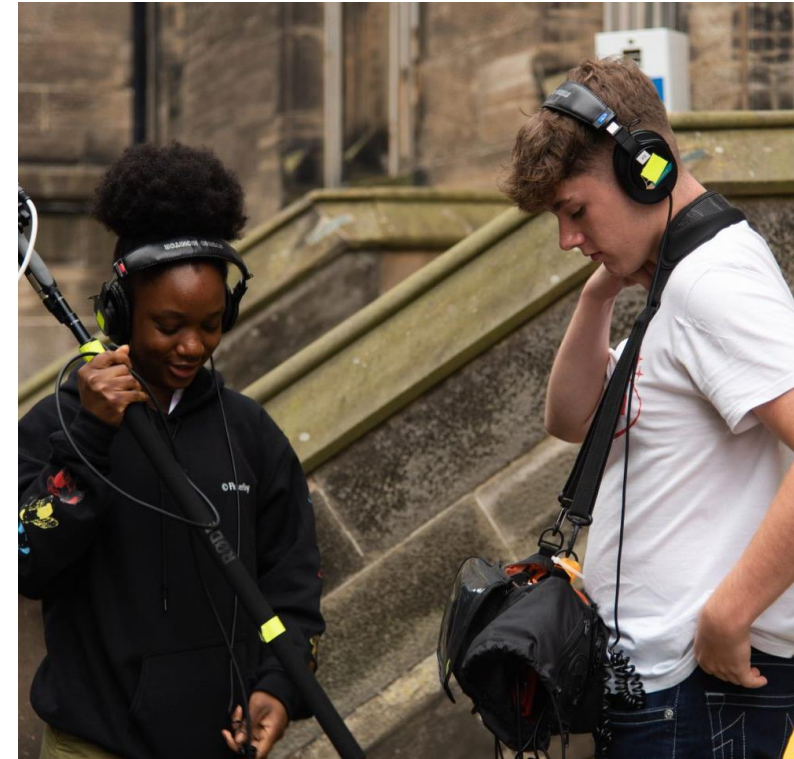

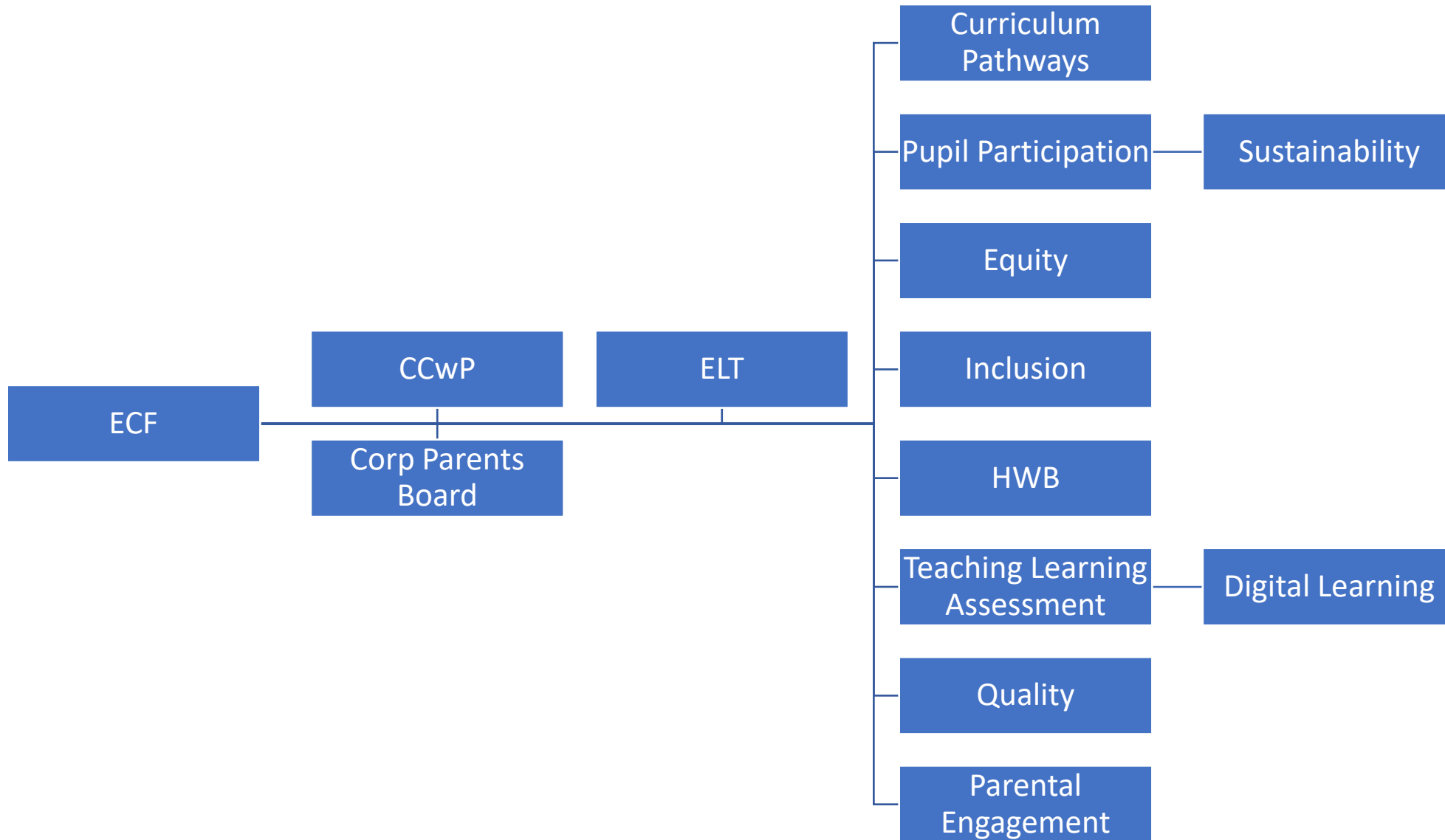
