## Housing, Homelessness and Fair Work Committee

10.00am, Tuesday, 8 August 2023

### Present

### 1. Deputations

#### Living Rent Lochend Branch

**(in relation to Item 16 – Motion by Councillor Caldwell – Geographic spread of Council Housing in SHIP, Acquisitions & Disposals)**

The deputation highlighted the issue of empty homes across the city. There were currently 1,453 empty homes across the city, 638 of which were located in the northeast of the city. This meant that 1 in 4 council homes in Edinburgh were currently unoccupied. Currently there were 23,000 people on the waiting list to be housed in social accommodation, with many being told it could be up to 15 years before they are housed. Currently £30m in rent was being lost due to empty homes.

The deputation argued that this was caused by the outsourcing of the voids team to the private sector. Lack of social housing had caused huge expenditure on temporary accommodation, which the landlords and B&B's were profiting from. Temporary accommodation was not a fix as people needed somewhere to call their home and that is why the social housing stock needed to be brought back into permanent use.

Living Rent stated that private companies had no interest in providing quality accommodation for the people of Edinburgh or bringing empty homes back into social housing stock and were only interested in profit. The dangers of this could be demonstrated in examples such as the tragedy of the Grenfell Tower disaster.

The SHR required all social landlords to prepare and publish an Annual Assurance Statement and Assurance Statement Summary of Compliance to confirm to their tenants and the SHR that they were meeting the requirements of the Regulatory Framework.

## 10. Affordable Childcare for Working Parents

---

An update was provided on the delivery of the current model for the Affordable Childcare for Working Parents service, sources of childcare support and a proposal for a future delivery model which included supporting eligible parents to access Universal Credit and supporting childcare providers to operate sustainable business models to ensure the availability of childcare for working parents in areas of deprivation.

## 11. Mapping of Existing Provision and Stage 1 NOLB Co-Production

Notes;

- 1) The importance of residents being able to live in Council housing in communities of their choice, i.e., where they have local ties.

- 3) Recent planned major Council housebuilding programmes are located exclusively in the Northwest and Southwest localities, with the Northeast and Southeast localities' affordable housing projects primarily being Housing Association (HA) or Mid-Market Rents (MMR), supplemented by Private Sector Leading (PSL) under Scottish Short Secure Tenancy (SSST).
- 4) That PSL, HA and MMR have a key role to play in Edinburgh's housing mix, as does long-term Council-owned property.

Therefore requests;

- 5) An Acquisition and Disposals update on the business bulletin, within 3 cycles which includes an updated figure of the disposals and acquisitions since the scheme's inception, broken down by ward, and how disposals in these two localities are being offset by Acquisitions in the same localities.
- 6) An update to efforts being made to build new Council Housing in the Northeast and Southeast localities to be included in the next Strategic Housing Investment Plan Report."

### **Amendment 1**

Deletes paragraph 4) of the motion by Councillor Caldwell and replaces with:

- 4) That whilst the Council currently relies on Private Sector Leasing (PSL) and Mid-Market Rental (MMR) properties to fulfil its statutory obligations in terms of housing and homelessness, the long-term ambition of the Council should be to reduce this reliance and drastically increase the number of socially rented homes with genuinely affordable tenancies, and not to facilitate growth in an already bloated private sector market through PSL, or to prioritise provision of MMR properties which are still unaffordable and restrictive for many people.

### **Amendment 2**

Deletes paragraphs 1 to 4 of the motion by Councillor Caldwell and replaces with:

- 1) That geographic location of Council owned HRA properties is subject to a complex mix of historic variables and is never likely to be evenly spread particularly where this is assessed by Council Wards which are subject to regular boundary changes over time.

- 2) That Council housing is only one element of social housing provision and often RSLs can provide more appropriate and locally focussed provision for specific neighbourhoods such as through housing cooperatives.

- 5) To note that whilst the Council currently relied on Private Sector Leasing (PSL) and Mid-Market Rental (MMR) properties to fulfil its statutory obligations in terms of housing and homelessness, the long-term ambition of the Council should be to reduce this reliance and drastically increase the number of socially rented homes with genuinely affordable tenancies, and not to facilitate growth in an already bloated private sector market through PSL, or to prioritise provision of MMR properties which were still unaffordable and restrictive for many people.
- 6) To request an Acquisition and Disposals update on the business bulletin, within 3 cycles which included an updated figure of the disposals and acquisitions since the scheme's inception, broken down by ward, and how disposals in these two localities were being offset by Acquisitions in the same localities.
- 7) To request an update to efforts being made to build new Council Housing in the Northeast and Southeast localities to be included in the next Strategic Housing Investment Plan Report.
