REPORT - SCHEDULE OF MEETINGS - 2020/21

1. Purpose

- 2.2. The Edinburgh Licensing Board has previously agreed rules for its meetings, setting the frequency of meetings (monthly) and generally on the last Monday in each month other than during holiday months, particularly July and December.
- 2.3. To ensure a co-ordination between meeting dates scheduled for the Licensing Board and the City of Edinburgh Council and its committees, dates of meetings are agreed annually, several months in advance. A suggested draft schedule of meetings dates for the 2020/21 period is attached. The Board meeting dates have been extracted from that and are set out in the rules below.
- 2.4. The schedule does not include specific provision for additional Board meetings, such as the requirement to hold a joint meeting with the Licensing Forum.
- 2.5. Details of the dates agreed by the Board will be communicated to the Council to ensure the Council calendar is up to date. The Council calendar is due to be finalised in February 2020. Details of meeting dates will also be published online, to ensure that all interested parties are aware of arrangements for Board meetings.

1.1 To ask the Board to consider an application to extend the provisional period for a provisional premises licence.

2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If it is not confirmed before the end of the provisional period, the licence is revoked, by operation of law. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, if appropriate, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting such an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.4 An application has been made to extend the provisional period for the premises at 57-59 High Street, Edinburgh. The licence was issued by the Board on 24th August 2015 and was due to expire on 24th August 2019. The Board agreed to an application to extend the provisional period at its July 2019 meeting, to 24th February 2020.
- 2.5 The provisional premises licence is for the operation of a premises described as retail premises located on the ground floor, forming part of a previously larger retail outlet extending to the first floor, on the Royal Mile.

3. Recommendation

PREMISES LICENCE REVIEWS - NON-PAYMENT OF ANNUAL PREMISES LICENCE FEES - 2019/20

1. Purpose

- 1.1 To advise the Board of details of premises, where annual fees for the period 2019/20 remain outstanding.
- 1.2 To ask the Board to agree in each case to schedule hearings for review of the premises licences.

2. Main Report

- 2.1. Premises licence holders are required to make payment of annual fees on or around 1st October every year, in terms of the Licensing (Fees) (Scotland) Regulations 2007. The fees require to be paid by licence holders in advance of the following licensing year.
- 2.2. Failure to pay fees is a breach of the mandatory conditions of licence. Breach of conditions is a ground for review of a premises licence. Details of premises where fees remain outstanding for the period 2019/20, having become due from 1st October 2019, are set out in the appendix attached to this report. Premises licence holders have been written to on several occasions, to advise them of the requirement for outstanding fees to be paid.
- 2.3. In addition, the Council's LSOs have visited premises, issuing Compliance Notices requiring compliance with the mandatory conditions of licence, i.e. payment of the fees.
- 2.4. Where the Board considers matters relevant to the grounds for review have been set out, it may make review proposals, leading to the requirement for review hearings to be held. On the basis that the fees remain outstanding for the premises listed, the Board is asked to agree that the information provided about each premises is relevant for review of the premises licences, and that review hearings should be scheduled for future meetings.

3. Recommendation

- 3.1 The Board is asked:-
 - (a) to note the details of the premises where annual fees remain outstanding and to agree that matters relevant to the grounds for review of the premises licences have been set out; and
 - (b) to schedule hearings in respect of the premises licences.

PREMISES LICENCE REVIEW HEARING - THE VILLAGE, 16 SOUTH FORT STREET, EDINBURGH

1. Purpose

- 1.1 To advise the Board of the requirement to hold a hearing on a premises licence review application for the premises at 16 South Fort Street, Edinburgh.
- 1.2 To set out the options available to the Board, if it considers it necessary for the purposes of the licensing objectives to take any action with the premises licence.

2. Main Report

- The grounds for review of a premises licence are:-
 - (a) that one or more of the licensing conditions has been breached;
 - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or
 - (c) any other ground relevant to the licensing objectives:-
 - preventing crime and disorder.
 - securing public safety,
 - preventing public nuisance.
 - protecting and improving public health, and
 - protecting children and young persons from harm.
- 2.2. The Board may reject an application for review if it is considered that it is vexatious or frivolous, or that it fails to disclose matters relevant to the statutory grounds for review. The Board's Statement of Licensing Policy provides that this decision may be taken by the Convener. He noted the details of the review application and agreed that the application should be reported to the Board for a premises licence review hearing.
- 2.3. The application has been submitted by the Council's LSOs, for the premises known as The Village. The premises licence holder is DHPC Limited, its registered office being the premises address. The company was dissolved in 2014. The premises have continued to operate, managed by Dean Conway, holder of a personal licence issued by the Board and a director of the dissolved company.
- 2.4. In carrying out a review hearing, the Board should hear from the applicant and then hear from the Licence holder or their representative in response. As the licence holder is a corporate body, having been dissolved, the Board may wish to hear from Mr Conway, the premises manager. At the conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-
 - (a) issue a written warning;
 - (b) make a variation of the licence;
 - (c) suspend the licence for such period as the Board may determine:
 - (d) revoke the licence.

- 2.5. If in the course of a hearing the Board makes a finding that any personal licence holder who is or was working in the premises has acted in a manner which is considered to be inconsistent with any one or more of the licensing objectives, the Board must hold a hearing on the personal licence. The LSO application suggests that the Board hold a separate hearing on Mr Conway's personal licence.
- 2.6. If the Board ultimately decided not to take any action on the review application, there would still be a requirement to consider what action to take, in view of the fact that the licence is presently held in the name of a company which has been dissolved. The Act makes no specific provision for this scenario, but without a licence holder in place it is no longer possible for the licence to be transferred or varied. This presents problems for the future operation of the premises.
- 2.7. It is suggested that this in itself may provide grounds in terms of the licensing objectives for review of the premises licence, necessitating action in terms of paragraph 2.4 above.

3. Recommendation

- 3.1 The Board is required:-
 - (a) to hold a premises licence review hearing;
 - (b) to decide at the conclusion of the hearing what action requires to be taken, having regard to the licensing objectives;
 - (c) in the event it makes a finding that Mr Conway has acted in a manner inconsistent with the licensing objectives, to hold a separate hearing on his personal licence.
