Present

1. Deputations

(a) Deputation – Central Taxis (in relation to items 2, 3 and 4)

The deputation highlighted the increases to expenditure to the taxi trade that had been caused by the emission and age restriction policy implemented by the City of Edinburgh Council (CEC). They were keen to see further increases to the fare scale to reflect these extra costs as well as to reflect inflationary increases. It was felt that there was a lack of analysis that led to the recommendations by Jacobs in the Taxi Fares Review 2019/20 report.

The increased drop off and pick up charges implemented by Edinburgh Airport were stressed as a significant issue as they could not fully be reclaimed by the trade. The deputation expressed a desire to be able to recover the full costs of these charges.

The deputation also expressed concerns regarding the resourcing of the enforcement officers as it was felt that more could be done to deter private hire car drivers from illegally taking jobs that were not pre-booked. They also highlighted the difference in the price of fees between taxi licences and private hire licences and felt that enforcement should reflect those costs.

(b) Deputation – Unite the Union Edinburgh Cab Branch (in relation to items 2 and 3)

The deputation highlighted the strain put upon the taxi trade due to the number of licensed private hire vehicles and that the current enforcement strategy required to be improved to reflect this. Concerns were raised regarding private hire car drivers failing to adhere to regulations. The deputation requested that the surplus for taxi licence fees be put towards prioritising and funding a 24-hour enforcement service.



It was also raised that the festive tariff provided no incentive for taxi drivers to work during Christmas. When surveyed 65% of members of the Unite the Union Edinburgh Cab Branch said it would not be financially viable to work this period if there was no increase to the tariff.

The deputation also requested the ability to fully reimburse the cost of charges by Edinburgh Airport.

(c) Deputation – Edinburgh City Private Hire Ltd (in relation to item 3)

The deputation commended officers for the work done on the report. It was felt, however, that there had been a misinterpretation of the work ethic and attitude of private hire car drivers reflected in the statistics of the report and that this misinformation needed to be addressed. The deputation requested that the discussion around private hires was rooted in the factual evidence provided by the report and not on what they saw as conjecture that had been perpetuated in public forums.

The deputation stressed that both taxi and private hire drivers needed to work to improve the relations between the trades.

2. Taxi Fares Review 2019/2020

Information was provided on the outcome of the statutory review of taxi fares carried out on behalf of the Council by Jacobs consultants. Consultation with the taxi trade had also been undertaken.

The consultants' report set out recommendations on the remaining steps necessary to complete the review and fix taxi fares.

Liz Richardson from Jacobs gave a presentation to the Committee on the results from the consultation report.

8. Taxi Stance Appointment – St Andrew Square

The City of Edinburgh Council, as Licensing Authority, was required to appoint taxi stances in line with the provisions of S19 (1) of the Civic Government (Scotland) Act 1982 ("the 1982 Act").

The Roads Authority had implemented a Traffic Regulation Order to facilitate the appointment of an authorised taxi stance on the south side of St. Andrew Square as set out in Appendix 1 of the report by the Executive Director of Place.

In order to satisfy the second part of the two-stage appointment process, approval was now sought to carry out the statutory consultation required prior to formally appointing the taxi stance.

9. Taxi Stance Appointment – East Market Street

As a result of planned construction works on Market Street for the Fruitmarket Gallery due to commence in January 2020 and other public safety considerations, the current location of the temporary taxi stance in Market Street was no longer suitable. It was now necessary to relocate the taxi stance whilst maintaining suitable and proportionate taxi provision for Waverley Station and surrounding areas.

Approval was sought to appoint a taxi rank on East Market Street for a temporary period as shown in Appendix 2 of the report by the Executive Director of Place.

The Executive Director of Place reassured Members that options would be considered to relocate the taxi stance at such time when a more suitable location for the taxi stance had been identified as part of the overall Waverley Station Masterplan.

Decision

- 2) To note that various construction projects, safety concerns around vehicle movements, the existing road layout, loading requirements for existing businesses and passenger drop offs to Waverley Station, all limited the available options for the placement of a taxi rank.

- 4) To note that further planning was required and would be taken forward by the City Centre Transformation projects and the Waverley Station Masterplan.
- 5) To appoint the taxi rank at East Market Street under Section 19 of The Civic Government (Scotland) Act 1982 ('the 1982 Act').

10. Air Weapons and Licensing (Scotland) Act 2015 – Repeal of Theatres Act 1968 - Update After Statutory Consultation

An update was provided on the implementation and changes to the licensing regime as a result of the Air Weapons and Licensing (Scotland) Act 2015.

The Theatres Act 1968 would be repealed on 27 January 2021 and the current exemption within the Civic Government (Scotland) Act 1982 would also be removed, thereby enabling a local authority to resolve under section 9 of the 1982 Act to license theatres under its public entertainment licensing regime.

The outcome of the statutory consultation on the proposed change was submitted and approval was sought to vary the Council's Public Entertainment Resolution to include any theatrical performances including plays, ballet, comedy and musical productions within the Resolution.

Decision

- 1) To note the report and the outcome of the statutory consultation.
- 2) To vary the City of Edinburgh Council's Public Entertainment Resolution as set out in Appendix 2 of the report to bring theatres into the Public Entertainment Resolution to take effect on 27 January 2021.
- To agree the revised fee structure by removing the Theatres category and to include this within the Public Entertainment Fees criteria, effective 28 days after the Resolution took effect for any application received after that date.
