Application for Advert Consent 20/03658/ADV at Advertising Drum, Brunswick Street, Edinburgh. Arts and Culture Advertising Structure.

Summary

Report

Application for Advert Consent 20/03658/ADV at Advertising Drum, Brunswick Street, Edinburgh. Arts and Culture Advertising Structure.

Recommendations

1.1 It is recommended that this application be Granted subject to the details below.

Background

2.1 Site description

The site is on the corner of Brunswick Street and Leith Walk on an area of widened footway.

The surrounding area is mixed use; with predominantly traditional tenements accommodating shops/restaurants and bars at ground floor, with residential flats on the upper floors.

There is currently a Just East Cycle Bike station located on the hardstanding, along with mature trees and a post on the perimeter.

The site sits opposite the MacDonald Library, a Category B Listed Building on the opposite side of Leith Walk.

The site falls just outside the New Town Conservation Area.

2.2 Site History

There is no relevant planning history for this site.

Main report

3.1 Description of the Proposal

This application seeks advertisement consent for the installation of an Arts and Culture Advertising Drum on the area of widened pavement.

The proposed design is cylindrical, essentially an advertising column. The tubular body of the drum is created using a rolled galvanised steel panel, with galvanised steel sheeting wrapped around the concreate base at the foot of the drum. The drum's cylinder body will measure approximately 2.4 metres in height, with a poured concrete base reaching 200mm. The structure and base at its widest part will cover an area of approximately 1.3 metres.

The design incorporates a flat copper lid with green roof. This is designed to patinate to a verdigris effect over time and provide ecological benefits by being adorned by a living roof of lvy.

The proposal is part of a wider initiative through the Arts and Culture sector within Edinburgh to meet current and future advertising needs on a financially accessible basis, whilst at the same time, helping to maintain a cleaner City. The scheme seeks to promote the reduction of fly-posting etc in the City by contracting Clean-Down services within a 30-metre radius of each Arts and Culture Advertising Drum which removes unauthorised advertising such as flyposting, poster/railing boards, cable ties, stickers and graffiti, tagging etc. As such, enhancing the amenity of the area, and improving the public realm, as per the Public Realm Strategy 2009.

A statement in support of the application has been submitted detailing the importance of the Advertising Drum. The statement can be viewed on the Planning and Building Standards Online Services.

3.2 Determining Issues

Do the proposals affect the amenity of the locality? In the determination of the suitability of the site for the display of advertisements, the Planning Authority shall have regard to the general characteristics of the locality including the presence of any feature of historical, architectural, cultural or similar interest. The authority may disregard any advertisements displayed in the locality.

Do the proposals affect public safety? The Planning Authority shall in particular consider whether any such display is likely to obscure, or hinder the ready interpretation of, any road traffic sign, railway signal, or aid to navigation by water or air.

3.3 Assessment

To address these determining issues, the Committee needs to consider whether:

- a) The impact of the proposal on amenity is acceptable;
- b) The proposal would compromise public safety and
- c) Any Public Comments have been addressed.

Regulation 4 (1) of the Town & Country Planning (Control of Advertisements) (Scotland) Regulations 1984 (as amended) states that advertisement control shall be exercisable only in the interests of amenity and public safety.

Advertisements must be compatible with the Council's Street Design Guidance section within the Edinburgh Design Guidance. The proposal should not increase street clutter, nor result in potential obstructions for those with visual impairments or other disabilities.

Section 2.2 of the Councils Outdoor Advertising and Sponsorship Guidance also refers to various additional documents which support the enhancement of the public realm throughout the city which should be considered. This guidance constitutes a material factor in the assessment of applications for advertisement consent. Section 9 of the Guidance, 'Small Format Outdoor Advertising Displays/ Advertising on Street Furniture' is also applicable.

Furthermore, the Council's non-statutory 'Guidance for Businesses' seeks to ensure that the display of advertisements preserve the setting of any nearby listed buildings.

a) <u>Amenity</u>

This is a wide paved area in a busy urban and mixed-use area. It's an acceptable location for an advertisement drum and is within keeping of the character of the area.

The proposed drum is set back the building line, the road and away from the existing trees. It will sit comfortably with the existing street furniture/planting and will not result in street clutter.

Its design is acceptable in scale and form and utilises appropriate materials that are compatible with the urban setting. The green roof provides an organic, colourful and environmentally friendly element to the streetscape.

The applicant has confirmed a gardening/management company will be retained to maintain the roof top of the structure.

The site sits opposite a Category B Listed MacDonald Library. Given its scale and positioning on the opposite side of Leith Walk. the installation will have no discernible impact upon its setting.

Overall, the proposal will have no adverse impact on the amenity of the area and will preserve the setting of the nearby listed building.

b) Public Safety

The drum will be located centrally on the pavement, set back from the building line and set back from the edge of Brunswick Road.

Its size and positioning within the wide public footway, ensures it will not impede pedestrian movements, and there is adequate space for pedestrian and wheelchair/pushchair users to pass. The drum is located away from the pedestrian crossings/dropped kerbs.

Given its central location within the area of hardstanding, the advert drum will not distract drivers passing or impede driver's line of sight.

The Roads Authority was consulted on the proposal and have raised no concerns with regards to road or pedestrian safety.

c) Public Comments

Five letters were submitted in support of the proposal and two objections were received.

Material considerations

- shouldn't have advertising boards on the pavement; addressed in section 3.3b;
- residential street isn't appropriate- addressed in Section 3.3a;
- Using vital pavement space next to an already busy bike hire scheme will create congestion at the end of the street; addressed in Section 3.3b;
- making social distancing that little bit harder. Addressed in Section 3.3b;

Letters of Support- material

- carefully designed;
- in keeping with the character of area;
- adds colours and enhances character and appearance of area and
- good positioning and location.

Letters of Support-non- material

- tidy and better to maintain than alternatives;
- necessary to help recover and rebuild post Coved 19 and help local arts;
- cost effective and
- reduces fly tipping.

Conclusion

The drums project is led by the Council's Culture Service and provides a significant income stream for the Service. The drums also provide a low-cost street advertising medium for the Council's Cultural Grants clients and the city's cultural venues. Non-statutory guidelines 'ADVERTISEMENTS, SPONSORSHIP AND CITY DRESSING' Provides guidance on proposals for advertisements, imposing restrictions on adverts on street furniture, hoardings, and at the roadside, and outlining the circumstances in which sponsorship, city dressing, banners and adverts on scaffolding should be acceptable.

Non-statutory guidelines 'GUIDANCE FOR BUSINESSES' provides guidance for proposals likely to be made on behalf of businesses. It includes food and drink uses, conversion to residential use, changing housing to commercial uses, altering shopfronts and signage and advertisements.

Non-Statutory guidelines Edinburgh Design Guidance supports development of the highest design quality and that integrates well with the existing city. It sets out the Council's expectations for the design of new development, including buildings, parking, streets and landscape, in Edinburgh.


