#### APPLICATIONS TO EXTEND PROVISIONAL PERIOD

#### 1. Purpose

1.1 To ask the Board to consider applications to extend the provisional period for provisional premises licences.

#### 2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If not confirmed before the end of the provisional period, the licence is revoked, by operation of the Act. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, where necessary, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors beyond the licence holder's control.
- 2.4. The Coronavirus (Scotland) Act 2020 provides for a six month extension to the provisional period where this is the first such extension and where it is for coronavirus-related reasons. Although none of the requests listed in the appendix to the report are first-time requests, the impact of Covid-19 may be a relevant consideration in the Board's deliberations.
- 2.5. Agents for the licence holders have been invited to attend the meeting, to provide any relevant information to the Board in support of the extension requests.

#### 3. Recommendation

3.1 In the event the Board is satisfied with the reasons given, the Board is asked to reach a decision on the duration of any extension of the provisional premises licence, noting this is a first-time request.
