APPLICATIONS TO EXTEND PROVISIONAL PERIOD

1. Purpose

- 1.1 To ask the Board to consider applications to extend the provisional period for provisional premises licences

2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If not confirmed before the end of the provisional period, the licence is revoked by operation of the Act. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, where necessary, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting such an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.4. The Coronavirus (Scotland) Act 2020 provides for a six month extension to the provisional period where this is the first such extension and where it is for coronavirus-related reasons. The two extension requests being made to the Board are for first-time extensions beyond the four year provisional period. If the reason for extension in each case is covid-related then the Board would be required to extend the provisional period by six months. If not covid-related, the provisions referred to in para 2.3 above would apply, and it would be for the Board to make a decision on duration of any extension.
- 2.5. Details of the premises are provided below. The provisional premises licences for each are due to expire on 4th December 2021.

3. Recommendation

- 3.1 In the event the Board is satisfied with the reasons given, the Board is asked to reach a decision on the duration of any extension of the provisional premises licence.

GAMBLING ACT 2005 – CONSULTATION ON POLICY STATEMENT

1. Purpose

The Licensing Board is the relevant licensing authority in terms of the Gambling Act 2005 (“the 2005 Act”). The Act requires the Board to publish a Statement of Policy every three years setting out how the Board will carry out its functions. The existing policy is due to be reviewed. This report:-

- 1.1 advises the Board of the requirement to review and carry out a consultation on its Statement of Policy, in terms of the 2005 Act;
- 1.2 suggests that the Board carries out a consultation with a view to agreeing a new policy statement, with responses to be reported to a later meeting of the Board.

2. Main Report

2.1. The 2005 Act requires the Board to publish a Statement of Policy every three years, setting out the principles the Board will apply, in exercising its functions. The policy forms the backdrop of all decisions taken by the Board on grant and variation of gambling premises licences and permits in terms of the 2005 Act.

2.2. Details of the extent of the Board’s policy-making duty are set out in section 349 of the Act and associated regulations, in line with Gambling Commission guidance. The Board must:-

- review its policy from time to time,
- revise the terms of the policy where the Board considers it necessary, and
- consult on any revisions

As the current policy is nearing the end of its three year duration, the Board must now consult and review its terms. The Board’s existing Statement of Policy is available online - [here](#)

2.3 At minimum the Board must consult:-

- the Chief Constable
- one or more persons who appear to the Board to represent the interests of persons carrying on gambling businesses in the Board’s area; and
- one or more persons who appear to the Board to represent the interests of persons likely to be affected by the exercise of the Board’s functions in terms of the Act

GAMBLING ACT 2005 – CONSULTATION ON POLICY STATEMENT

During the lifetime of the existing policy there have been relatively few applications for new premises licences or variation of existing premises licences. There have been no applications made to the Board for review of premises licences within the Board's area. All of this is perhaps to be expected, in the context of the Covid-19 Pandemic.

- 2.4 There have been no significant issues highlighted with the existing policy. The timescale for publication of a new Statement of Policy is relatively short and it is therefore proposed to carry out a consultation inviting comments on the current policy, with the outcome reported to the Board at its next meeting in order that the Board can revise the terms of its policy and publish the version to take effect for the period 2022-25.
- 2.5 The new policy will require to take account of any changes to the guidance issued by the Gambling Commission to licensing authorities, and the Depute Clerks will ensure the policy is updated to that extent.
- 2.6 When preparing the existing policy, the Board confirmed an intention to consider the preparation of Local Area Profiles, in line with Gambling Commission guidance. These are used to map out the extent of potential areas of concern within a board's area, having regard to potential impacts upon the licensing objectives, namely:-
- preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime;
 - ensuring that gambling is conducted in a fair and open way;
 - protecting children and other vulnerable persons from being harmed or exploited by gambling

It has not been possible to prioritise the work necessary for preparation of a profile, particularly taking account of the events of the past 18 months. The lack of application activity over the lifetime of the current policy suggests that the lack of a current Local Area Profile remains relatively low risk.

- 2.7 Given the limited timeframe available it is suggested to the Board that the priority at this time is to ensure that a new policy is put in place for the start of 2022, with any work on Local Area Profiles to be followed up thereafter.
- 2.8 Details of the consultation will be published on the Council's online Consultation Hub. There will also be direct communications with consultees. A suggested timeline for the consultation is as follows:-

1st November 2021 – commencement of consultation

3rd December 2021 – closing date for consultation responses

Date to be agreed December/January – reporting of consultation responses to Board

31st January 2021 – finalise new policy statement for publication

3. Recommendation

- 3.1 The Board is asked to agree:-
- a. to carry out a consultation on the terms of the Board's existing policy;
 - b. to await the results of consultation being reported to a future Board meeting, date to be agreed;
 - c. to agree if any work is to be carried out on Local Area Profiles, that this is continued for the meantime, potentially forming part of a further review of policy
