#### 1. Preliminary matters

#### PREMISES LICENCE REVIEW HEARING – TAMSONS, 280 EASTER ROAD, EDINBURGH

#### 1. Purpose

- 1.1 To advise the Board of the requirement to hold a hearing on a premises licence review application for the premises Tamsons, 280 Easter Road, Edinburgh.
- 1.2 To set out the options available to the Board, if it considers it necessary for the purposes of the licensing objectives to take any action with the premises licence.

#### 2. Main Report

- 2.1. The grounds for review of a premises licence are:-
  - (a) that one or more of the licensing conditions has been breached;
  - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or
  - (c) any other ground relevant to the licensing objectives:-
    - preventing crime and disorder,
    - · securing public safety,
    - preventing public nuisance,
    - protecting and improving public health, and
    - protecting children and young persons from harm.
- 2.2. The Board may reject an application for review if it is considered that it is vexatious or frivolous, or that it fails to disclose matters relevant to the statutory grounds for review. The Board's Statement of Licensing Policy delegates this decision to the Convener. The details of the application for review were forwarded to the Convener for consideration and he agreed the application should be reported to the Board for a premises licence review hearing.
- 2.3. The application has been submitted by Police Scotland. The premises licence holder is Kast Scotland Limited. A copy of the review application has been sent to the premises licence holder with a copy of this report. Details of the review application have been forwarded to the Council's Licensing Standards Officers and the LSO report will be provided to the licence holder and the Board.
- 2.4. In carrying out a review hearing, the Board should hear from the applicant, hear the LSO report and then hear from the Licence holder or their representative in response. At the conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-
  - (a) issue a written warning;
  - (b) make a variation of the licence;
  - (c) suspend the licence for such period as the Board may determine;
  - (d) revoke the licence.

#### PERSONAL LICENCE REVIEW - SECTION 84A - ROBERT SALKELD

#### 1. Purpose

1.1 To advise of a requirement to hold a personal licence review hearing.

#### 2. Main Report

- 2.1. Robert Salkeld holds a personal licence issued by the Edinburgh Licensing Board. Police Scotland have applied for review of his personal licence.
- 2.2. The details of the review application are set out in a letter from Police Scotland, a copy of which has been sent to Mr Salkeld. The police have submitted a separate application for review of the premises licence of which Mr Salkeld is the named manager, and that application has been set down for a separate hearing. The Board is required to hold a hearing on the terms of the review application and decide what action is considered necessary for the personal licence.
- 2.3. If the Board is satisfied that it is necessary to take action for the purposes of any of the licensing objectives, it may make an order:-
  - (a) revoking;
  - (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
  - (c) endorsing

the personal licence.

2.4. If it is considered, having regard to the licensing objectives, that the licence holder is no longer fit and proper to hold the licence, the Board must revoke the licence.

#### 3. Recommendation

- 3.1 The Board should:-
  - (a) hold a hearing on the personal licence, allowing the licence holder the opportunity to be heard; and
  - (b) decide what action should be taken, having regard to the licensing objectives.
