Appointment of Members to Committees, Boards and Joint Boards

2. Executive Summary

2.1 This report details the outstanding appointments required to be made by Council and an approach to reviewing the Council's political management arrangements.

3. Background

- 3.1 On 26 May 2022 the Council made appointments to a range of committees, boards and joint boards.
- 3.2 A number of vacancies on committees etc were outstanding following the Council's initial appointments at its 26 May 2022 meeting.
- 3.3 Councillors McNeese Mechan and Frank Ross have resigned from their positions on the Licensing Board and the Council is asked to appoint members in their place.

4. Main report

- 4.1 The appointment of committees, joint committees and joint boards is a reserved matter for full Council.
- 4.2 At its meeting on 26 May 2022 the Council made appointments to a range of committees, boards and joint boards. A number of vacancies on committees etc were outstanding following the Council's initial appointments at its 26 May 2022 meeting. The attached list at Appendix 1 details the Convener vacancies and Appendices 2 and 3 detail the committees etc vacancies.
- 4.3 The Recruitment Committee membership is listed as Leader of Council (Convener), Depute Leader of the Council, Convener of the Finance and Resources Committee and the appropriate Executive Committee Convener and relevant opposition spokespersons (or nominees). Currently, the Depute Leader of the Council and the Convener of the Finance and Resources Committee are the same person and therefore the Council should appoint another member.

Licensing Board

4.4 Councillors McNeese Mechan and Frank Ross have resigned from their positions on the Licensing Board and the Council is asked to appoint members in their place.

- 4.5 The Licensing (Scotland) Act 2005 states that any member appointed to the Licensing Board cannot take their place on the Board until they have completed an external training course and passed an examination.
- 4.6 A Councillor who is a premises licence holder, or the employee of a premises licence holder and works as such in licensed premises, whether alone or in partnership with another person engaged in the business of producing or selling alcohol, or a director or other officer of a company so engaged or an employee of any person so engaged and working as such in that business, shall not act as a member of a Licensing Board for any purpose under the Act.

Political Management Arrangements

- 4.4 The current political management arrangements system has been adapted and refined over a number of years. The system is functioning well and facilitates competent and lawful decision making, however, there are strains in the system.
- 4.5 This report outlines that the Chief Executive, in consultation with each political group, will explore options and develop proposals for political management arrangements for consideration by Council in August/September 2022. Consideration should be given to structure, membership, scrutiny arrangements, supporting processes, and take into account the findings of the Effectiveness Review of the Governance, Risk and Best Value Committee.

5. Next Steps

- 5.1 Training will be provided to members as necessary.
- 5.2 The Corporate Governance Team will schedule a series of meetings with group leaders (or their representatives) over July and August and support the review of political management arrangements.

6. Financial impact

6.1 There is no direct financial impact of this report.

7. Stakeholder/Community Impact

7.1 All Joint Committees, Joint Boards and Partnerships are aware of the appointments process.
