PUBLICATION OF ANNUAL FINANCIAL REPORT - 2019/20, 2020/21 and 2021/22

1. Purpose

- 1.1 To ask the Board to approve the terms of its annual financial report;
- 1.2 To discharge statutory duties of the Licensing Board in relation to the reporting of income and expenditure; and
- 1.3 To provide information about spend and pressures as advised to the Board by the Council's Place Directorate.

2. Main Report

- 2.1. At a previous meeting on 26 June 2017 the Board was advised of a new duty introduced by an amendment to the Licensing (Scotland) Act 2005 ("the 2005 Act"). Section 9B of the 2005 Act requires Boards to prepare and publish no later than three months after the end of the financial year, an annual financial report. This period was temporarily extended to nine months by the Coronavirus (Scotland) Act 2020. The annual report for the year 21/22 is the last year to benefit from the temporary extension period for publication.
- 2.2. The financial report should include:
 - A statement of the amount of liquor licensing income received by the Board during the financial year;
 - A statement of the expenditure incurred by the Board during the same period; and
 - An explanation of how the amounts in the statement were calculated.
- 2.3. Section 9B of the 2005 Act provides some detail as to what is required of Boards to comply with this duty, but the Scottish Government has not issued guidance on the specifics. The report format has been left to individual Councils and Boards to decide.
- 2.4. In terms of the 2005 Act all fees received by the Licensing Board should be paid to the Clerk of the Board who in turn must remit the fees to City of Edinburgh Council ("the Council"). The current position within the Council is that the Licensing Board budget is the responsibility of the Place Directorate.
- 2.5. The Council's Place Directorate has therefore prepared the annexed report (Appendix One) based on information obtained from the licensing applications database. The report has been prepared using a similar template to the previous three annual financial reports considered by the Board at its meetings on 4 December 2017, 26 November 2018, and 25 November 2019.
- 2.6. The annexed report sets out the income and expenditure details calculated for the 2019/20, 2020/21 and 2020/21 financial years. These reports were not available during the period of the pandemic due to the operational pressures on the Licensing Service within the Directorate of Place of maintaining the

continued operation of the licensing system for both the Council and Board. Additionally, resources with the Directorate of Place were required to prioritise the introduction of two new licence schemes for the Council.

- 2.7. Income details have been provided from an assessment of the Council's licensing applications database for all fees gathered between 1 April and 31 March in each period.
- 2.8. The annexed report explains the basis upon which the expenditure figure has been reached, with an explanation as to why this represents an estimate figure of the total expenditure for the financial year. This model was subject to a review by Internal Audit as part of the Council-wide review of fees and charges in 2019.
- 2.9. The Place Directorate, in addition to preparing the financial statements, have also provided supplementary information and comment in relation to the Board's financial position as set out at Paragraphs 2.10 2.14 below.
- 2.10. Staffing in the Licensing Service/Licensing Standards teams has had an impact on costs and the outturn for the financial year, specifically:
 - 2.10.1. The staffing costs for Licensing Standards Officers were lower than the forecast figures. A number have retired or left the employment of the Council, and whilst the aim has always been to maintain a full establishment, the time lag for recruitment has resulted in an underspend.
 - 2.10.2. Within the wider Licensing Service, two Licensing Officers and two Licensing Assistant posts have been vacant during the period due to retirement, staff moving to other roles or internal promotion. The overall staffing costs are split across all licence types including liquor, and therefore this has contributed to the staffing costs recharged to the Board being lower than projected.
- 2.11. Appendix 2 sets out the reserve over the three-year period covered in this report.
- 2.12. Members are asked to note that whilst the current reserve stands at £349k this amount has to be considered against a number of potential financial pressures. Once vacancies are filled, combined with the Board contributing circa 30% share of the overall costs of upgrading of the Licensing Service ICT system, the reserve may be completely depleted. It is recommended that consideration is given to the financial year end position of the last two years as they effectively cancelled each other out and therefore there was minimal contribution toward the reserve.
- 2.13. Maintaining a reserve is also necessary in anticipation of legal costs for any appeals against Board decisions and that is a risk for the Board.
- 2.14. Any change considered by the Board in terms of improving service provision must be viewed alongside what service must be reduced in order to introduce additional service.

3. Current Fees

- 3.1 In terms of the Licensing (Fees) (Scotland)Regulations 2007, when determining any fee payable under the Regulations, ".... the Board is to have regard to the desirability of ensuring that the total fees payable in respect of any period are likely to be broadly equivalent to the expenses incurred by that Board, and the Council for the area of that Board in administering the Act generally during that period...". The costs of the Council employing Licensing Standards Officers are also included by the Regulations within expenses incurred by the Board.
- 3.2 Certain fees are set by the Regulations e.g., occasional licences. However, fees for other applications e.g., premises licences and major variations are set by each Board up to a maximum limit as stated in the Regulations. The Board currently does not charge the maximum fees allowed for by the Regulations and has not increased fees since the commencement of the 2005 Act provisions. A copy of the current fee list is attached at Appendix Three. If the Board wish to consider current fee levels in more detail, a further report can be provided to a future meeting of the Board.
- 3.3 In the meantime, provided that the Board approves the annexed financial report, covering the last three-year period then it will be published as required on the Board's webpage on the City of Edinburgh Council website.

4. Recommendation

- 4.1 The Board is asked to:
 - a) approve the terms of the annual financial report covering the periods 2019/20,2020/21 and 2021/22 as annexed; and
 - b) delegate publication of the report to the clerk and his deputes.

Report

Motion by Councillor McFarlane – Prevention of Drug Deaths

2. Executive Summary

- 2.1 On <u>30 June 2022</u>, the City of Edinburgh Council approved a motion by Councillor McFarlane on the Prevention of Drug Deaths, which included an action to "request a report in two cycles to the Regulatory Committee to explore opportunities within licensing provision to increase requirements for training in administering Naloxone for licensed premises, door staff and personal licence holders".
- 2.2 This report summarises the work carried out to date in this respect.

3. Background

- 3.1 On 30 June 2022, the City of Edinburgh Council debated the motion on drug related deaths and possible measures to respond to these.
- 3.2 Naloxone is a drug which temporarily reverses an opiate overdose, and which can be administered by non-medical professionals.
- 3.3 From the information available to the Council from Police Scotland and Licensing teams, there is no direct evidence of a pattern of opiate overdose in liquor licensed or other premises licensed by the Council.
- 3.4 Advice has been sought from the Edinburgh Alcohol and Drugs Partnership (EADP) and NHS Lothian's Harm Reduction Team (HRT) on what proactive steps could be taken to address the issues raised in the motion.
- 3.5 Some licensed premises already act as community hubs, hosting automated external defibrillators ('AEDs') and other community resources. While it is not envisaged that Naloxone would often be required on these premises, providing it at these locations would make it available for the local community if required.

4. Main report

Licensed Premises

- 4.1 Officers considered whether it would be possible to make the provision of 'Take Home Naloxone' ('THN kits') a condition of either Personal or Premises alcohol licences.
- 4.2 This would primarily be a matter for the Licensing Board, which is the licensing authority for those premises.

Other Types of Licence

- 4.3 Consideration was also given to whether other types of licence which fall within the remit of the Council might fall within the scope of the motion.
- 4.4 The starting point for any mandatory training, which would be imposed as a requirement by means of licence condition, is that it must be within the powers available to the licensing authority, and that there is a clear evidence base which would justify such a condition.
- 4.5 The <u>Civic Government (Scotland) Act 1982</u> is now quite outdated and does not provide a basis for addressing contemporary issues. As such, it would not provide the framework for a condition of licence that would require staff in licensed premises to undergo mandatory training of this type. The courts have consistently overturned attempts to use the 1982 Act to regulate contemporary issues beyond the core purpose of the Act.
- 4.6 Additionally, the Council would be required to show an evidence base for why such a condition is necessary and proportionate, which at present does not exist. Taking these two points together, Committee is advised that it would not be feasible to introduce a mandatory training requirement for any licence type administered by the Council.

Other Options

- 4.7 Officers from Regulatory Services have met with colleagues in EADP and HRT to discuss whether there are other options and have jointly agreed to take forward the motion via the pilot work described below, and thereafter to assess its impact.
- 4.8 It is believed that the kits can be provided via NHS HRTs. These teams can also provide training on use of THN kits, which takes only a short time.
- 4.9 Several options for the distribution of the kits have also been discussed. It is intended to investigate an intelligence-based targeted approach. The EADP will liaise with Licensing Standards Officers to identify areas of peak need, with resources then being focussed appropriately:

Licensing Standards Officers	•	Collaborate with EADP to identify premises which would benefit from the training
	•	Monitoring of premises (to be carried out as part of routine inspections)
Harm Reduction Team	•	Provision of THN kits
	•	Training
	•	Administration

4.10 Once targeted premises have been identified, the next phase of work will include the following:

Scottish Ambulance Service	Raising awareness of kit locations and premises opening hours
EADP	Communications
Harm Reduction Team, Turning Point Scotland, local pharmacies	Raising awarenessPotential for leaflet distribution
Licensed premises	 Engage with communications plan (EADP) Undertake training (HRT) Store THN kits appropriately Engage in THN kit monitoring (HRT)

- 4.11 Initial discussions identified that there may be a role for the Security Industry Authority (SIA). Officers will liaise with SIA representatives to explore any possibility of including training on use of the THN kit in mandatory SIA first aid training.
- 4.12 Finally, officers are aware that one of the taxi companies within the city has been encouraging drivers who are part of their network to participate in the training and carry a THN kit. Officers will engage with the Hire Car Trade Group to establish if there is scope to widen participation with other Taxi and PHC companies.

5. Next Steps

5.1 Officers will continue to work with NHS teams to establish a pilot zone. Given this is more directly relevant to the remit of the Licensing Board, any updates will be provided to the Board.

6. Financial impact

6.1 THN kits will be provided via NHS Lothian's HRTs as required.

7. Stakeholder/Community Impact

7.1 The report proposed no policy change for the reasons set out in the report and therefore there is no direct impact.

Chief Inspector Happs presented the terms of the Chief Constable's annual report, advising the Board of work carried out by the Police Licensing Team and other police officers across the Board's area. The Board heard the details of the workload covered by the police when dealing with licensing related matters, the partnership working approach being followed and the details of initiatives over the reporting period and planned for the future. Board members asked questions on various parts of the report and matters arising from it. The Board agreed to note the terms of the report.

2. Reconstitution of Licensing Forum – verbal update from Regulatory Services Manager

The Board heard from Andrew Mitchell who confirmed the Licensing Forum had held its first meeting and was due to meet againon 2nd December 2022 when it would appoint its convener. The Board asked a number of questions on the membership of the Forum and arrangements for future meetings.

3. Referral of Motion from Council – report from Depute Clerk

The Board noted the terms of a motion from the Council on 17th March 2022, which had been referred for Board consideration on the terms of the "Get Me Home Safely" campaign. It was noted there had been a subsequent motion in similar terms, considered by the Council at its meeting on 27th October 2022.

Board members discussed the terms of the motion, and agreed (1) to note the terms of the motion agreed on 17th March 2022 and (2) include consideration of the "Get Me Home Safely" campaign within the scope of the ongoing consultation on the Board's current statement of licensing policy.

- 4. Convener's Update
 - Policy consultation



The Convener referred to the Board's ongoing policy consultation, asking that an update should be provided to the Board at its next meeting.

Meeting with Licensing agents

The Convener advised of a meeting held with a group of Licensing agents who regularly attended Board meetings, during which a number of action points had been agreed. Details would be circulated to the Board for information at a later date.

Occasional licences

The Convener referred to the particular scenario of occasional licences being used on a long term basis as a means of licensing premises that were otherwise unlicensed. She advised it was likely there would be more referrals of occasional licence applications for Board consideration in future.

5. Minutes of meeting of 26th September 2022 and matters arising

The Minutes and decision list for the meeting of 26th September 2022 were approved. Veronica Macmillan provided the Board with an update on item 6 of the minutes, advising there had been an LSO visit to the Spey Lounge premises to confirm compliance with licensing conditions, records of staff training, etc.

The details of applications considered by the Board at the meeting on 31st October 2022 are set out in a separate decision list, for approval and to be appended to these minutes.

Noting Mr McKenzie was not in attendance, the Board agreed one final continuation of the consideration of the report.

Having previously agreed to make a finding on Mr Moussa's personal licence following the premises licence review for the Spey Lounge at its meeting on 29th September 2022, the Board heard from Mr Moussa and from his agent Alistair Macdonald.

APPLICATION TO EXTEND PROVISIONAL PERIOD

1. Purpose

1.1 To ask the Board to consider an application to extend the provisional period for a provisional premises licence.

2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If not confirmed before the end of the provisional period, the licence is revoked, by operation of the Act. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, where necessary, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting such an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.4. The agent for the licence holder has indicated they will provide information to the Board to support the licence holder's request for extension and this will be supplied to the Board along with this report.

3. Recommendation

3.1 In the event the Board is satisfied with the reasons given, the Board is asked to consider the duration of any extension period.

PERSONAL LICENCE REFERRAL – SECTION 84 – LEITH MCKENZIE

1. Purpose

1.1 To advise of a referral for review of a personal licence.

2. Main Report

- 2.1. Leith McKenzie holds a personal licence issued by the Edinburgh Licensing Board. The West Dunbartonshire Licensing Board conducted a premises licence review hearing for premises at which Mr McKenzie was the named premises manager. In the course of the hearing, a finding was made that Mr McKenzie had acted in a manner inconsistent with the licensing objectives.
- 2.2. The details of the review hearing conducted by the West Dunbartonshire Board and the decision reached on Mr McKenzie's licence are set out in a letter from the clerk of that Board, a copy of which has been sent to Mr McKenzie.
- 2.3. As Mr McKenzie is the holder of a personal licence issued by the Edinburgh Board and he is not currently believed to be working in the West Dunbartonshire Board area, the Board is required to hold a hearing on the terms of the referral and decide whether to take the action recommended by the West Dunbartonshire Board or any alternative action the Board considers necessary.
- 2.4. If the Board is satisfied that it is necessary to take action for the purposes of any of the licensing objectives it may make an order:-
 - (a) revoking;
 - (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
 - (c) endorsing

the personal licence.

2.5. In this instance the West Dunbartonshire Licensing Board has recommended that Mr McKenzie's personal licence be revoked. Mr Mackenzie was invited to attend the Board meetings on 26th September and 31st October 2022, but failed to attend and has not responded to communications sent to him. It is suggested that if he is not in attendance at the meeting on 28th November the Board should proceed to deal with the matter in his absence.

3. Recommendation

- 3.1 The Board should:-
 - (a) hold a hearing on the personal licence, allowing the licence holder the opportunity to be heard; and
 - (b) decide what action should be taken, having regard to the licensing objectives and noting the recommendation set out in the referral.

1. Purpose

- 1.1 To advise the Board of the requirement to hold a hearing on a premises licence review application for the premises 301 Leith Walk, Edinburgh.
- 1.2 To set out the options available to the Board, if it considers it necessary to take any action with the premises licence at the conclusion of the hearing.
- 1.3 To advise the Board of a connected application for review of the personal licence of Muhammad Tahir Sharif.
- 1.4 To set out the options available to the Board, if it considers it necessary to proceed with a hearing on the personal licence.

2. Main Report

- 2.1. The grounds for review of a premises licence are:-
 - (a) that one or more of the licensing conditions has been breached;
 - (b) that having regard to the licensing objectives the premises licence holder is not a fit and proper person to hold the licence; or
 - (c) any other ground relevant to the licensing objectives:-
 - preventing crime and disorder,
 - securing public safety,
 - preventing public nuisance,
 - protecting and improving public health, and
 - protecting children and young persons from harm.
- 2.2. The Board may reject an application for review if it is considered that it is vexatious or frivolous, or that it fails to disclose matters relevant to the statutory grounds for review. The Board's Statement of Licensing Policy delegates this decision to the Convener. The decision was made by the convener of the Board that the application should be reported to the Board for a premises licence review hearing.
- 2.3. The application has been submitted by Police Scotland. The premises licence holder is Muhammad Tahir Sharif. A copy of the review application has been sent to him along with a copy of this report.
- 2.4. A copy has also been sent to the Council's LSOs in order that a report can be provided by the LSOs. This will be submitted to the Board for consideration
- 2.5. In carrying out a review hearing, the Board should first hear from the police representative. The Board should then hear the LSO report and finally from the licence holder in response. At the conclusion of the hearing if the Board is satisfied that it is necessary or appropriate for the purposes of any of the licensing objectives the Board can take any of the following steps:-

- (a) issue a written warning;
- (b) make a variation of the licence;
- (c) suspend the licence for such period as the Board may determine;
- (d) revoke the licence.
- 2.6 The police have submitted a separate application for review of Mr Sharif's personal licence and a copy of the police letter is provided for the Board's consideration.
- 2.7 If the Board is satisfied that it is necessary to take action for the purposes of any of the licensing objectives, it may make an order:-
 - (a) revoking;
 - (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
 - (c) endorsing

the personal licence.

2.8 If it is considered, having regard to the licensing objectives, that the licence holder is no longer fit and proper to hold the licence, the Board must revoke the licence.

3. Recommendation

- 3.1 The Board is required:-
 - (a) to hold a premises licence review hearing;
 - (b) to decide at the conclusion of the hearing what action requires to be taken, having regard to the licensing objectives;
 - (c) to decide whether to hold a personal licence review hearing;
 - (d) in the event it does so, to decide what action requires to be taken.
