# Police Scotland Licensing Overview -

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within Safer Communities based at Dalmarnock Police Station, Glasgow.

The VPLCU upholds the two tier structure for licensing which supports both national and local priorities through service delivery. They have overall responsibility for determining and delivering national licensing strategy and policy, by providing advice, guidance and support to divisional licensing teams as well as undertaking other specialist functions.

The Violence Prevention and Licensing Co-ordination Unit is a specialist department which consists of a small team of officers, based in Glasgow. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide practical and tactical advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the

illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2021/2022, from a licensing perspective, our particular focus was on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Working closely with Licenced Premises and Scottish Government to navigate the challenges of the COVID-19 pandemic through the 4Es approach by engaging, explaining, educating and enforcing.
- Governance and ongoing development of the National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management. Police Scotland are currently working on an upgrade to the National ICT system to ensure compliance with GDPR legislation.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

## LICENSING BOARD AREA

The Licensing Board area is policed by Edinburgh (E) Division.

Chief Superintendent Sean Scott is the Divisional Police Commander who has the responsibility for all day-to-day policing functions.

#### **Senior Officers**

The senior officers holding responsibility for licensing within the area of E Division are as follows:

Head of Department: Superintendent David Robertson – Specialist Operations

Chief Inspector David Happs – Licensing and Events

The Licensing Department is based at St. Leonard's Police Station and consists of:

Inspector Robert Innes, Sergeant Marc Copland, 3 Police Constables and 4 Divisional Licensing Administrators.

## **Local Policing Priorities**

Following our public consultation process, the policing priorities for E Division, as set out in our Local Policing Plan are as follows;

- Addressing violence
- Reducing drug harm and targeting supply
- Tackling housebreaking and acquisitive crime
- Dealing with disorder and antisocial behaviour
- Making our roads safer

In response to the local policing priorities, E Division will continue to address violence, focusing on alcohol related violence, as well as dealing with disorder and antisocial behaviour related to the sale and consumption of alcohol. It is recognised that education, prevention, partnership working and robust policing are all key factors in reducing crime and disorder in this area.

# **Edinburgh Licensing Board Statistics 2021/22**

The Edinburgh Licensing Board area had 7,909 personal licence holders and 1,952 premises licences as of 31<sup>st</sup> March 2022. This includes 399 on-sale, 485 off-sale and 1,068 on and off sale.

# SUMMARY OF APPLICATIONS, PREMISES AND PERSONAL LICENCE REVIEWS

#### **Section 20 - Application for premises licence**

Each application received from the Licensing Board is scrutinised by the Divisional Licensing Team. Where relevant, objections and representations are made to the Board, paying particular attention to both relevant convictions and the five licensing objectives:

- Preventing crime and disorder.
- Securing public safety.
- Preventing public nuisance.
- Protecting and improving public health.
- Protecting children and young persons from harm.

Within the limits permitted by the legislation, the Chief Constable will highlight all relevant information before the Board to afford the fullest picture of the applicant/application to be considered in any subsequent deliberations.

#### **Section 56 - Occasional Licences**

Occasional Licenses are traditionally used during the many significant events and festivals held in Edinburgh each year, to allow the use of 'pop up bars' and other spaces not normally licensed to cater for the increase in visitors and tourism in the city.

#### Section 68 - Extended Hours Licences

Extended Hours applications are routinely used when premises seek an extension to their permitted hours to cater for special events or occasions, or special events of local or national significance.

With the return of Edinburgh's Festivals in 2021, albeit on a much smaller scale, in the wake of the Covid-19 pandemic, Edinburgh Licensing Board set dates for 'Seasonal Variations' during August 2021. This permitted premises who elected to have seasonal variations to trade for 2 hours longer at the end of their core licensed hours.

Extended hours applications that are out with seasonal variations and that do not fall within Board Policy of only 1 extra hour trading can contribute to increased anti-social behaviour (ASB) and increased disruption to residents of the city. Consequently, Police Scotland often object to a high number of extended hours requests that do not

fall within Board Policy. Many premises submit several extended hours applications in relation to one event, for example Hallowe'en or St Patrick's Day, where the date itself does not fall on a weekend. Often premises apply for extended trading on the date, as well as days either side, or the full weekend, again increasing the likelihood of ASB and public nuisance, therefore Police Scotland tend to object to this type of application.

## **Section 72 - Personal Licence Applications**

In line with the legislation, close scrutiny is made by the Divisional Licensing team, paying particular attention to relevant convictions and the five licensing objectives. In general, if an applicant has no relevant convictions, the Police will not provide any representation or objection. If the applicant has relevant convictions, Police will either provide a representation confirming those convictions, or they will object to the granting of the licence, based on the nature of the conviction, and whether or not they believe the person to be 'fit and proper' to hold a licence.

## Crime and Disorder during the Night Time Economy (NTE)

Excessive consumption of alcohol is recognised as a significant factor in levels of crime and disorder, particularly during the NTE. This manifests itself in public space violence and disorder in areas densely populated with licensed premises or private space crime where individuals consume large quantities of cheaper alcohol from off sales.

Ordinarily, alcohol fueled crime is most visible at weekends within the City Centre. To manage this, a dedicated policing plan 'Operation Nightguard', is implemented every Friday and Saturday night purely to police the NTE, with officers from outlying areas of the City brought in to the City Centre to resource the operation.

During Operation Nightguard, we continue to work closely with partners to ensure those partaking in Edinburgh's NTE remain safe and have an enjoyable night out. During the review period, police have carried out joint patrols with City of Edinburgh Council (CEC) Licensing Standards Officers (LSO), Environmental Health Noise

Teams and Security Industry Authority (SIA) enforcement teams. As well as working closely with CEC's citywide CCTV operators, including the mobile CCTV van, taxi marshals, and volunteer welfare providers Street Assist. This collaborative approach to keeping people safe is a vital tool in ensuring the continued safety of residents and visitors to Edinburgh.

#### **Drunkenness/Disorder Offences**

It is important to note that the following figures relate to offences under Licensing (Scotland) Act 2005. Offences in the proximity of, or within licensed premises, that do not fall under Licensing (Scotland) Act 2005 are not included.

Over the period covering 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022 for the Board area, the following licensing offences related to drunkenness and disorder were recorded.

The figures in the above table indicate no offences committed by any staff members of premises, and shows the ongoing partnership working and success of the support between the Police and the licensing industry.

#### Section 94 - Think Twice Bail / Exclusion Orders

When an individual is charged with a violent offence on licensed premises within the Edinburgh city centre ward, a senior officer will consider the offence and decide whether a 'Think Twice' bail condition is justified, proportionate and necessary in the circumstances. The bail condition prevents the person from entering, or attempting to enter any licenced premises within Edinburgh city centre ward where the licence permits the sale and consumption of alcohol on any part of the premises. A request is made to the Procurator Fiscal seeking a continuance of the conditions until the case is concluded.

The reporting officers also request an exclusion order within the Police report, requesting that the accused person be excluded on conviction from licensed premises in the area where the offence was committed, for a period of time the court sees fit.

## **Section 97 - Closure Orders**

There have been no closure orders implemented during the reporting period.

## **Applications for Review of Licence**

#### Section 36 – Premises

During the reporting period 1 application for a premises licence review was made to the Board by Police Scotland.

This was in relation to a premises where there was continued non-cooperation with police after a serious offence occurred within the premises, where staff, and the manager in particular, refused to co-operate with the police investigation.

The Board decided to issue a written warning to the premises.

#### Section 84 - Personal

During the reporting period 1 application for a review of a personal licence was made to the Board by Police Scotland.

This related to the manager for the above premises due to their obstructive and uncooperative behaviour. The Board decided to suspend their licence for 28 days.

## **Licensed Premises Incidents and Inspections**

Section 138 Licensing (Scotland) Act 2005 allows a police officer entry to any premises licensed under the act to ensure they are operating in a manner consistent with the Licensing Objectives and licensing legislation.

Licensed Premises Inspection Reports are completed by operational police officers who have visited a premises pro-actively, to provide advice and support to staff, addressing any issues identified.

Licensed Premises Incident Reports are also completed by officers in response to calls made by members of the public, or premises staff reporting an ongoing incident.

Inspections and Incidents are recorded on a police IT system called Innkeeper. This allows officers to record their observations following the visit and detail the actions of staff in dealing with incidents that occur. The information is then forwarded to the Police Licensing Department for their information and any subsequent monitoring or action.

Inspections are also carried out by Police Licensing Officers as a supportive measure in response to concerns raised by an initial incident, or inspection report, or as a routine pro-active licensing inspection.

The following table provides information on the number of incidents and inspections recorded on Innkeeper for the reporting period.

Police Scotland also records incidents where alcohol has been stolen from a licensed premises, usually recorded as a theft by shoplifting, however the numbers above do not include incidents of theft.

## Interaction and Intervention

On every occasion an issue or incident at a Licenced Premises is highlighted, the Police Licensing team consider whether a problem solving approach could be implemented that would prevent similar incidents or issues reoccurring. Applying a problem solving approach to licenced premises where issues have arisen can often result in an improvement in standards and practices without recourse to a formal review hearing at a Licensing Board. In addition it ensures Police Scotland have utilised a fair and incrementally evidenced based approach to resolve the problem through a range of options.

On reviewing incidents at licensed premises, Police Scotland consider a range of options depending on several factors. This includes the seriousness or nature of the incident, the number of recent incidents and the action or inaction by staff that may have contributed to the incident. Options available to Police are:

No Action This may be considered where the issue was unavoidable and no fault

of the premises, or if it is clear the Designated Premises Manager (DPM) or Premises Licence Holder (PLH) has already rectified the issue.

Interaction Will involve either communication with the PLH or DPM, or attendance

at the premises to discuss the issue or incident. Advice and feedback

are provided and no further action is deemed necessary.

Monitored Having examined the circumstances, consideration may be given to grading the premises as 'Monitored'. This may be a result of Police requesting action from the premises to address an issue, or where a

requesting action from the premises to address an issue, or where a tasked inspection regime is deemed necessary to monitor the premises over a set period of time. If the issue is successfully rectified, then the

requirement for 'monitored' status is removed.

Intervention If the issue or incident is serious, then consideration is given to

proceeding straight to intervention. Intervention may also result from a culmination or continuation of events whilst the premises is being monitored. A formal meeting takes place with the PLH and/or DPM and any other interested party, including a legal agent, during which the issue or incident is discussed at length and a formal action plan is drawn up to ensure the issue does not persist. Police can share helpful material and advice to support the premises during an intervention period in attempt

to prevent the matter progressing to premise licence review hearing. At the end of the intervention period, police can extend, end, or move to a

premises licence review request, depending on the progress made throughout.

Problematic After Intervention, if issues cannot be rectified by the premises, it may be deemed necessary to consider a premises to be 'problematic'. In some rare cases, the incident or issue may be serious enough that a premises would be deemed problematic without having gone through an intervention. In either case, this would trigger a premises licence review request to the Licensing Board. All efforts are made by Police Licensing team to prevent the requirement for a premises licence review request, and it is often seen as a last resort should issues or incidents at a premises persist.

It is important to note that the Police Licensing Team often make contact with premises and their staff to highlight and thank them for their efforts, with the vast majority of engagement with licence holders being positive, encouraging them to continue their effective management practices.

## **Partnerships**

The Licensing Team, supported by local policing officers, promote Police Scotland's Policing priorities in conjunction with the five licensing objectives and the overarching principles and aims of the Licensing (Scotland) Act 2005.

The Licensing Team maintain a positive working relationship with the Licensing Standards Officers (LSO's). Both teams meet on a regular basis to share information and over the reporting period numerous joint inspections of licensed premises in the Board area were conducted.

## **Bystander Training**

Bystander training aims to provide understanding and support to staff working within licensed premises, including door staff, to help identify opportunities to intervene if they believe a person to be at risk, or vulnerable to sexual or violent harm from another. Training has previously been provided to University students and encouraged them 'not to be a bystander'.

Throughout the reporting period, Edinburgh Police Licensing Department carried out Bystander training to staff from various premises. This was deemed necessary due to the high turnover in staff in the wake of the Covid-19 pandemic, as well as an increase in the reporting of alleged spiking incidents both nationally and in Edinburgh.

# PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

Police Scotland can make a positive impact on the future outcomes for children and families, by addressing the sale and supply of alcohol to young persons via problem premises or by proxy (agent purchase). Working with our partners, we take appropriate action to address both the potential and actual misuse of alcohol within early years.

Edinburgh Community Alcohol Partnerships (CAP) have continued to expand across the division and continued their successful work during the reporting period to prevent underage sales through education and partnership work with licensees.

A National Proxy Purchase Campaign took place in the lead up to school holidays in October 2021. Police and partners engaged with premises to raise awareness of the issue of adults buying alcohol for children and young people. This involved provision of education, support and advice to premises, as well as using local and social media to highlight the impact on communities, in an effort to reduce proxy purchases in the division. A further Proxy Purchase Campaign is set to take place throughout the summer of 2022.

Police Scotland has the capability to carry out test purchase operations on an intelligence led basis. When intelligence is received about premises selling alcohol to persons under 18, the first stage in the process is to issue a warning letter to the premises. This is usually hand delivered by a member of the police licensing team who will inspect the premises and discuss expectations regarding responsible sale of alcohol with the licensee. Only when intelligence continues to be received should a test purchase operation be implemented.

School Link Officers are seen as one of the main links between the police and children and young people in Edinburgh. Edinburgh Licensing Department continue to work with School Link Officers across Edinburgh to provide education and support to students around the dangers of alcohol, both on their health and to their community.

Over the reporting period 2021-22 for the Board area the following licensing offences relating to the Sale or Supply of Alcohol to Children or Young People were recorded:

The offence under Section 102 – Sale of alcohol to a child or young person is currently subject to ongoing criminal proceedings. Once these proceedings have concluded, the full circumstances will be reported to The Board.

#### TACKLING SERIOUS AND ORGANISED CRIME

Serious and organised crime has far reaching consequences that affect a large proportion of society and the economy. Those involved have spread their activity into an increased variety of criminal enterprises including illegal drugs, money laundering, fraud, human trafficking, fake goods and the licensed trade.

It is important to highlight that all applications submitted in respect of the Licensing (Scotland) Act 2005 are scrutinised in terms of the applicant (whether individuals or companies), the premises and the activity applied for to minimise the risk of organised criminals infiltrating the licensed trade.

Serious and Organised Crime Groups (SOCG) present a clear threat to the licensed trade in Edinburgh. Police continue to target known criminality in this area as well reduce the opportunity for individuals to exploit legitimate licensing opportunities for their own illegitimate means.

Edinburgh Division Licensing Department works closely with the Divisional CID Proactive team as well as the Organised Crime and Counter Terrorism Unit (OCCTU) to act at the earliest opportunity to disrupt criminals who are believed to be running or involved in licensed premises. Where this can be evidenced, police licensing will provide the Licensing Board with information in an attempt to prevent or remove known criminals from premises.

Edinburgh Division continues to carry out targeted premises visits and initiatives to ensure they operate in line with licensing legislation. Such visits may also involve partner agencies including HMRC, Council LSO's, Council Environmental Health, Fire Service, DVLA, SIA and Immigration Enforcement. During the reporting period, there have been joint initiatives with Immigration Enforcement to tackle illegal workers within licensed premises and the Scottish Fire and Rescue Service to improve safety in relevant establishments.

As a result of joint visits with SIA, two persons were reported to COPFS in relation to operating as a door steward without a licence.

#### PROPOSED ACTIVITY FOR THE YEAR AHEAD

Throughout the coming year, Edinburgh Division Licensing Department will continue to focus on the Divisional and National Policing Priorities, set out by Local and National Policing Plans, specifically Addressing Violence and Public Order & Safety, in connection with the consumption of alcohol.

We will do this by carrying out the following proposed activities in the coming year:

- Continue to work in partnership with LSO's to provide quality and consistent advice and support to licensed premises and their staff, including education in legislation, licensing objectives, and dealing with incidents occurring within their premises.
- Continue to work closely with Community Alcohol Partnerships (CAP's) throughout the city.
- Work with partners to deliver a successful Proxy Purchase Campaign, raising awareness and education in relation to adults who buy alcohol for children and young persons.
- We will continue to engage with all partners involved in the licensed trade and work together with them to uphold the five licensing objectives and the spirit of the 2005 Act, to ensure the safety and wellbeing of the people of Edinburgh.
- Deliver personal safety initiatives, such as Bystander Training to licenced premises staff in the city, to protect vulnerable persons within licensed premises and help tackle sexual violence connected to alcohol consumption.
- Edinburgh Police Licensing Department will look to lead a Test Purchase Operation in the city, in response to relevant intelligence received regarding children and young people purchasing alcohol.
- Engage with major event and festival organisers to agree Alcohol Management Plans for events held across the city. These help control the risk around selling alcohol at events, ensuring compliance with legislation and safe event delivery.
- Edinburgh Police Licensing Department will continue to raise objections, representations and other appropriate concerns in relation to applications to the board for all types of alcohol licences.

To conclude I would like to thank you for your continued support during what has been a challenging year for us all. We have adapted and embraced new ways of working and ever changing circumstances. I look forward to a safe and healthy 2022/2023.

REPORT - REFERRAL OF A DECISION OF CITY OF EDINBURGH COUNCIL TO THE LICENSING BOARD

## 1. Purpose

- 1.1 To advise the Board of a decision of Council on 17 March 2022 relating to the "Get Me Home Safely Campaign" and to suggest what action the Board may wish to take. It should be noted that unfortunately, there has been a delay in bringing this decision to the attention of the Board due to an administrative oversight given the time lapse from the last Council meeting to the appointment of the new Board.
- 1.2 The decision referred to is set out below: -

25 Get Me Home Safely Campaign - Motion by Councillor Watt

The following motion by Councillor Watt was submitted in terms of Standing Order 17:

"Council: Notes the "Get Me Home Safely Campaign" and that journeys to or from work at night can expose workers to violence, the threat of violence or fears about personal safety and security.

Research referenced by the campaign found that women feel particularly vulnerable when travelling to and from work. Waiting at a bus stop in the dark, walking home at night or having to park their car in an isolated spot means being exposed to the risk of harassment and assault.

Notes that East Dunbartonshire Council's Licensing Board has made safe transport home a requirement of any venue wishing to apply for a new or 1am licence.

Requests a report within two cycles to the Licensing Board, considering options to require applicants for new or extended licences to outline the provisions for ensuring their staff have safe travel home for any shift that ends after 11pm."

#### MINUTES OF MEETING

## **MONDAY 26th SEPTEMBER 2022**

In its consideration of items 1 and 8 below, the Board deliberations were broadcast using the Council's webcast system. A copy of the webcast can be viewed here.

1. Report – Commencement of Initial Consultation – Statement of Licensing Policy and Overprovision Assessment

The Depute Clerk referred to a report setting out arrangements for launching the Board's consultation on its statement of licensing policy and overprovision assessment. It was intended the consultation would begin as soon as it could be published on the Council's online consultation hub. A summary document had been prepared for consultees and this was provided for members' consideration.

Board members discussed arrangements for the consultation and in particular the summary document provided for consultees. It was noted it was intended there would be use made of social media to communicate the details of the consultation.

The Board agreed to the publication of the consultation and circulation of the summary document to consultees, and the consultation to continue until 20<sup>th</sup> December 2022.

2. Minutes and decision list – 29<sup>th</sup> August 2022

The Minutes and decision list for the meeting of 29<sup>th</sup> August 2022 were approved.

3. Applications - details as set out in separate list

The details of applications considered by the Board at the meeting on 26<sup>th</sup> September 2022 are set out in a separate decision list, for approval and to be appended to these minutes.

4. Update Report from LSOs – Merlin Bar, 168-172 Morningside Road

Veronica Macmillan provided the Board with an update on the operation of an external area at the Merlin Bar, which had been requested following grant of a variation application by the predecessor Board earlier in the year. The Board agreed to note the update and that no further action was required.

5. Report – Personal Licence referral – Leith McKenzie

Noting Mr McKenzie was not in attendance, the Board agreed to continue consideration of the report.

**6.** Report – Review Hearing – Spey Lounge, 39 Leith Walk

The Board noted the details of a review application submitted by the Council's LSOs. Veronica Macmillan presented the terms of the application and the Board heard from Sergeant Stephen, who confirmed he had been asked by the LSOs to provide information connected with incidents at the premises.

The Board heard a detailed presentation from Patrick Robson on behalf of the premises licence holder. Following consideration of all of the representations made the Board agreed to vary the premises licence and also that it should be suspended for a period of two weeks.

In the course of the review hearing the Board made findings that personal licence holders Mohammed Adel Moussa and Kerry Killen had acted in a manner inconsistent with the licensing objectives, and that hearings should be held on their licences at a later date.

7. Report – Review Hearings – Premises Licence Annual Fees

The Board noted there were no further premises requiring review hearings for outstanding annual fees, as these had all now been paid.

**8.** Update – status of amendments to Licensing (Scotland) Act 2005 during coronavirus pandemic

The Depute Clerk advised the Board of updates to the 2005 Act, following the expiry of a number of amendments which had been brought in by the Coronavirus (Scotland) Act 2020 and associated Regulations. An advice note had been circulated to the Board, and would be published online for general information, confirming for the most part that from 1<sup>st</sup> October 2022 the licensing regime would revert to operation pre-pandemic.

#### Other business

Following consideration of item 8, the Board discussed arrangements for circulation of Board agendas. Councillor Booth referred to late circulation of additional papers and the limited time available for their consideration. Board members considered the possibility of setting clear deadlines for applicants and agents providing additional papers. Councillor Booth also asked about

arrangements for publication of Board papers and whether this could be looked at further by the Board.

The Convener suggested that a "ways of working" protocol should be established, and that this could be reported back to the Board at a later date. The Board also agreed that publication arrangements should be looked at, with a view to ensuring transparency in the decisionmaking process.

Councillor Flannery asked about the current status of the Licensing Forum. Mrs Leck advised the Forum membership had been selected and the appointment of a chairperson would be made at their first meeteing. The Board agreed to invite Andrew Mitchell, Regulatory Services Manager to the next meeting to provide an update.

9. Urgent items – Requests for Extension of Provisional Period

The Board noted there were two requests for extension of provisional period where licences would otherwise expire prior to the next available Board meeting. The Board agreed to the extension requests in each case, as follows:-

#### APPLICATIONS TO EXTEND PROVISIONAL PERIOD

#### 1. Purpose

1.1 To ask the Board to consider applications to extend provisional period for provisional premises licences.

#### 2. Main Report

- 2.1. In terms of section 45(6) of the Licensing (Scotland) Act 2005, a provisional premises licence is granted for a period of four years from the date of issue of the licence. If not confirmed before the end of the provisional period, the licence is revoked, by operation of the Act. Confirmation is obtained upon receipt by the Licensing Board of clear section 50 certificates (Planning, Building Standards and, where necessary, Food Hygiene).
- 2.2. In terms of section 45(7) of the Act, a provisional premises licence holder may apply to the Board before the end of the provisional period, requesting an extension by such further period as the Board considers appropriate.
- 2.3. In granting such an extension, the Board must be satisfied in terms of section 45(8) of the Act that (a) completion of the construction or conversion of the premises to which the licence relates has been delayed and (b) the delay has been caused by factors outwith the premises licence holders' control.
- 2.4. The agent for the licence holders has provided information to support the licence holders' requests for extension and this will be supplied to the Board along with this report. Details of the requests have also been communicated to the Council's Building Standards Team for information and to allow any comment to be made if necessary.

#### 3. Recommendation

- 3.1 The Board is required:-
  - (a) To consider the terms of the provisional extension requests; and
  - (b) To decide on durations for extensions, in the event the Board is satisfied with the explanations provided in each case.

#### PERSONAL LICENCE REFERRAL – SECTION 84 – LEITH MCKENZIE

#### 1. Purpose

1.1 To advise of a referral for review of a personal licence.

#### 2. Main Report

- 2.1. Leith McKenzie holds a personal licence issued by the Edinburgh Licensing Board. The West Dunbartonshire Licensing Board conducted a premises licence review hearing for premises at which Mr McKenzie was the named premises manager. In the course of the hearing, a finding was made that Mr McKenzie had acted in a manner inconsistent with the licensing objectives.
- 2.2. The details of the review hearing conducted by the West Dunbartonshire Board and the decision reached on Mr McKenzie's licence are set out in a letter from the clerk of that Board, a copy of which has been sent to Mr McKenzie.
- 2.3. As Mr McKenzie is the holder of a personal licence issued by the Edinburgh Board and he is not currently believed to be working in the West Dunbartonshire Board area, the Board is required to hold a hearing on the terms of the referral and decide whether to take the action recommended by the West Dunbartonshire Board or any alternative action the Board considers necessary.
- 2.4. If the Board is satisfied that it is necessary to take action for the purposes of any of the licensing objectives it may make an order:-
  - (a) revoking;
  - (b) suspending for such period, not exceeding 6 months, as the Board considers appropriate, or
  - (c) endorsing

the personal licence.

2.5. In this instance the West Dunbartonshire Licensing Board has recommended that Mr McKenzie's personal licence be revoked. Mr Mackenzie was invited to attend the Board meeting on 26<sup>th</sup> September 2022, but failed to attend and has not responded to communications sent to him.

#### 3. Recommendation

- 3.1 The Board should:-
  - (a) hold a hearing on the personal licence, allowing the licence holder the opportunity to be heard; and
  - (b) decide what action should be taken, having regard to the licensing objectives and noting the recommendation set out in the referral.
