# 3 Assessor's Progress Report to the Lothian Valuation Joint Board

Staff continued to work on a hybrid basis, part home based, part office based. The Board had agreed its Hybrid Working Policy and this would be implemented over the coming months.

The Board had around 17,000 outstanding appeals which had been lodged on the basis of Covid-19. The disposal date for these appeals was 31 December 2023.

# **6 Revenue Budget 2022-2027**

An update on the financial position of the Board was provided summarising the projected outturn at 31 March 2023, based on the position at 31 August 2022.

The forecast was for net expenditure to be £212,000 greater than the 2022/23 budget. Following completion of the external audit of the annual accounts for 2021/22, indicative financial plans had also been updated for the period 2023 to 2027.
