5. Millerhill Energy from Waste Plant: Heat Interchange Unit

The report outlined the response to an action agreed by the Council to provide a report to the Governance, Risk and Best Value Committee to allow scrutiny of the increase in costs to date associated with the construction of a Heat Interchange Unit at Millerhill. It was highlighted that a six-monthly update would be provided from August 2024 onwards.

6. Draft Public Performance Scorecard

The first Quarterly Public Performance Scorecard report was presented, providing an overview of performance across a range of Council services up to the end of September 2023. Analysis of performance against the Key Performance Indicators was also provided. Current performance against targets and a comparison with same period last year in addition to four-year average for longer term trends was provided with an over of the scrutiny undertaken by Executive Committees.

- 4) To welcome officers' suggestion that a focus group of members of the public could review the scorecard and give feedback on its accessibility and endorses this approach;
- 5) To welcome proposed changes from officers on the presentation of data, to simplify and provide comparable data over a longer period of time; and
- 6) To agree that a workshop is set up workshop following the focus group consultation and allowing enough time to enact changes focussing on:
 - Areas where there is a grey RAG or no target including Homeless cases housed, Average number of days to re-let properties, Rent collected as % of total rent due and Value of lost rent from empty homes;
 - Performance data for areas not covered in the report; and
 - Ways in which to enhance accessibility and to make the format as engaging to members of the public as possible.
