Council and Committee Statistics

2. Executive Summary

2.1 This report responds to requests of Council to provide annual reports to the Governance, Risk and Best Value Committee on various statistics relating to committee reporting.

3. Background

- 3.1 In December 2023, the Council considered an update report on critical risks and agreed to receive an annual report to the Governance, Risk and Best Value Committee detailing, as a minimum, the total number of reports, referred reports, motions, amendments, and written questions (if applicable) to each Council Committee including Full Council.
- 3.2 The Governance, Risk and Best Value Committee at its meeting of 28 November 2023 considered the Corporate Leadership Team Risk Report which included information on workforce and service delivery risks which had been rated 'critical' in previous reports. The Committee requested 'a data led report on the impact of Council decisions on officer workload including a breakdown of sources.'

4. Main report

- 4.1 Information has been collated for Council, the six executive committees and the Governance, Risk and Best Value Committee. Appendix 1 contains the information requested in December 2023, as well as additional information on the duration of meetings and number of deputations to each meeting. This information covers the period from January to December 2023 and will be reported annually to Governance, Risk and Best Value Committee.
- 4.2 In addition, members have recently expressed concerns about reports being issued after the initial agenda and meeting paper publication. The number of reports marked 'to follow' in the initial publication is subject to ongoing monitoring at the request of the Chief Executive. Information on the number of council and committee reports issued late is included at Appendix 2.

Governance, Risk and Best Value Committee – 20 February 2024 Page 2 of 4 4.3 Discussions have taken place with directorates to identify how the information requested by the Governance, Risk and Best Value Committee on the impact of council and committee decisions on workload could be gathered. However, while requests for specific work to be undertaken inevitably have an impact on officer time and workload, it has not been possible to collate meaningful information. As council and committee actions normally arise from work already being done, separating time spent on actions requested by members from other work is challenging. Where work to address Council and committee decisions is interlinked with ongoing projects and 'business as usual' work, officer time spent on the specific actions is difficult to quantify. The information requested is not attainable without significant resource being allocated to monitor officer time on future actions. Past information gathering exercises, for example regarding time spent on Council questions, have been resource intensive and have not produced meaningful data.

5. Next Steps

5.1 Data will continue to be collected and reported to the Committee on an annual basis. This information will be presented in calendar years and reported to the Governance, Risk and Best Value Committee in February each year.

6. Financial impact

6.1 The costs of this report are contained within existing directorate budgets.

7. Equality and Poverty Impact

7.1 The report writing guidance and templates aim to make council and committee reports accessible to elected members and members of the public. This will continue to be assessed and considered in future reviews.
